# **INTRODUCTION**

The Mississippi Department of Environmental Quality (MDEQ) developed this status report to provide information on certain solid waste management activities that were conducted during Calendar Year 2006. This report also includes waste disposal information for emergency rubbish disposal sites that were approved by MDEQ to operate temporarily in the aftermath of Hurricane Katrina to assist with the disposal of the massive amounts of hurricane debris. A report on the solid waste management or disposal activities conducted at each landfill, rubbish site, and land application facility in the state is required to be submitted to MDEQ by the facility owner each year. This status report provides summary information on the amounts of solid waste received at these solid waste management facilities as listed below:

## **Part I - Commercial Solid Waste Disposal Facilities**

Part I of this report contains a summary report on disposal activities conducted at commercial disposal facilities in the state. A commercial solid waste disposal facility is any facility that is engaged in the disposal of solid waste for compensation or which accepts waste from more than one generator not owned by the facility owner. Commercial solid waste disposal facilities include:

- Municipal Solid Waste (MSW) Landfills
- Non-Municipal Solid Waste (non-MSW) Landfills
- Class I and Class II Rubbish Sites

## **Part II - Non-Commercial Solid Waste Disposal Facilities**

Part II of this report contains a summary report on disposal activities conducted at non-commercial disposal facilities. A non-commercial solid waste disposal facility is a facility that receives solid waste from a single generator and that is not operated for compensation. Non-commercial solid waste disposal facilities include:

- Industrial and Institutional Landfills
- Industrial and Institutional Rubbish Sites

## **Part III - Solid Waste Land Application Facilities**

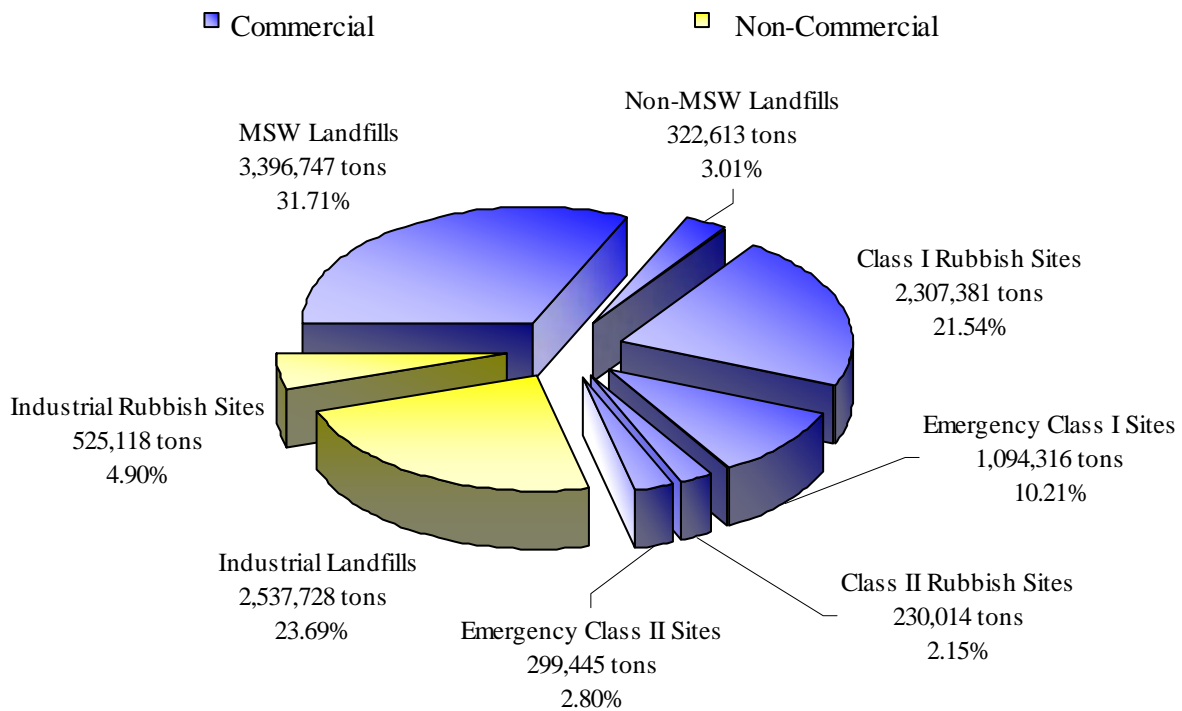
Part III of this report contains a summary of information on activities conducted at permitted land application facilities in Mississippi. A land application facility is a facility that receives wastes for incorporation into the soil, injection below the land surface, or other application of wastes on the land for soil amendment or conditioning purposes or for biodegradation of the wastes.

This status report contains information that may be utilized by local government officials and solid waste decision makers, disposal facility owners and operators, state agencies, and other organizations. The information provided in the report includes the following:

1. The total amount of waste received during Calendar Year 2006 at each permitted or authorized solid waste disposal facility as reported by the facility owners/operators;
2. An estimated remaining life at solid waste disposal facilities as reported by the facility owners/operators at the end of Calendar Year 2006; and
3. State maps showing the locations of each disposal facility.

Copies of this report will be provided to local government officials and solid waste decision makers to assist them in planning for the management of solid wastes in their jurisdictions. A copy of this status report will also be provided to the Mississippi State Tax Commission for verification of the information that the State Tax Commission receives from commercial disposal facility owners/operators each year.

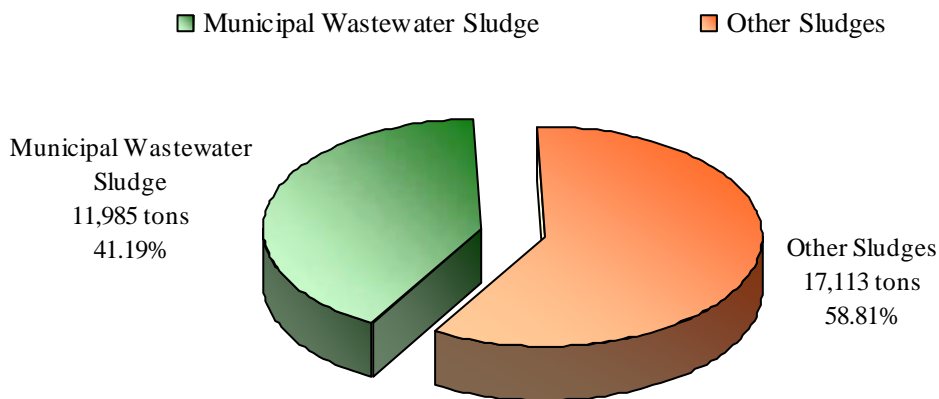
The annual reports indicate that a total of approximately 10,713,362 tons of solid waste was received during Calendar Year 2006 at commercial and non-commercial landfills and rubbish sites, and emergency rubbish disposal sites for Hurricane Katrina debris. Approximately 34.72% (3,719,360 tons) of the total waste was disposed at commercial landfills, 23.69% (2,537,728 tons) at non-commercial landfills, 36.69% (3,931,156 tons) at commercial rubbish sites, and 4.90% (525,118) at non-commercial rubbish sites (see Figure: 1 below).

This status report also indicates that Mississippi received a total of 811,760 tons of solid waste from out-of-state sources representing approximately 7.58% of the total solid waste that was disposed in Mississippi during Calendar Year 2006. Commercial landfills received approximately 740,876 tons and commercial rubbish sites received approximately 70,884 tons of out-of-state waste.

The annual reports indicate that a total of approximately 29,098 tons of solid waste was received during Calendar Year 2006 at land application sites. Approximately 41.19% (11,985 dry tons) of the total waste applied in the state during Calendar Year 2006 was municipal wastewater sludge and the remaining 58.81% (17,113 dry tons) was waste other than municipal wastewater sludge such as wood ash, pulp and paper mill sludge, etc (see Figure: 2 below).

**COMMERCIAL SOLID WASTE  
DISPOSAL FACILITIES**

## Municipal Solid Waste (MSW) Landfills

MSW Landfills are disposal facilities that are designed and constructed to receive a wide range of nonhazardous solid wastes for disposal including household garbage, commercial business wastes, nonhazardous industrial wastes, and special wastes such as asbestos or treated medical wastes. There were 17 MSW landfills that operated in the state during Calendar Year 2006. According to the annual reports submitted by the owners/operators, these landfills received a total of 3,396,747 tons of solid waste during Calendar Year 2006.

The annual report on the solid waste disposal activities conducted at each MSW landfill is required by the Mississippi Code Annotated Section 17-17-219 (Supp. 2005) and Section IV.B.15 of the Mississippi Nonhazardous Solid Waste Management Regulations. This report contains a summary of the information from these individual facility reports as provided by the facility owners. The report includes the following information:

1. A state map showing the locations of MSW landfills;
2. A summary of operational information contained in the individual annual reports for Calendar Year 2006 for MSW landfills; and
3. Individual state maps for the 17 active MSW landfills including geographic locations, the geographic areas serviced with the amount of wastes received in tons/year, and other pertinent information.

### MSW Landfill Disposal Trends

Data in this report indicates that during 2006, Mississippi MSW landfills received more municipal solid waste (approximately 216,903 tons) than during Calendar Year 2005 (see [Figure 3](#) below).

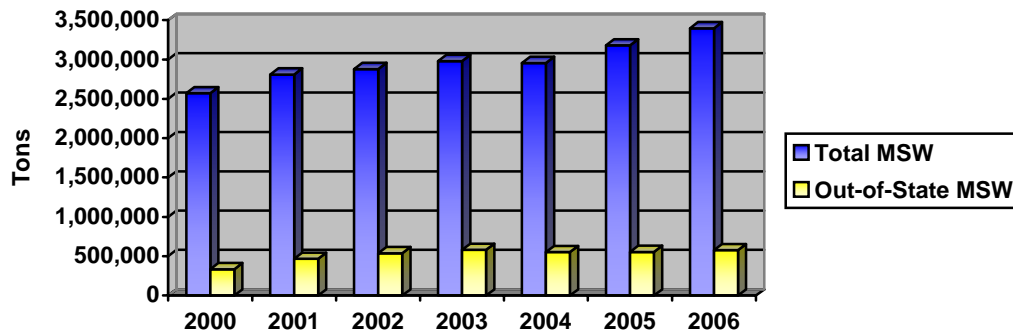

Figure 4 below shows a comparison of the annual disposal amounts for MSW landfills over the six year period from Calendar Years 2001 through 2006. Over this six year period, the average annual percent change in disposal rates was +3.92% for total MSW, +3.87% for in-state MSW, and +4.48% for out-of-state MSW. Over this six year period the total amount of wastes received at MSW landfills increased by approximately 20.94%.

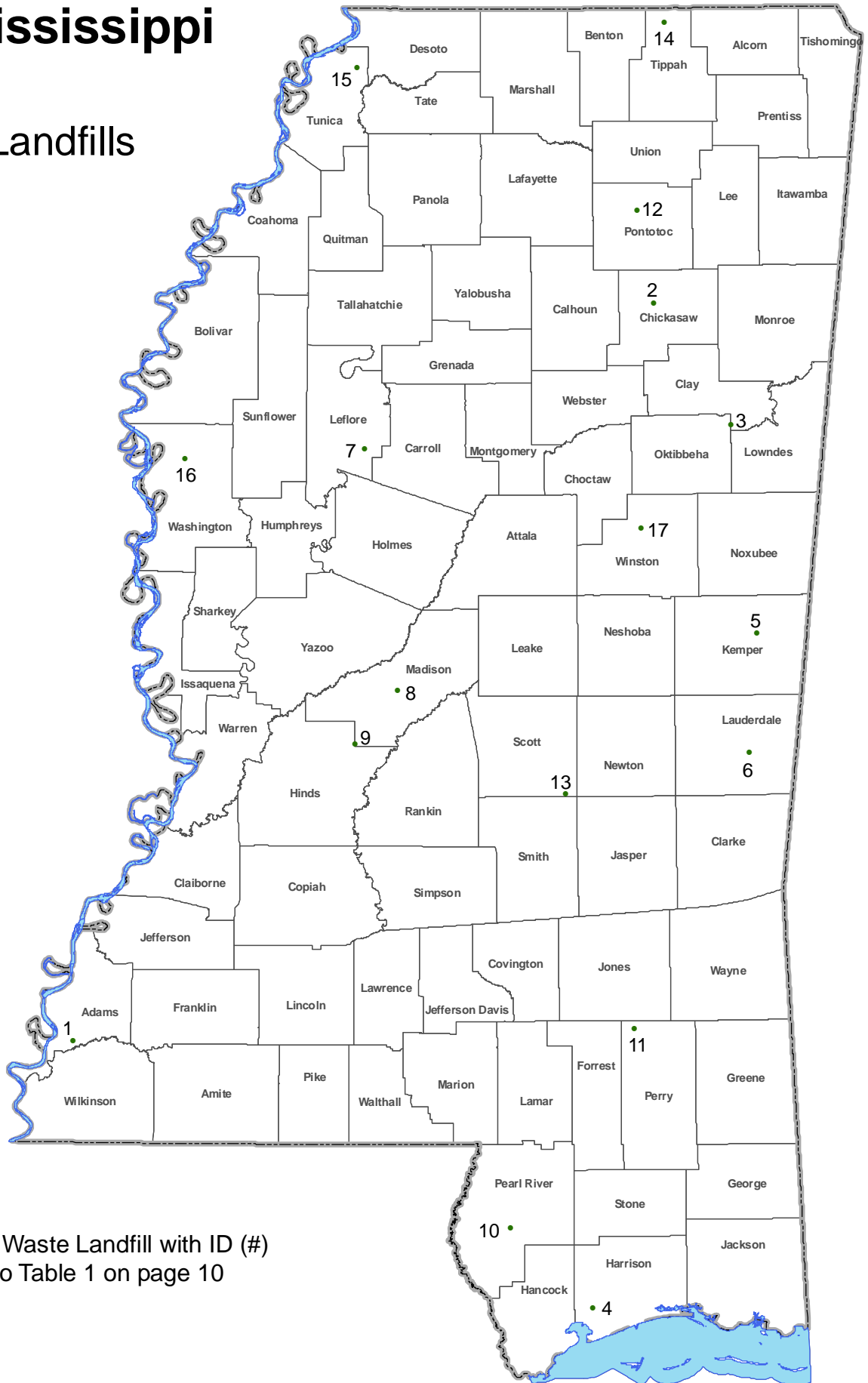
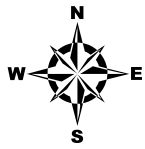

## **Non-Municipal Solid Waste (Non-MSW) Landfills**

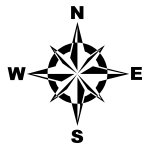
Non-MSW Landfills are commercial disposal facilities that are designed and constructed to receive a limited range of nonhazardous solid wastes including industrial sludges, ashes, and other process wastes or special wastes, such as asbestos, for disposal. These landfills generally receive waste from either one primary industrial source or receive one primary waste stream. These facilities are not authorized to accept household garbage or other similar wastes. There were 6 permitted non-MSW landfills that operated during Calendar Year 2006. According to the annual reports submitted by the owners/operators, these 6 non-MSW landfills received a total of 322,613 tons of solid waste during Calendar Year 2006.

The annual report on the solid waste disposal activities conducted at each non-MSW landfill is required by the Mississippi Code Annotated Section 17-17-219 (Supp. 2005) and Section IV.B.15 of the Mississippi Nonhazardous Solid Waste Management Regulations. This report contains a summary of these individual facility reports as provided by the facility owners. The report includes the following information:

1. A state map showing the locations of non-MSW landfills; and
2. A summary of operational information contained in the individual annual reports for Calendar Year 2006 for non-MSW landfills. The information is listed alphabetically by the County in which the landfill is located.

## Class I and Class II Rubbish Sites

Class I and Class II Rubbish Sites are facilities that are designed and constructed to receive rubbish wastes from a variety of sources for disposal. Rubbish is a subset of the overall municipal solid waste stream generated in the State of Mississippi that includes non-putrescible types of wastes. A significant amount of rubbish wastes are managed and disposed of each year at commercial rubbish disposal facilities across the state. This was especially true in 2005 and 2006 due to the unprecedented damage caused by Hurricane Katrina. In addition to the existing 155 permitted rubbish sites in Mississippi, another 31 emergency disposal sites were authorized temporarily by MDEQ for disposal of rubbish debris from the Hurricane Katrina clean-up efforts.

### Class I Rubbish Sites

Class I rubbish sites may accept those solid wastes that are defined as rubbish wastes. These wastes generally include the following materials:

- construction and demolition debris;
- brick, mortar, concrete, stone, and asphalt;
- cardboard;
- natural vegetation;
- appliances which have had the motor removed (except refrigerators and air conditioners);
- furniture;
- plastic, glass, crockery, and metal (except containers); and
- sawdust, wood shavings, and wood chips.

There were 79 permitted commercial class I rubbish sites, 4 of which were inactive during Calendar Year 2006 and 3 that did not report. According to the annual reports submitted by the facilities, a total of 2,307,381 tons of rubbish wastes were disposed of at the remaining 72 active class I rubbish sites during Calendar Year 2006. Also, 16 of these 72 class I rubbish sites reported that 1,105,240 tons of this class I rubbish was from Hurricane Katrina clean-up activities during 2006.

In addition, 16 of the 31 emergency building and structural debris disposal sites were authorized to receive class I type rubbish wastes resulting from Hurricane Katrina clean up efforts. According to the annual reports submitted by 14 of these emergency sites, a total of 1,094,316 tons of wastes were received for disposal during Calendar Year 2006. The remaining 2 emergency sites had not reported at the time of publication.

### Class II Rubbish Sites

Class II rubbish sites may accept limited types of inert rubbish wastes. These inert wastes include natural vegetation, brick, mortar, concrete, stone, and asphalt.

There were 76 permitted commercial class II rubbish sites, 12 of which were inactive during Calendar Year 2006 and 3 that did not report. According to the annual reports submitted by the facilities, a total of 230,014 tons of rubbish wastes were disposed of at the 61 active class II rubbish sites during Calendar Year 2006. Also, 9 of these class II sites reported that 21,055 tons of this class II rubbish was from Hurricane Katrina clean up efforts.

In addition, 15 of the 31 emergency vegetative debris disposal sites were authorized to receive class II type rubbish wastes (primarily vegetative debris) resulting from Hurricane Katrina clean up efforts. According to the annual reports submitted by 14 of these emergency sites, a total of 299,445 tons of wastes were disposed during Calendar Year 2006. One emergency site had not reported at the time of publication.

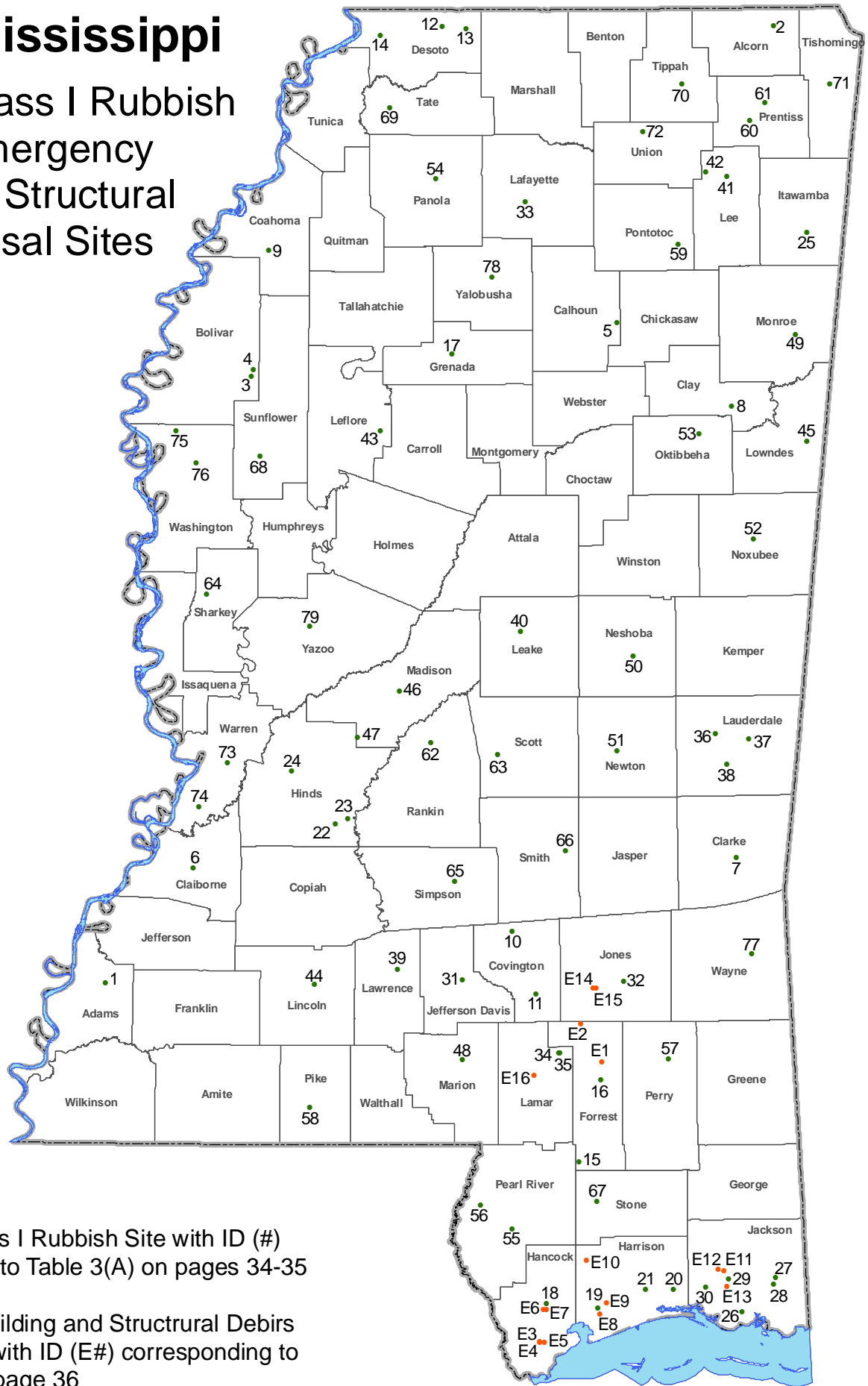
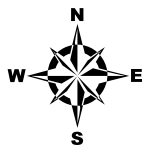
An annual report on the solid waste disposal activity conducted at each rubbish site is required by the Mississippi Code Annotated, Section 17-17-219 (Supp. 2005), Section VI.E.16 of the Mississippi Nonhazardous Solid Waste Management Regulations, Section T of Statewide General Permit No. SWGP-R1 for class I rubbish sites, and Section R of Statewide General Permit No. SWGP-R2 for class II rubbish sites. This report contains a summary of information from these facility reports as provided by the facility owners. The report includes the following information:

1. A state map showing the locations of the permitted class I rubbish sites and the emergency building and structural debris disposal sites that were temporarily authorized for disposal of class I type rubbish wastes from Hurricane Katrina clean up efforts;
2. A summary of the information provided by rubbish site owners in the individual annual reports for Calendar Year 2006 for the permitted class I rubbish sites and the emergency building and structural debris disposal sites that received class I type rubbish wastes from Hurricane Katrina clean up efforts in Mississippi. The information is listed alphabetically by the County in which the facility is located;
3. A state map showing the locations of the permitted class II rubbish sites and the emergency vegetative debris disposal sites that were temporarily authorized for disposal of class II type rubbish wastes from Hurricane Katrina clean up efforts; and
4. A summary of the information provided by rubbish site owners in the individual annual reports for Calendar Year 2006 for the permitted class II rubbish sites and the emergency vegetative debris disposal sites that received class II type rubbish wastes from Hurricane Katrina clean up efforts in Mississippi. The information is listed alphabetically by the County in which the facility is located.

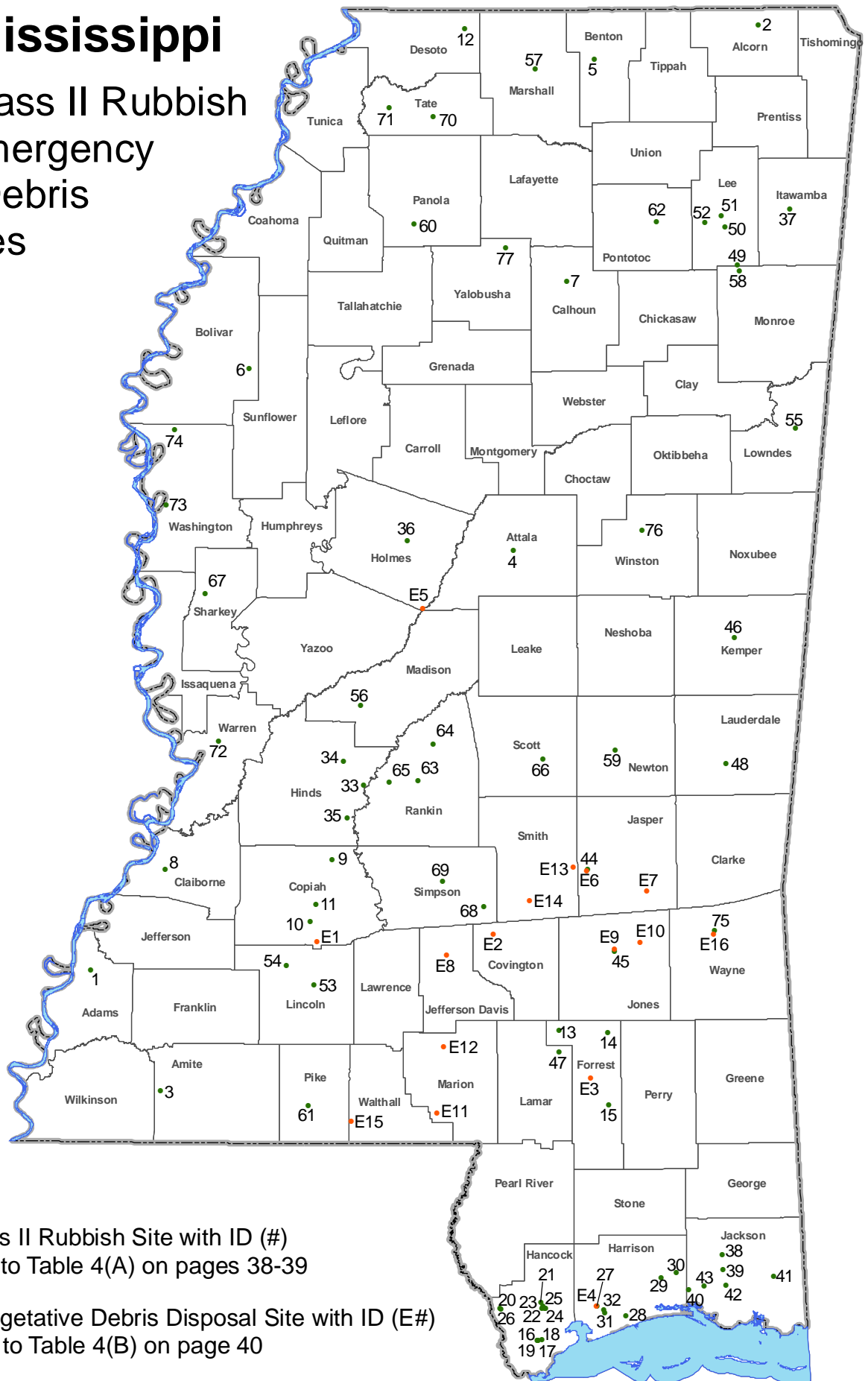
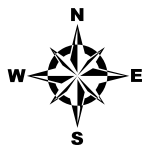

## **Industrial and Institutional Landfills**

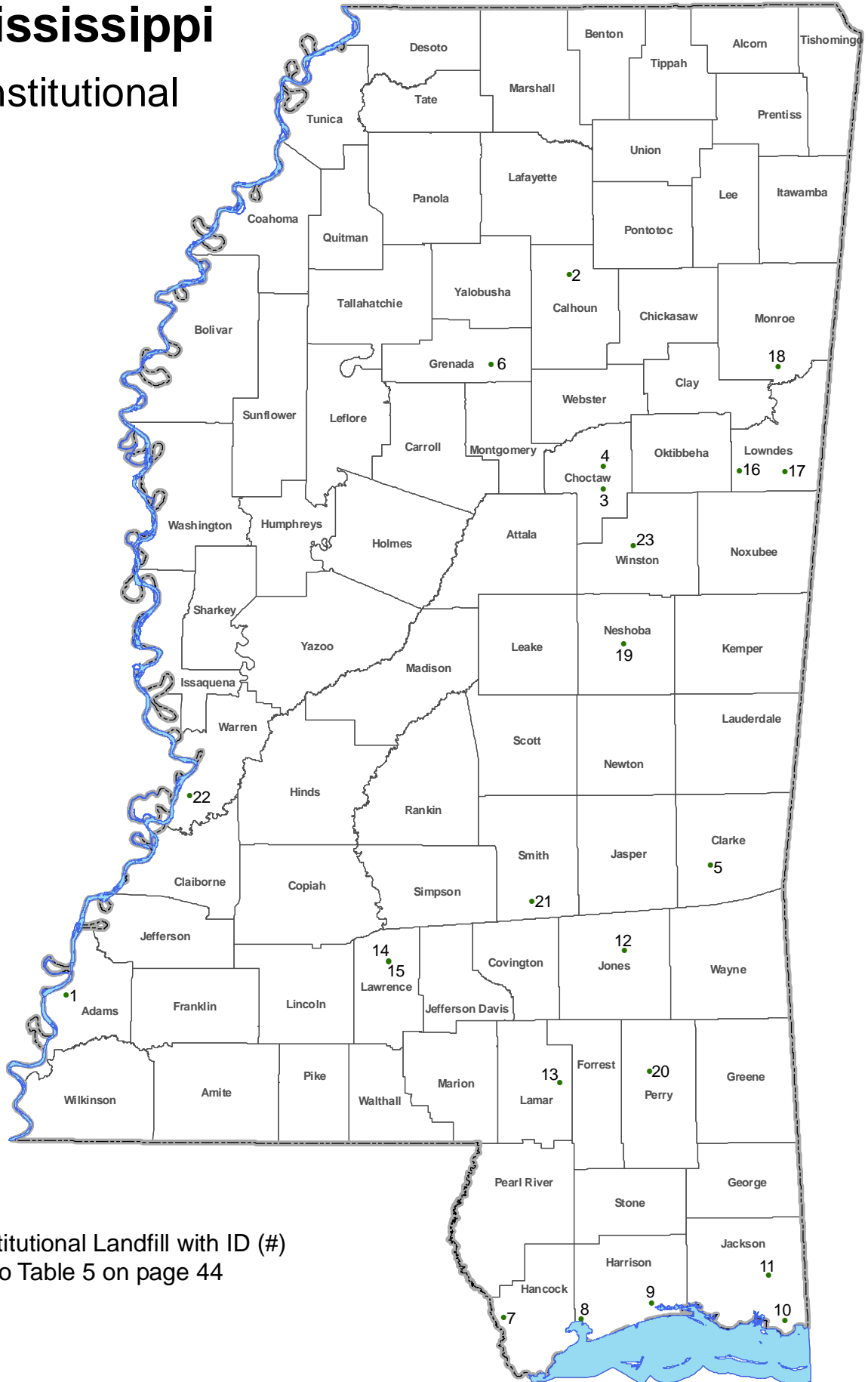
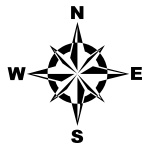
Industrial and Institutional Landfills are disposal facilities that are designed and constructed to receive nonhazardous industrial wastes and certain special wastes from one primary source for ultimate disposal. These disposal facilities are generally owned and operated by the industry or institution that generates the wastes. There were 23 permitted industrial and institutional landfills, of which 2 were inactive during Calendar Year 2006. According to the annual reports submitted by the owners/operators, a total of 2,537,728 tons of solid waste were disposed of at the 21 active landfills during Calendar Year 2006.

The annual report on the solid waste disposal activities conducted at each industrial and institutional landfill is required by the individual facility permit conditions. This report contains a summary report on the disposal activities conducted at landfills in Mississippi during Calendar Year 2006. The report includes the following information:

1. A state map showing the locations of industrial and institutional landfills; and
2. A summary of operational information contained in the individual annual reports for Calendar Year 2006 for industrial and institutional landfills. The information is listed alphabetically by the County in which the facility is located.

## **Industrial and Institutional Rubbish Sites**

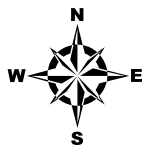
Industrial and Institutional Rubbish Sites are facilities that are designed and constructed to receive class I and/or class II rubbish wastes from industrial or institutional sources for disposal. These disposal facilities are generally owned and operated by the industry or institution that generates the wastes and are categorized as either class I or class II rubbish sites depending upon the types of waste disposed. There were 19 permitted industrial or institutional rubbish sites, 5 of which were inactive during Calendar Year 2006. According to the annual reports submitted by the owners/operators, a total of 525,118 tons of solid wastes were disposed of at the 14 active industrial rubbish sites during Calendar Year 2006.

The annual report on the solid waste disposal activity conducted at each rubbish site is required by Section VI.E.16 of the Mississippi Nonhazardous Solid Waste Management Regulations, Section T of Statewide General Permit No. SWGP-R1 for class I rubbish sites and Section R of Statewide General Permit No. SWGP-R2 for class II rubbish sites. This report contains a summary of the individual facility reports as reported by the facility owners. The report includes the following information:

1. A state map showing the locations of industrial and institutional rubbish sites; and
2. A summary of the information provided by the rubbish site owners in the individual annual reports for Calendar Year 2006 for all non-commercial rubbish sites in Mississippi. The information is listed alphabetically by the County in which the facility is located.

## **Solid Waste Land Application Facilities**

Land application facilities are sites where solid waste is applied to the land through incorporation, injection, or other application for soil amendment or conditioning purposes or for biodegradation of the waste. A significant amount of municipal wastewater sludge (commonly referred to as biosolids), non-municipal wastewater sludge, and other waste streams from industrial sources are land applied each year at the permitted land application facilities across the state.

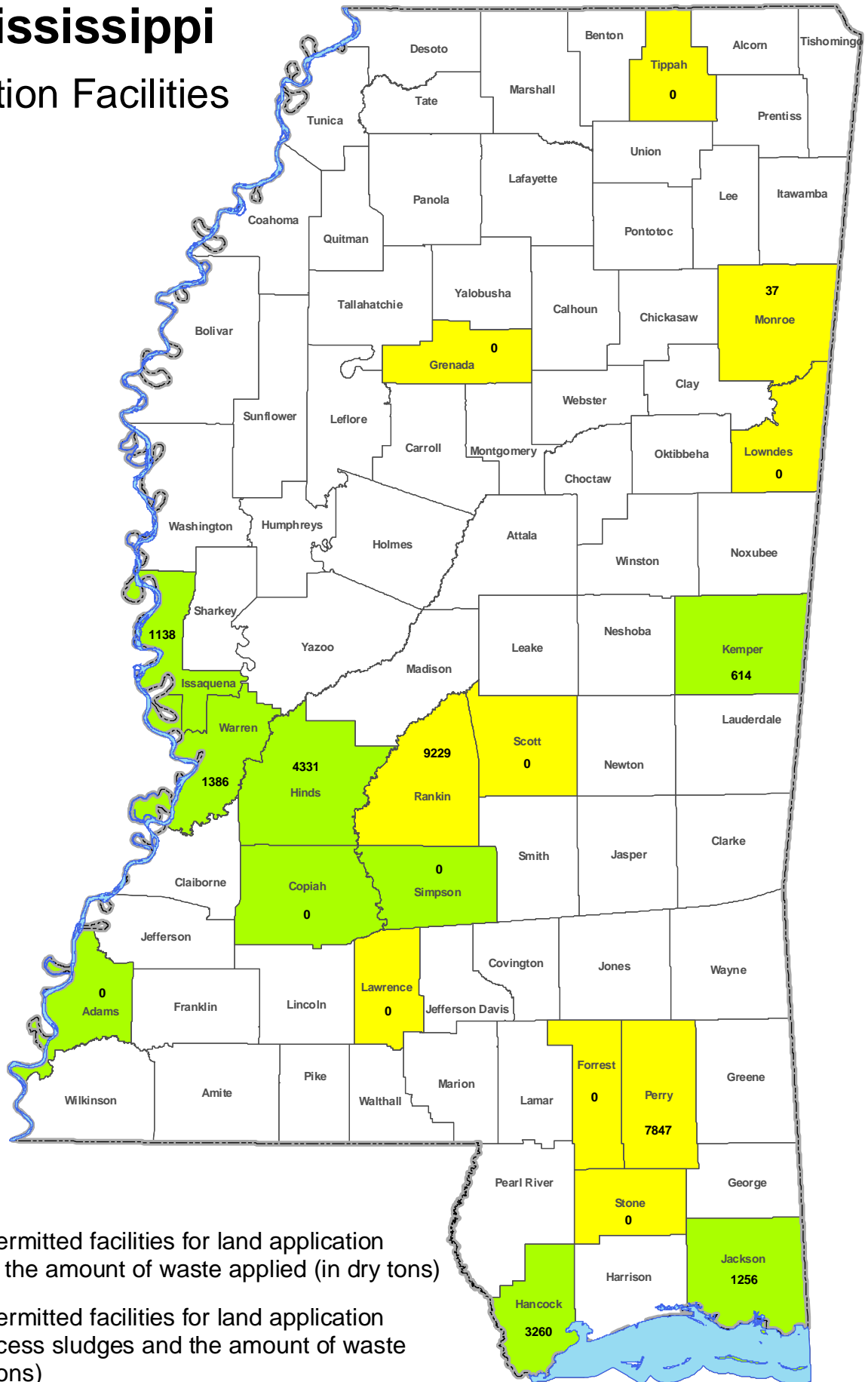
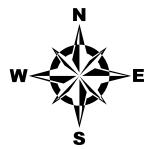
There were 28 permitted land application facilities, 15 of which were inactive during Calendar Year 2006. According to the submitted annual reports, a total of approximately 29,098 dry tons of solid waste was land applied during Calendar Year 2006 at 13 active land application facilities in Mississippi. Approximately 41.19% (11,985 dry tons) of the total waste applied during Calendar Year 2006 was municipal wastewater sludge and the remaining 58.81% (17,113 dry tons) was waste other than municipal wastewater sludge such as wood ash, pulp and paper mill sludge, etc.

An annual report on activities conducted at each land application site is required by the individual facility permit conditions. This report contains summary information on the activities conducted at the permitted land application sites in Mississippi during Calendar Year 2006. The report includes the following information:

1. A state map showing counties where land application sites are permitted; and
2. A summary of operational information contained in the individual annual reports for Calendar Year 2006 for land application sites. The information is listed alphabetically by the County in which the facility is located.
