
RESTORATION SUMMIT PURPOSE

The Restoration Summit was created for the following purposes:


- Have a single venue in which all new restoration projects are announced for the coming year

- Create a means to solicit community feedback, input, and suggestions on restoration projects, processes, and priorities




RESTORATION FUNDING STREAM



LOCATION: Stennis international airport Hancock County, Mississippi

EXISTING PROJECT Additional funding amount: \$4,000,000

- \$3M IN RESTORE FUNDS COMMITTED IN 2017
- \$7M TOTAL ESTIMATED PROJECT COST
- SITE HAS BEEN ACQUIRED AND PLANNING UNDERWAY (\$1M FROM LEGISLATURE/BP ECONOMIC DAMAGES FUNDS)
- INCREASE WORKFORCE TRAINING CAPACITY IN HANCOCK COUNTY







NEW PROJECTS – BUCKET 1 – MISSISSIPPI AQUARIUM

LOCATION: GULFPORT HARRISON COUNTY, MISSISSIPPI

EXISTING PROJECT Additional funding amount: \$1,350,000

- \$17M RESTORE FUNDING COMMITTED IN 2016
- AQUARIUM CONSTRUCTION IS UNDERWAY
- ANTICIPATED PUBLIC OPENING: LATE 2019/EARLY 2020





NEW PROJECTS – BUCKET 1 – MGCCC WORK READY COMMUNITY PROGRAM

LOCATION: MGCCC CAMPUSES IN LONG BEACH AND GAUTIER JACKSON/HARRISON COUNTY, MISSISSIPPI

EXISTING PROJECT Additional funding amount: \$5,000,000

- \$4M RESTORE FUNDING COMMITTED IN 2016
- SUPPORT CONTINUED WORKFORCE TRAINING ACTIVITIES
- ESTABLISH UNMANNED SYSTEMS TECHNOLOGY TRAINING PROGRAM
- WILL SUPPORT ONGOING STATE AND REGIONAL UNMANNED SYSTEMS INDUSTRY ECONOMIC DEVELOPMENT EFFORTS, INCLUDING GOVERNOR'S OCEAN TASK FORCE
- STUDENTS WILL RECEIVE AN ASSOCIATE OF APPLIED SCIENCE DEGREE

NEW PROJECTS – BUCKET 1 – JACKSON COUNTY CONNECTOR ROAD



EXISTING PROJECT Additional funding amount: \$4,800,000

- \$10.2M IN RESTORE FUNDING PREVIOUSLY PROVIDED FOR PHASE I (CONSTRUCTION ACTIVITIES UNDERWAY)
- \$8.2M IN FEDERAL AND \$1.1M IN COUNTY FUNDING HAS FUNDED ALL RIGHT OF WAY ACQUISITION, ENGINEERING/DESIGN AND PERMITTING.
- ADDITIONAL FUNDS WILL SUPPORT ADDITIONAL PHASE(S) OF THE MULTI-PHASE EAST-WEST CONNECTOR ROAD.



NEW PROJECTS – BUCKET 1 – HARRISON COUNTY RAIL LINE UPGRADES

LOCATION: INDUSTRIAL SEAWAY HARRISON COUNTY, MISSISSIPPI

NEW PROJECT FUNDING AMOUNT: \$2,300,000

- RAIL SPUR OUT OF SERVICE SINCE 2016 DUE TO HEAVY RAINS
- RAIL LINE SERVES TENANTS ALONG INDUSTRIAL SEAWAY
- NEGATIVELY IMPACTING CURRENT TENANTS
- NEGATIVELY IMPACTS NEW INDUSTRY RECRUITMENT





NEW PROJECTS – BUCKET 1 – MS GULF COAST AIR SERVICE GROWTH PROGRAM

LOCATION: GULFPORT BILOXI INTERNATIONAL AIRPORT HARRISON COUNTY, MISSISSIPPI

FUNDING AMOUNT:

\$1,200,000

- EXPAND AIR SERVICE OFFERING TO GULFPORT TO INCREASE VISITATION
- PROGRAM SUCCESSFULLY IMPLEMENTED WITH FUNDING THROUGH MDA AND FAA — AND DEMONSTRATED RETURN ON INVESTMENT
- ADDITIONAL FUNDING NEEDED TO ENHANCE EFFORTS





NEW PROJECTS – BUCKET 1 – GULF SEAFOOD MARKETING PROGRAM

LOCATION: Coast-Wide, Mississippi

NEW PROJECT FUNDING AMOUNT: \$400,000



- FUNDING TO SUPPORT DMR'S SEAFOOD MARKETING PROGRAM EFFORTS
- FUNDING WOULD COVER 3 YEARS

NEW PROJECTS BUCKET 3 - 2018

- Promote funded projects to be as successful and sustainable as possible.




NEW PROJECTS BUCKET 3 – HANCOCK MARSH LIVING SHORELINE – PHASE 6

LOCATION: Hancock County, Mississippi

ADDITION TO AN EXISTING PROJECT FUNDING AMOUNT: \$6,000,000

- LEVERAGE EXISTING NRDA HCMLS PROJECT
 - \$50 MILLION, 6 MILES OF LIVING SHORELINE
- PRIMARY PURPOSE: PROVIDE RESILIENCE TO MARSH BY REDUCING FURTHER MARSH LOSS



NEW PROJECTS BUCKET 3 – OYSTER SHELL RECYCLING PROGRAM

LOCATION: COAST WIDE

NEW PROJECT FUNDING AMOUNT: \$650,000

- PROGRAM WILL COLLECT, ACCUMULATE AND RECYCLE DISCARDED OYSTER SHELLS
- TWO COMPONENTS:
 - ECONOMIC SUSTAINABILITY ANALYSIS
 - IMPLEMENTING THE OYSTER SHELL RECYCLING PROGRAM





NEW PROJECTS BUCKET 3 – BU PROGRAM FOR MARSH CREATION AND RESTORATION

LOCATION: Coast wide

NEW PROJECT FUNDING AMOUNT: \$12,000,000

- CAPITALIZE ON DREDGE MATERIAL TO ACCELERATE MARSH CREATION AND RESTORATION
- LEVERAGE RESTORE B2 AND NFWF BU EFFORTS TO MAXIMIZE MARSH CREATION



PROJECT OVERVIEW

IMPLEMENTING TRUSTEES: MDEQ and DOI PROJECT PARTNERS: MDMR Coastal Preserves/Grand Bay NERR, USFWS PDARP GOALS:

- Restore and Conserve Habitat: Wetlands, Coastal, and Nearshore Habitats
- Replenish and Protect Living Coastal and Marine Resources: Birds

Supplement Intent:

We are considering increasing the budget to expand the habitat management, enhance the monitoring and adaptive management, and potentially acquire more properties/habitat in the Grand Bay Area.


