# **ENGAGEMENT: Collaborative Process**

#### **BACKGROUND**

CHARLESTON IS A CITY IN NORTH CENTRAL MS THAT STRETCHES 1.4 SQUARE MILES IN TALLAHATCHIE COUNTY.

The City of Charleston, MS received notice from the Mississippi Department of Environmental Quality to close and clean a city owned unauthorized (unpermitted) dump site that was once the city's cesspool.

For 20 years, the improperly disposed waste had become a breeding ground for rodents and insects. The site, boarded by Tillatoba Creek, and within 20 feet of residents' homes, posed significant threats to wildlife, water supply, public health and safety, property value and quality of life.

The State of Mississippi 2002 List of Waterbodies denotes the Tillatoba Creek drainage area (Waterbody ID No. MS272E) in Yalobusha and Tallahatchie counties, to be listed for aquatic life support due to pathogens. This waterbody is in the Yazoo River drainage basin.



### **DEMOGRAPHICS**

The population was 2,193 at the time of the 2010 census. In the 2013 US Census' population estimates, Charleston's population decreased to 2, 171. Of the population, African Americans comprise 75.4% - (1,693); Caucasian comprise 21.9% (492); Hispanic - 42 (1.9%); Asian - 14 (0.6%) and American Indian - 9 (0.4%). The percentage of residents living in poverty in 2012 was 41.1%.
