James Matheny of MDEQ’s Coal Mining Division presented the MLMC application for Permit Revision 9 of MS-002, Renewal 2. The revision included expanding the current 5 year term boundary to the east, as well as the construction of a new freshwater diversion along the eastern edge of the current mine area to route surface water around the perimeter of the active mine operations. This allows the active mine area to be extended to the east. A public hearing was held on Thursday, February 10, 2016, at the Choctaw County Courthouse in Ackerman, Mississippi. Two neighboring landowners spoke in opposition to the revision. MDEQ staff considered the comments and prepared written responses and forwarded the response document to all interested parties. All interested parties were notified that the matter would be heard at the April 12, 2016, Environmental Quality Permit Board meeting. Prior to the meeting, Permit Board members were provided copies of the hearing transcript and response to comments. The objecting landowners did not attend the meeting. No one at the meeting spoke against the proposed revision.

B and B Concrete Company, Inc., Oxford Division
Modification of Ready Mix Concrete
General Permit Coverage, Lafayette County, MSG110081

Michael Griffith of MDEQ’s Environmental Permits Division presented the B and B Concrete Company, Inc. application for Modification of its Coverage under the Ready Mix Concrete Multimedia General Permit, (No. MSG110081) to construct and operate an additional ready mix concrete plant on its property located near Oxford in Lafayette County, Mississippi. On March 8, 2016, MDEQ received a Major Modification Form and an associated Storm Water Pollution Prevention Plan from B and B for the construction and operation of the additional ready

mix concrete plant. Contiguous landowners were notified via certified mail, return receipt requested, of the proposed modification. MDEQ received two letters from contiguous landowners objecting to the expansion of the facility. The issues raised in these objection letters were related to dust, noise, and storm water runoff. MDEQ replied to these letters of concern on April 1, 2016. MDEQ staff notified interested parties of the Permit Board meeting to be held on April 12, 2016. The objecting contiguous landowners did not attend the meeting and no one at the meeting spoke against the proposed modification. Mr. David Brevard, President of B and B Concrete, and B and B's engineer, Chris Sokol, were present at the meeting. Mr. Brevard expressed his desire to expand in order to provide additional plant resources to support the increasing business projects related to the Oxford, Lafayette County, and University Communities.

On motion by Dennis Riecke and seconded by Jim Hoffmann, the Permit Board voted to accept the staff's recommendation to modify B and B's coverage under the Ready Mix Concrete Multimedia General Permit.

OTHER BUSINESS

Mr. Roy Furrh welcomed Julie McLemore to the Permit Board. Ms. McLemore will serve the Permit Board as the designee for the Mississippi Department of Agriculture and Commerce. Ms. McLemore will serve in place of Permit Board member Jim Lipe who will be retiring the end of April, 2016. Mr. Furrh also welcomed to the Permit Board, William "Bill" Moody, who served as the designee for Leslie Royals with the Mississippi Department of Health for the meeting.

Mr. Furrh also reminded the Permit Board that their Statement of Economic Interest Forms must be submitted to the Mississippi Ethics Commission by May 1, 2016.
