The Mississippi Department of Environmental Quality (MDEQ) collected three (3) soil samples from your property on February 24, 2006. SUBJECT: 100 Puckett Street

I telephoned Ms. Yolanda Peyton about meeting her for the purpose of sampling her yard. We met at 17:00 on February 23, 2006. During this meeting, she pointed out the areas of the property where she believes fill dirt was used to level the property. She stated that she had lived there since 1987 and that she had purchased the property from a man she believed worked at Kuhlman. She believes that this person brought fill dirt from Kuhlman to her property prior to her purchasing the property in 1987. I returned at 9:00am on Friday, February 24, 2006. I collected 3 discrete samples from various locations in the yard. These samples were a composite sample of the top 12 inches of soil from each location. The locations are annotated on the MDEQ sample request forms. I departed the site and returned to the MDEQ after collecting the 3 samples. I then departed the MDEQ and took the samples to the MDEQ lab.

SUBJECT: Conversation with Elonja Peyton July 27, 2005

Ms. Peyton (601-576-3858 or cell phone 601-212-1115) called about getting the soil tested at her residential address in Crystal Springs, 100 Puckett Street. She stated that the previous owner – Kenneth Powell – had hauled soil from the KEC facility and filled in areas of the yard. Powell was an employee of the KEC facility at the time he hauled soil to this location. I asked her about me calling Mr. Powell and she stated that he would most likely deny that he hauled soil from KEC facility to this location. She did not know his phone number.

She also stated that she was the daughter of Mrs. Maggie Williams who lived at 106 Puckett Street, which is presently be delineated for PCB contamination. She alluded to the fact her deceased father may have hauled contaminated soil to the 100 Puckett Street residence. She is very interested in getting the corner of her yard tested (bordered by Puckett Street and Rail Road Avenue). She has small children that play in the yard.

I informed her that I needed as much information as she could give me so we could make a determination as to the validity of the concern/complaint. We were under budgeted so MDEQ could not do the testing but if there was sufficient information as to the validity of the concern/complaint we could request KEC/BW to sample the area of concern. I also told her that we would call her back once a decision was reached.
