Findings of Fact and Conclusions of Law related to the Permit Board's decision  
to grant MDEQ's Motion to Dismiss petitioner, Dan Check's request for an  
Evidentiary Hearing

Senior Attorney, Ted Lampton, with the Mississippi Department of Environmental Quality, presented the proposed Findings of Fact and Conclusions of Law (FOFCOL) for consideration regarding the Permit Board's decision on February 14, 2017, to grant MDEQ's Motion to Dismiss the evidentiary hearing request received from Austin D. (Dan) Check regarding the reissuance of Water Pollution Control Permit to Discharge Wastewater in Accordance with the National Pollutant Discharge Elimination System Permit No. MS 0020117 to the City of Meridian Publicly Owned Treatment Works, located in Lauderdale County, MS ("Meridian POTW"). Permit Board Chairman Mike Bograd made some minor editorial changes.



After consideration by the Permit Board and upon motion by Board Member Howard Leach and seconded by Board Member Dennis Riecke, the Permit Board unanimously voted to adopt the proposed Findings of Fact and Conclusions of Law with Chairman Bograd's edits.

**Dry Facility Asset Holding, LLC - Issuance, Transfer, and Modification of Section 401 Water Quality Certification, Transfer of Storm Water Coverages; and  
Transfer of Permit to Construct Air Emissions Equipment  
Pearl River County, Mississippi**

**Formal Evidentiary Hearing**

The matter before the Permit Board was a formal evidentiary hearing regarding the Permit Board's issuance of a Clean Water Act Section 401 Water Quality Certification to Alliance Consulting Group, LLC ("ACG") and subsequent modification and transfer to Dry Facility Asset Holding, Inc. ("DFAH"). The evidentiary hearing also related to the Permit Board's transfer of the Certificate of Coverage under Mississippi's Large Construction Storm Water General Permit (MSR106120), Certificate of Coverage under Mississippi's Baseline Storm Water General Permit (MSR002071), and an Individual Permit to Construct Air Emissions equipment (2180-00052) from ACG to DFAH.

The hearing officer in this matter was attorney Frank Spencer, formerly with the Mississippi Office of the Attorney General. The Mississippi Department of Environmental Quality was represented by its General Counsel, Roy Furrh, and by Senior Attorney Lisa Ouzts. Attorneys Amanda Tollison and Michael Caples represented DFAH. Attorney Lewie G. "Skip" Negrotto represented the Petitioners who are residents of the Ravenwood Subdivision. MDEQ pre-filed direct and rebuttal testimony through the affidavits of Florance Bass and Steven Bailey. DFAH pre-filed direct testimony through the affidavits of Bart Pittman, Joshua Brown, and Kevin Bowen and rebuttal testimony through the affidavit of Bart Pittman. Petitioners pre-filed rebuttal testimony through the affidavits of Kimberly Jacobs, Brenda Rody, Jennifer Juan, and Nick Sciambra. Hearing Officer Spencer granted DFAH's Motion to Strike Mr. Sciambra's rebuttal affidavit ore tenus because he was unable to attend the hearing and be subject to cross-examination. All witnesses who pre-filed testimony, other than Mr. Sciambra, were present at the hearing and available for cross examination, questions by the Permit Board, and for re-direct.

Mr. Furrh made an opening statement on behalf of MDEQ, followed by Ms. Tollison for DFAH, and Mr. Negrotto for the Petitioners. Mr. Bailey and Ms. Bass testified on MDEQ's behalf through their direct and rebuttal affidavits and were tendered for cross-examination and for questioning by the Permit Board. Bart Pittman, Joshua Brown, and Kevin Bowen were tendered for cross-examination by the parties and for questioning by the Permit Board. Kimberly Jacobs, Brenda Rody, and Jennifer Juan were tendered for cross-examination by the parties and for questioning by the Permit Board. All parties had an opportunity to re-direct their witnesses. Upon hearing from the Petitioners' witnesses, the Permit Board requested that MDEQ witness-Steve Bailey answer additional Permit Board questions.

Upon conclusion of the testimony, Mr. Furrh, Mr. Caples, and Mr. Negrotto made closing arguments. The matter was then presented to the Permit Board for its decision.

The Permit Board first considered the transfer of the Large Construction Storm Water Coverage, transfer of the Baseline Coverage, and transfer of the Air Construction Permit. On motion by Mr. Riecke and seconded by Mr. Leach, the Permit Board affirmed its previous decision to transfer the permit coverages and air construction permit to DFAH.

The Permit Board next considered the issuance, transfer, and modification of the Section 401 Water Quality Certification. Permit Board Member Wittman asked Mr. Furrh to read the definition of "mitigation" from the state regulations. Permit Board Member Bograd asked Mr. Furrh if the Permit Board made a procedural error when it required that the 3.84 onsite wetland area remain in a restrictive covenant. Mr. Furrh answered that the Permit Board did not make such a procedural error, but also stated that it was within the Permit Board's discretion to remove the restriction. Mr. Furrh stated in response to Permit Board member Hawkins's

question that MDEQ has placed restrictive covenants on wetlands but that it was rare. Mr. Hawkins also asked whether MDEQ staff would have approved the purchase of 16.5 acres of wetland credits as satisfaction of the mitigation requirements had the credits been purchased at the beginning of the project. Mr. Furrh responded "yes."

On motion by Mr. Riecke and seconded by Mr. Leach, the Permit Board affirmed its decision to issue the Section 401 Water Quality Certification and its decision to modify and transfer the Certification to DFAH. Upon motion by Mr. Riecke and seconded by Mr. Leach, the Permit Board voted to rescind its previous decision requiring DFAH to place the 3.84 acres of onsite wetlands in a restrictive covenant.

#### **CONFIRMATION OF THE NEXT REGULAR PERMIT BOARD MEETING**

Michael Bograd confirmed that the next Regular Meeting will be held on April 11, 2017.

#### **MEETING ADJOURNED**

There being no further business to come before the Permit Board, Michael Bograd adjourned the meeting.
