Design Precast and Pipe, Inc., submitted a Notice of Intent and Storm Water Pollution Prevention Plan (SWPPP) for coverage under the Ready Mix Concrete Multimedia General Permit (RMCGP) for its existing facility in Gulfport, Mississippi. The RMCGP covers the operation of air emissions equipment, discharge of process wastewater, and storm water runoff from ready mix concrete facilities. MDEQ deemed the Notice of Intent and SWPPP complete. During the application review process, MDEQ's Environmental Permits Division received two letters from contiguous landowners opposing the facility. The contiguous landowners primarily objected for reasons related to local land-use and zoning. The contiguous landowners who opposed the project were invited to the Permit Board meeting, but did not attend. There were no visitors present to speak for or against the proposed permit. Michael Griffith stated that MDEQ had concluded that the permit application and proposed permit met requirements of the applicable laws and regulations including the regulatory siting criteria. Mr. Griffith recommended that the Permit Board issue the coverage to Design Precast and Pipe, Inc.

On motion by Julie McLemore and seconded by Howard Leach, the Permit Board voted to accept the staff's recommendation to issue the coverage.

Energy / Water II Branch

Mississippi Lignite Mining Company

MDEQ reissued NPDES Permit No. MS0054046 to Mississippi Lignite Mining Company on January 30, 2014. The permit required Mississippi Lignite to monitor total recoverable selenium for the first three years of the permit. Mississippi Lignite would then be subject to numeric water quality based effluent limitations for total recoverable selenium approximately three years after the permit issuance date. On January 20, 2017, Mississippi Lignite requested a permit modification allowing it to continue monitoring total recoverable selenium and to extend imposition of numeric water quality based effluent limitations to February 1, 2022. Pursuant to state regulations: "Whenever a new Water Quality Based Effluent Limit is imposed in a permit, the permittee shall have no more than three years in which to achieve compliance with such limitations. A permittee may apply to the Permit Board for a variance from the compliance schedule." 11 Miss. Admin. Code Pt. 6, R. 1.2.6.I (emphasis added). Thus, Mississippi Lignite has applied to the Permit Board for a variance to the compliance schedule in the permit. Mississippi Lignite also included in its modification request recommended permit language requiring Mississippi Lignite to submit routine progress reports to MDEQ. MDEQ sent the proposed modified permit to EPA on April 20, 2017, and EPA responded that it had no comments or objections via an email dated May 31, 2017. The proposed permit went to public notice June 19, 2017, and no comments were received from the public.

Staff of MDEQ's Environmental Permits Division introduced Mississippi Lignite's request for a compliance schedule variance for selenium. Mississippi Lignite's legal counsel, Mr. John Brunini with Butler Snow LLP, presented the request to the Permit Board and explained the reasons for the request. Mr. Brunini specifically stated that after a year of monitoring, Mississippi Lignite discovered that it was discharging selenium above the current Mississippi water quality standard for selenium. He also acknowledged that in 2016, EPA published revised national recommended aquatic life criteria for selenium. Mississippi Lignite believes, based on recent fish tissue sampling, that it can meet the 2016 EPA recommended aquatic life criteria for selenium. Mississippi has not yet adopted the 2016 recommended criteria for selenium. The MDEQ Water Quality Standards program will be conducting a Triennial Review in 2018 and will be considering the adoption of the latest recommendations for selenium as part of that process. Based on past triennial reviews, it is typically a two to two-and-a-half year process for revisions to the MS Water Quality Criteria to be adopted by the Commission and then approved by EPA. Mr. Brunini stated that Mississippi Lignite cannot consistently meet Mississippi's current selenium standard. Thus, Mississippi Lignite requested a compliance schedule variance in the event that Mississippi adopts the 2016 recommended aquatic life criteria for selenium or to allow Mississippi Lignite additional time to choose among a list of options that would enable it to meet Mississippi's current selenium standard. Krystal Rudolph, Chief of MDEQ's Environmental Permits Division, recommended that the Permit Board grant the variance.

On motion by Howard Leach, seconded by Leslie Royals, the Permit Board voted to accept MDEQ staff's recommendation and granted Mississippi Lignite's request for the compliance schedule variance for selenium.
