Gentlemen:

Covington Civil and Environmental, LLC (CCE), on behalf of the Mississippi State Port Authority, is pleased to submit the enclosed permit application for coverage of the subject construction project under MDEQ's Large Construction Storm Water General Permit for land disturbing activities of greater than five (5) acres. This is a revised application submittal for the LCNOI submitted on December 6, 2010. The submitted material includes:

1. Permit Application signed by Mr. John Webb, P.E., Deputy Director, Engineering, Mississippi State Port Authority and
2. Storm Water Pollution Prevention Plan (SWPPP) governing the construction of the proposed facilities, including applicable construction drawings and inspection and monitoring forms.

The Mississippi State Port Authority is proposing to construct an approximately 11.5-acre, limestone parking area for emergency parking of containers, vehicles and equipment in case the main port facilities are threatened by a major storm. The proposed site is located approximately 2 miles inland from the port.

As shown, the drainage from the limestone parking lot will be collected in ditches in the parking area and directed to a sediment/detention pond where the stormwater runoff will be slowly discharged thorough an outfall structure to the undeveloped area west of the sediment/detention pond. The sediment/detention pond will not only control the volume of water being released from the site due to the improvements, but will also allow any sediment to settle out in the sediment/detention pond before the stormwater is released. The submitted improvements have been reviewed with Mr. Kris Riemann, P.E., Director of Engineering, City of Gulfport. Since this project is on state-owned property, permitting and approval of this project from the City of Gulfport is not required.

The Mississippi State Port Authority is hoping to get this project permitted and constructed very soon. The Mississippi State Port Authority has decided not to use FEMA funds for this project, so going through the Environmental Assessment and Public Notice requirements for FEMA funding will not be done.

Your assistance in reviewing and approving this permit application will be greatly appreciated. If you desire to visit the site, we will be glad to schedule a time for such a visit. Additionally, be aware that the contractor who will construct the parking lot has not been selected, yet. Once the contractor is selected and under contract, we will submit all required paperwork identifying the contractor whose responsibility will be to implement the enclosed storm water requirements.
