Proposed amendments to 11 Miss. Admin. Code, Part 1, Chapter 5. (For
information. No action needed)

MDEQ staff is providing information on a public notice for comment on proposed amendments to the Permit Board's administrative procedure regulations, 11 Mississippi Administrative Code, Part 1, Chapter 5. The proposed amendments directly align requirements of the Mississippi Environmental Permit Board's makeup with requirements of the Federal Clean Air Act. This action, in conjunction with actions by the Mississippi Commission on Environmental Quality, will allow EPA to remedy partial-disapprovals of recent state plan submittals to address requirements for the National Ambient Air Quality Standards under the Clean Air Act. The 30-day public comment period began February 2, 2018, and will conclude with a public hearing to be held on March 5, 2018. Following the conclusion of the public participation process, staff intends to bring the proposed amendments to the Permit Board for approval at the March 13, 2018 meeting.
