MISSISSIPPI COMMISSION ON ENVIRONMENTAL QUALITY OFFICIAL MINUTES **NOVEMBER 17, 2017**

The regular monthly meeting of the Commission on Environmental Quality was held on Friday, November 17, 2017, in the Commission Hearing Room, 515 East Amite Street, Jackson, Mississippi, beginning at 9:00 a.m. Commissioners present were:

John Dane III Brenda Lathan Jamie Martin Billy Van Devender Jack Winstead, Chairman

Commissioners Dick Flowers and Chat Phillips were not present.

Others present were: Gary Rikard, Executive Director; Krista Caron, Willie McKercher, Dusty Myers, Kay Whittington, staff of MDEQ; and other staff members and visitors whose names appear elsewhere in these minutes.

The meeting was called to order by Chairman Winstead, and after Mr. Van Devender led the invocation, the following business was transacted:

Notice of Meeting

The Commission was informed that the legal Notice of Meeting concerning the time, date, and place of this meeting had been posted publicly as required by law. The Notice of Meeting read as follows: "Please take note that the regularly scheduled meeting of the Mississippi Commission on Environmental Quality for November, 2017, will take place on Friday, November 17, 2017. This meeting will be held in the Commission Hearing Room at the offices of the Mississippi Department of Environmental Quality at 515 East Amite Street, Jackson, Mississippi. As always, the public is invited to attend." This notice was posted in the lobby of the MDEQ offices in Jackson on October 17, 2017.

Approval of Minutes

On motion made by Ms. Lathan and seconded by Mr. Van Devender, the minutes of the August 24, 2017 meeting were approved and adopted as the Official Minutes.

Commission Approval of Hazardous Waste Regulation Revisions

Ms. Krista Caron stated a public hearing was held on November 7, 2017, concerning the revisions to the Mississippi Hazardous Waste Management Regulations. These revisions, which were previously sent to the Commission for review, were proposed to clarify the delegation authority of the Mississippi Department of Environmental Quality (MDEQ) in previously adopted hazardous waste regulations and to correct typographical errors. In addition, these revisions are necessary for the reauthorization of MDEQ's Hazardous Waste Management Program by the U.S. EPA. The proposed revisions do not represent new rule making by MDEQ or adoption of any new rule promulgated by EPA. There were no attendees to the public hearing and staff received no comments. Staff recommended the Commission adopt the hazardous waste regulation revisions to maintain consistency between the Mississippi Hazardous Waste Regulations and the EPA Hazardous Waste Regulations as required by 40 CFR 271.4. Following staff presentation and after deliberation, on motion made by Mr. Van Devender and seconded by Mr. Dane, the Commission unanimously voted to adopt the revisions to the Mississippi Hazardous Waste Management Regulations.

Environmental Covenant for Key Energy Services, LLC

Pursuant to the Commission's delegation regulations (11 Miss. Admin. Code Pt. 1, R.1.1.Y.), Mr. Willie McKercher stated the Executive Director of MDEQ approved the Environmental Covenants between the Commission and Key Energy Services, LLC regarding the remediation of property located at 1304 West Main Street in Sandersville, MS. Key Energy Services, LLC operated the site as the Moncla Well Services, an oilfield support operation. Environmental Site Assessments revealed a release of petroleum impacting soils and groundwater at concentrations in excess of Target Remediation Goals (TRGs), so remediation of the site is necessary. The staff of the MCEQ evaluated the proposed Environmental Covenant and believes that, with the conditions and restrictions contained within; the site will be in compliance with applicable State laws and standards and will be protective of the public health and the environment. This briefing was for informational purposes only, requiring no action by the Commission.

Revised Environmental Covenant for Letourneau Main Plant

Pursuant to the Commission's delegation regulations (11 Miss. Admin. Code Pt. 1), Mr. Willie McKercher stated the Executive Director of MDEQ approved the Environmental Covenants between the Commission and Cameron International Inc. regarding the property located at 500 LeTourneau Road in Vicksburg, MS. The site is referred to as the LeTourneau Main Plant Site (Site). Environmental Site Assessments revealed the Site was impacted with chlorinated solvents in the groundwater in excess of Target Remediation Goals (TRGs). The original Environmental Covenant issued through Order No. 6045 11 included 0.1 acres of property. Cameron International Inc. requested the Environmental Covenant to be increased to 3.68 acres of property. The staff of the MCEQ evaluated the proposed Environmental Covenant and believes that, with the conditions and restrictions contained within; the site will be in compliance with applicable State laws and standards and will be protective of the public health and the environment. This briefing was for informational purposes only, requiring no action by the Commission.

Environmental Covenant for FPR, LLC

Pursuant to the Commission's delegation regulations (11 Miss. Admin. Code Pt. 1, R.1.1.Y.), Mr. Willie McKercher stated the Executive Director of MDEQ approved the Environmental Covenants between the Commission and FPR, LLC regarding the remediation of property located on Soldier Colony Road in Canton, MS. The previous property owner, Dwight Kerry Rudder, operated the site as Rudder Flying Service. Environmental Site Assessments revealed a release of toxaphene impacting soils and groundwater at concentrations in excess of the Target Remediation Goals (TRGs), so remediation of the site is necessary. The staff of the MCEQ evaluated the proposed Environmental Covenant and believes that, with the conditions and restrictions contained within; the site will be in compliance with applicable State laws and standards and will be protective of the public health and the environment. This briefing was for informational purposes only, requiring no action by the Commission.

Environmental Covenant for POM Enterprises

Pursuant to the Commission's delegation regulations (11 Miss. Admin. Code Pt. 1, R.1.1.Y.), Mr. Willie McKercher stated the Executive Director of MDEQ approved the Environmental Covenants between the Commission and POM Enterprises regarding the remediation of property located on 400 West Main Street in Ackerman, MS. POM Enterprises operated the site as Trinity Industries. Environmental Site Assessments revealed petroleum hydrocarbons and chlorinated impacting soils and groundwater at concentrations in excess of the Target Remediation Goals (TRGs), so remediation of the site is necessary. The staff of the MCEQ evaluated the proposed Environmental Covenant and believes that, with the conditions and restrictions contained within; the site will be in compliance with applicable State laws and standards and will be protective of the public health and the environment. This briefing was for informational purposes only, requiring no action by the Commission.

Transfer of Environmental Covenant for DG Investments

Pursuant to the Commission's delegation regulations (11 Miss. Admin. Code Pt. 1), Mr. Willie McKercher stated the Executive Director of MDEQ approved the Environmental Covenant transfer upon the sale of land among the Commission, HSC Gulfport, LLC (current owner), and DG Investments (prospective owner) regarding the remediation of property located at 3283 Pass Road in Gulfport, MS. HSC Gulfport, LLC operated the site as the Holcomb Paint Factory. Environmental Site Assessments revealed contamination with C9-C10 Aromatics, C9-C18 Aliphatics, and C11-C22 Aromatics in excess of the Tier 2 Target Remediation Goals (TRGs), so remediation of the site is necessary. The staff of the MCEQ evaluated the proposed Environmental Covenant and believes that, with the conditions and restrictions contained within; the site will be in compliance with applicable State laws and standards and will be protective of the public health and the environment. This briefing was for informational purposes only, requiring no action by the Commission.

Notice of Proposed Amendments to Administrative Procedures Act Rules - 11 Miss. Admin. Code Pt. 7, Ch. 3 for Dam Safety

Mr. Dusty Myers stated the Dam Safety Division in the Office of Land and Water Resources is

working on amending the Dam Safety Regulations to include provisions for the use of an incremental consequence analysis based spillway design approach. This approach, which is currently being used in several other states, will allow greater flexibility in the regulations by taking into consideration any flooding which is occurring at the structures at risk downstream prior to a failure of the dam. If there are no incremental consequences resulting from the failure, this approach would allow for a reduction of the required design rainfall event. As part of this update process, other revisions and additions regarding minimum design and permitting requirements are being included to ensure the regulations match current dam safety policies and procedures. The proposed amendments were made available for public comment in early November and a public hearing is scheduled for December 5, 2017. After the conclusion of the public hearing staff will take into consideration any comments received and then present the proposed amendments to the Commission at a future meeting with a recommendation for adoption. This briefing was for informational purposes only, requiring no action by the Commission.

Delta Sustainable Water Resources Task Force Update

Ms. Kay Whittington provided an update to the Commission on the work of the Delta Sustainable Water Resources Task Force. The Task Force was created to develop and implement strategies to stabilize water level declines in the Mississippi River Valley Alluvial Aquifer, which supplies most of the water used for agricultural irrigation and aquaculture in the Mississippi Delta. The briefing focused on conservation practices required through water use permitting, modeling to evaluate water availability, and data collection to enhance the understanding of the aquifer system and improve model accuracy. Mr. Winstead emphasized the importance of addressing the problem and critical role of the CEQ. He also suggested we might hold a future Commission meeting in the Delta. This briefing was for informational purposes only, requiring no action by the Commission.

Asbestos Certifications

On previous authority delegated to the Head, Office of Pollution Control, the staff reported that 172 lead paint certifications had been issued since the last report.

Underground Storage Tank (UST) Certifications

On previous authority delegated to the Head, Office of Pollution Control, the staff reported that 22 certifications to those who install, alter, or remove underground storage tanks had been issued since the last report.

Wastewater Operator Certifications

On previous authority delegated to the Head, Office of Pollution Control, the staff reported that 60 wastewater operator certificates had been issued since the last report.

Administrative Orders

On previous authority delegated to the Executive Director, DEQ, the staff reported that 35 Administrative Orders, and 1 Amended Agreed Order, had been issued since the Commission's last meeting. A list of these orders is made a part of these minutes and is filed in the Official Minutes File.

Other Business

Executive Director Gary Rikard stated Mississippi's recent annual Restoration Summit was well received and that there would be an update on Restoration activities at the next Commission meeting. Mr. Rikard also informed the Commission that EPA Administrator Scott Pruitt was recently in town to meet with Governor Bryant and to gather stake holder input on the Waters of the United States and Clean Power Plan rules. Mr. Rikard and Mr. Winstead thanked Alice Perry for her outstanding work in handling the logistics of the meeting between Governor Bryant and Administrator Pruitt.

It was the decision of the Commission to distribute information on December's meeting date in the near future.
