Amendments to 11 Miss. Admin. Code Pt. 5, Ch. 3 Underground Storage Tank Regulations for the Certification of Persons Who Install, Alter, and Remove Underground Storage Tanks (UST-3) Commission Regulations

PLEASE TAKE NOTE that the Mississippi Commission on Environmental Quality ("Commission") is considering amendments to the 11 Miss. Admin. Code Pt. 5, Ch.2 Underground Storage Tank Regulations Technical Standards (UST-2) and the 11 Miss. Admin. Code Pt. 5, Ch. 3 Underground Storage Tank Regulations for the Certification of Persons Who Install, Alter, and Remove Underground Storage Tanks (UST-3).

### I. Substance of the Proposed Amendments

- 1. The Mississippi Department of Environmental Quality (MDEQ), as staff of the Commission, prepared proposed amendments to the Underground Storage Tank Regulations Technical Standards (UST-2) to comply with federal regulations published July 15, 2015. These mandates include new or revised requirements for integrity testing for containment sumps, piping replacements, fuel type changes, release detection, and walkthrough monthly and annual inspections. The proposed amendments also include additional changes to enhance and protect human health, safety, and the environment. These proposed changes include requirements for airport hydrant systems and field constructed tanks, lender liability requirements to maintain USTs for future operation, and more specific reporting requirements. For all of the specific proposed changes, please review the proposed amendments, which are available as described below. This notice of rulemaking is provided pursuant to Miss. Code Ann. §§ 25-43-3.101, et seq., 49-17-25, and 49-17-413.
- 2. MDEQ, as staff of the Commission, also prepared proposed amendments to the Underground Storage Tank Regulations for the Certification of Persons Who Install, Alter, and Remove Underground Storage Tanks (UST-3). The proposed amendments provide two additional UST certification licensures, UST Technician and UST Cathodic Protection Tester, to ensure consistent, quality UST contractor services throughout the State while requiring the appropriate level of training, education, and testing prerequisites for applicants. For all of the specific proposed

changes, please review the proposed amendments, which are available as described below.

The proposed amendments to the 11 Miss. Admin. Code Pt. 5, Ch. 2 Underground Storage Tank Regulations Technical Standards (UST-2) Commission Regulation and 11 Miss. Admin.
