**THE PERMIT BOARD CONSIDERED THE FOLLOWING
OFFICE OF POLLUTION CONTROL MATTERS:**

Air Division

Amendments to 11 Miss. Admin. Code, Part 1, Chapter 5.

MDEQ staff recommended that the Permit Board adopt proposed amendments to the Permit Board's administrative procedure regulations, 11 Mississippi Administrative Code, Part 1, Chapter 5. The amendments directly align requirements of the Mississippi Environmental Permit Board's makeup with requirements of the Federal Clean Air Act. This action, in conjunction with actions by the Mississippi Commission on Environmental Quality, will allow EPA to remedy partial-disapprovals of recent state plan submittals to address requirements for the National Ambient Air Quality Standards under the Clean Air Act. A public hearing was held on March 5, 2018, after a 30-day public comment period. No verbal comments were received at the public hearing. Written comments were received and were provided to the Permit Board for consideration prior to the meeting. The Permit Board allowed two visitors to address the Board regarding the proposed amendments. Ms. Catherine Eglund, with the Mississippi State Conference of the NAACP, suggested that the Permit Board meetings should be more inclusive and transparent and requested that the Board consider holding its meetings via Skype or webinar. She also encouraged the Permit Board to hold at least one meeting per year in a different congressional district. Ms. Ruth Story, the Executive Director of the Education, Economics, Environmental, Climate and Health Organization, suggested that the regulations should be further amended to include state statutory requirements regarding statements of economic interest and other ethics in government requirements. Ms. Story suggested that for future actions involving amendments to regulations, that the public should be provided with direct links to where the subject regulations can be found on MDEQ's website. Neither Ms. Eglund nor Ms. Story objected to the proposed regulation amendment. Staff recommended that the Permit Board adopt the proposed amendments.

On motion by Jim Hoffmann and seconded by Chris McDonald, the Board accepted the staff's recommendation to adopt the proposed amendments.

Water I Branch

Issuance of Coverage to Le Poultry under the DLPAFO General Permit #MSG201968, Pike County

Issuance of Coverage to Le Poultry under Large Construction Storm Water General Permit #MSR107600, Pike County

Le Poultry applied for coverage under the State of Mississippi Dry Litter Poultry Animal Feeding Operation Multimedia General Permit (No. MSG201968) and the Large Construction Storm Water General Permit (No. MSR107600) for eight proposed poultry houses to be located in Pike County at 1159 Pumping Station Road in Osyka, Mississippi. Tracy Tomkins, Chief of the Water Branch I of MDEQ's Environmental Permits Division, stated that Le Poultry submitted a Large Construction Notice of Intent, a Construction Storm Water Pollution Prevention Plan, a Dry Litter Poultry Notice of Intent, and a Comprehensive Nutrient Management Plan developed by the Natural Resources Conservation Service ("NRCS") as part of the permit applications. The applicant proposed to disturb approximately nine acres of land to construct eight poultry houses which would house 184,000 broilers. As stated in the nutrient management plan prepared by NRCS, all litter will be transferred off site. MDEQ considered the application complete on December 27, 2017.

As required by the Poultry General Permit, the permit applicant notified the contiguous landowners of the proposed poultry facility. Specifically, Le Poultry sent contiguous landowner notifications in November 2017. In response to the notifications, MDEQ received 13 letters of concern and a copy of a petition with 237 signatures protesting the proposed facility which had been submitted to the Pike County Board of Supervisors. The letters expressed concerns with the impact of the proposed poultry facility on property values, health, and odor issues. Some letters expressed concerns that litter from the proposed facility could potentially contaminate groundwater and could adversely impact water wells in the area. Pauline and Billy Magee were concerned about how the proposed poultry facility would impact their cattle operation which they run on approximately 52 acres of land they own which is contiguous to the proposed facility. The letters all objected to the poultry houses being built in the community. The Permit Board allowed visitors to state their concerns and ask questions about the proposed facility. Mississippi State Senator Tammy Witherspoon of Pike County shared her concerns that the area would become saturated with chicken houses, high levels of nitrogen, and water contamination. Senator Witherspoon asked the Permit Board to create a study of potential air and ground water from oversaturation of chicken houses and submit the study to the Senate Committee on Environmental Protection, Conservation, and Water Resources of which she is the Vice Chair. Ms. Denise Weatherspoon, a respiratory therapist, stated that large concentrations of ammonia would be bad for people with lung conditions. Some of the visitors criticized the 17-day time period that contiguous landowners were allowed to submit comments upon receiving contiguous landowner notification. Ms. Gloria Tatum, former MDEQ Environmental Justice Coordinator, felt that MDEQ staff should have reached out and been more informative to the residents in the area and held a community engagement meeting prior to presentation to the Permit Board due to the interest in the proposed poultry facility. Ms. Melissa Collier, Director of MDEQ's Office of Community Engagement stated her belief that MDEQ could do better regarding the notification. Among other speakers were Eddie Simmons, Steffie Patterson, Randy Tate, Tom Nally, Bobby Carson, Tiljuana Smith, Ralph Varnado, NAACP representative Charles Hampton and Magnolia Mayor Anthony Witherspoon who all opposed the proposed poultry facility. Ms. Tomkins informed the Permit Board that although the contiguous landowner notifications allow contiguous landowners 17 days to submit comments, MDEQ continued to receive and consider comments well beyond the 17 days. The applicable regulations do not require any notice to contiguous landowners and the notifications are required by the General Permit.

Ms. Tomkins made the presentation to the Permit Board. Ms. Tomkins stated that landowner notifications were sent in November 2017. She stated that MDEQ's regional office conducted a site inspection on January 22, 2018. At that time, the proposed site complied with the required buffer distances. Specifically, the regulatory siting criteria provide that a proposed poultry facility cannot be closer than 150 feet from an adjoining property line nor 600 feet from an occupied dwelling not owned by the permit applicant. MDEQ's Environmental Permits Division conducted a follow-up inspection on April 3, 2018. The follow-up inspection revealed that a trailer had been moved into the buffer zone onto an adjacent 52-acre parcel owned by Pauline and Billy Magee. The trailer is located approximately 311 feet from the closest of the proposed poultry houses. Ms. Tomkins stated that the homeowners (Pauline or Billy Magee) told the MDEQ inspector during the April 3, 2018, site visit that the trailer was unoccupied at the time of the inspection. Billy Magee told the Permit Board that the markings for a paved driveway were visible in January 2018. He stated that the trailer has 911 service, a septic tank (which had not been approved by the health department), and a water well, which had been drilled in September 2017. Billy Magee stated that he is currently using a generator for electricity because the power

company was months behind in making connections. Billy Magee stated that he and Pauline Magee plan to live in the trailer full time once the electricity is connected. He stated that he purchased the trailer sometime between March 8-12, 2018, and placed it on his property in late March 2018. Billy Magee stated he currently lives at 7077 Stateline Road, Osyka, Mississippi, which is approximately 4,000 feet from the proposed location of the poultry houses. He mentioned that he built a 3-car garage and a large studio room where he currently lives. He indicated that he planned to build a permanent home, but the cows took priority. He indicated that he contracted with NRCS in either 2015 or 2016 to design a pond to water his cattle. He stated that he contracted with NRCS in January of 2017 for a water well system. He indicated that installation of the water well was started in June of 2017 and completed in September of 2017. When questioned, Ms. Tomkins stated that Billy and Pauline Magees' December 1, 2017, letter sent to MDEQ never mentioned their plans to move a trailer towards the proposed poultry houses. Pauline Magee read the December 1, 2017, letter to the Permit Board and indicated she felt that she was only allowed to comment on environmental issues.

Jimmy Le owns Le Poultry. Mr. Le does not have experience raising chickens; however, he stated that he has worked on his brothers' chicken farms to gain experience. He stated that he had been planning his own poultry farm for three years and he looked at many properties that would meet the 80 minimum acres required by his integrator Sanderson Farms. Ms. Tomkins stated that NRCS designed the layout of the proposed facility. Mr. Le stated he did not attempt to obtain a buffer zone waiver from Pauline and Billy Magee because he did not know he needed one. When Permit Board Member Leslie Royals asked Billy and Pauline Magee if it would be acceptable for Mr. Le to move two of the poultry houses and the compost facility away from their property, they responded that it would not be acceptable. Mr. Le was not sure whether reconfiguring would be possible. Ms. Tomkins stated that Mr. Le would need to coordinate with the Natural Resources Conservation Service and Sanderson Farms, the integrator, if reconfiguration resulted in changing the footprint of the proposed facility. Mr. Le stated he has time-limited contracts with Sanderson Farms which gave him timeframes for construction of the poultry houses. He stated Sanderson Farms has already extended the timeframes a few times and was not sure if they would extend the timeframe again. Mr. Le plans to build a residence and live on the site of his proposed poultry facility. Mayor Witherspoon asked the Permit Board to clarify how variances could be issued to reduce buffer zone requirements. MDEQ staff indicated that permit variances could be requested by the permit applicant (Mr. Le); that adjacent landowners in the buffer zone could grant a waiver; and when deciding on a buffer zone variance request, the Permit Board could consider such factors that it deems appropriate.

Roy Furrh, MDEQ's General Counsel, stated that the Permit Board could grant a variance to the siting criteria if it found the trailer was an occupied dwelling. He stated that the Board had the following four options: (1) deny the permit coverages; (2) issue the permit coverages consistent with MDEQ staff recommendation; (3) if the Permit Board determined the trailer was an occupied dwelling, the Board could grant a variance (upon Mr. Le's request) to the siting criteria and issue the coverages; or (4) the Board could postpone the matter and make a decision at a subsequent meeting.

On motion by Chris McDonald, and seconded by Jim Hoffmann, the Permit Board then voted to close the meeting to discuss whether to go into executive session. The meeting was then closed and the only discussion during the closed session was whether the Board should go into executive session. The Permit Board voted not to go into executive session and to return to open session. Mr. Furrh next advised the meeting attendees that interested parties aggrieved by the Permit Board's decision had the right to request an evidentiary hearing before the Permit Board within 30 days of the Permit Board's initial decision. If a participating party in an evidentiary hearing is aggrieved by the Permit Board's final decision, that party may appeal the Permit Board's decision following an evidentiary hearing to the Chancery Court of Pike County. If no interested party requests an evidentiary hearing within 30 days of the Permit Board's initial decision that decision becomes final.

Ms. Tomkins recommended that the Permit Board issue the coverages under the AFO General Permit and the Large Construction Storm Water General Permit.

On motion by Chris McDonald and seconded by Jim Hoffmann, the Permit Board voted to postpone its decision on Le Poultry's application for coverage under the Dry Litter Poultry Animal Feeding Operation General Permit and Coverage under the Large Construction Storm Water Permit and, in the interim, directed MDEQ staff to schedule a meeting with a representative of MDEQ, the Natural Resources Conservation Service, Mr. Le, and a representative of the concerned citizens to explore the possibility of reconfiguring the proposed poultry farm house footprint in an effort to accommodate Mr. and Ms. Magee. The Permit Board instructed the parties to then bring the matter back at the May meeting for the Board's consideration.

Surface Mining Permit to Transfer

L. D. Hancock Family, LLC (Lee County) requested transfer of their permit P94-136T to James A. Hodges Construction, Inc. James A. Hodges Construction, Inc. provided the proper bonding and transfer forms to MDEQ. Upon approval by the Permit Board, the new permit number for James A. Hodges Construction, Inc. will be P94-136T. The staff recommended approval of the transfer request.

Surface Mining Permit to Transfer Revision

At the March 13, 2018 Permit Board meeting there was a typographical error on the Permit Board agenda regarding the D.W. Lamey Fill and Trucking, Inc. transfer to DeSoto Services, LLC. Specifically, the agenda noted P04-022AA as the permit number. This number was typed in error. (This number belongs to an inactive permit). The correct surface mining permit number is P04-006AA. Therefore, staff requested that the transfer of P04-006AA, be approved. The new permit number would be P04-006AAT, if approved.

On motion by Jim Hoffmann and seconded by Jennifer Wittmann, the Permit voted to approve the above surface mining permit transfer and surface mining permit transfer revision. (David Dockery abstained)

OTHER BUSINESS

MDEQ’s General Counsel, Roy Furrh, stated that MDEQ provided the Permit Board a link to MDEQ’s website where they could view the Waste Division’s “Annual Status Report on Solid Waste Management Facilities and Activities” summarizing the solid waste activities that took place in the state for calendar year 2016. The status report is based on information provided by individual solid waste facility owners for 2016 as required by state law and regulations and by the facility operating permits. The 2016 report includes summary information on activities conducted by Municipal Solid Waste Landfills; Class I and Class II Rubbish Sites; Industrial and Institutional Disposal Facilities; Transfer Stations; Land Application Sites; Processing Facilities; Composting Facilities; Beneficial Use Determination Holders; and Waste Tire Management Facilities.

Mr. Furrh also reminded the Permit Board that the Statements of Economic Interest for Permit Board members and designees must be completed electronically and filed with the State Ethics Commission by May 1, 2018.
