This report summarizes the activities accomplished from February 1 to February 28, 2018, in order to comply with Resource Conservation and Recovery Act (RCRA) 3008(h) and RCRA 3013(a) Orders for the former Hercules Hattiesburg Plant.

#### TASKS INITIATED, CONTINUED, OR COMPLETED DURING FEBRUARY 2018

- Completed backfilling the Impoundment Basin (IB) with compacted soil including installation of liner.
- Completed final restoration of IB area (topsoil, seed, mulch).
- Completed IB/ET-10 decommissioning demobilization activities.
- Continued preparation of the Consolidated Semiannual Groundwater Monitoring Report, including a summary of completed activities for the Restricted Use Agreed Order (RUAO), Area #1, and Area #2.
- Conducted the second quarterly groundwater sampling event for the Poly Pale<sup>™</sup> Area.
- Conducted soil and groundwater investigations of potential historical pits identified during evaluation of aerial photographs for the site.

- Participated in a conference call with the U.S. Environmental Protection Agency (USEPA) and Mississippi Department of Environmental Quality (MDEQ) on February 20, 2018, to discuss pending work and the next steps for the human health and ecological risk assessments.
