This report summarizes the activities accomplished from April 1 to April 30, 2018, in order to comply with Resource Conservation and Recovery Act (RCRA) 3008(h) and RCRA 3013(a) Orders for the former Hercules Hattiesburg Plant.

#### TASKS INITIATED, CONTINUED, OR COMPLETED DURING APRIL 2018

- Demolished ET-10 and graded area.
- Hauled concrete debris to Pine Belt Regional Landfill for disposal. Metal was recycled.
- Demobilized from the site.
- Continued preparation of the IB/ET-10 Decommissioning Completion Report.
- Continued preparation of the Data Evaluation and Assessment of Exposure and Toxicity for the Baseline Risk Assessment draft report.
- Continued preparation of the Consolidated Semiannual Groundwater Monitoring Report, including a summary of completed activities for the Restricted Use Agreed Order (RUAO), Area #1, and Area #2.
- Continued preparation of the Draft Conceptual Site Model Update Report.

- Initiated preparations and coordination for preliminary data collection at the sludge pits to support evaluation of potential closure options.
- Participated in conference calls with the U.S. Environmental Protection Agency (USEPA) and Mississippi Department of Environmental Quality (MDEQ) on April 3 and April 23, 2018, to discuss pending work and the next steps for the human health and ecological risk assessments.
- Determined that the vapor intrusion work at the Former Commissary Building will not be conducted at this time. This determination was based on conversation and correspondence with the USEPA and MDEQ. The Work Plan (submitted June 29, 2017) will remain a draft document.
