Surface Mining Permit to Rescind

Kevin Haas Trucking, Inc. Hancock County P06-036

Kevin Haas Trucking, Inc. requested recission of its Surface Mining Permit, No. P06-036, and return of its bond. Staff advised the Permit Board that the site has been fully reclaimed and the property has been sold. The new landowner, Ronald Gouthreaux, is completely satisfied with the reclamation and does not wish to mine the property. His intentions are to use the site as a vacation home with pond and land. MDEQ staff inspected the site and recommended approval of Kevin Haas requests.

On motion by Duncan Welch and seconded by Jim Hoffmann, the Board accepted the staff's recommendation to rescind the permit and return the bond. (David Dockery abstained)

THE PERMIT BOARD CONSIDERED THE FOLLOWING OFFICE OF POLLUTION CONTROL MATTERS:

Water I Branch

Issuance of Coverage to Le Poultry under the DLPAFO General Permit MSG201968, Pike County

Issuance of Coverage to Le Poultry under the Large Construction Storm Water General Permit MSR107600, Pike County

Le Poultry applied for coverage under the State of Mississippi Dry Litter Poultry Animal Feeding Operation Multimedia General Permit (No. MSG201968) and the Large Construction Storm Water General Permit (No. MSR107600) for eight poultry houses to be located in Pike County at 1159 Pumping Station Road in Osyka, Mississippi. The Permit Board initially considered these two permit coverages at its meeting on April 10, 2018, after receiving public comment. At that meeting, the Permit Board voted to postpone its vote and directed MDEQ staff to schedule a meeting with a representative of MDEQ, the Natural Resources Conservation Service ("NRCS"), Mr. Jimmy Le (owner of Le Poultry) and a representative of the concerned citizens to explore the possibility of reconfiguring the proposed poultry farm house footprint to accommodate Mr. and Ms. Pauline and Billy Magee who are contiguous landowners. Tracy Tomkins, Chief of the Water Branch I of MDEQ's Environmental Permits Division, stated that, following the April 10th Permit Board meeting, MDEQ staff held a community meeting at Shady Grove Missionary Baptist Church in Osyka, Mississippi, on April 16, 2018. Ms. Tomkins stated that several members of the community were present and afforded an opportunity to question MDEQ staff after staff made a presentation regarding MDEQ's permitting process. Ms. Tomkins stated that MDEQ extended the public comment period to April 30, 2018. MDEQ received more than 350 comment letters and forwarded the letters to the Permit Board members prior to the Board's May 10, 2018, meeting.

MDEQ also received comment letters after the end of the extended comment period up until the day before the Permit Board meeting. The Permit Board considered the comment letters, even those submitted after the comment period ended, before the meeting.

Ms. Tomkins stated that on April 25, 2018, she and Melissa Collier, MDEQ's Director of the Office of Community Engagement, went to the NRCS office in Pike County to meet with NRCS representatives, Mr. Le, community representatives Mr. Eddie Simmons and Mr. Billy Magee, and representatives from Le Poultry's integrator Sanderson Farms. Ms. Tomkins informed the Board that an alternative configuration of the poultry houses was presented which would move the proposed poultry houses more than 600 feet away from the trailer on Pauline and Billy Magees' property. Ms. Tomkins stated that the alternative configuration would cost Mr. Le more money because relocating the poultry houses would require more dirt work and would require him to replace the access road. At the NRCS meeting Mr. Le stated he would do what it takes to satisfy the community; at the same meeting, Mr. Billy Magee stated no configuration would satisfy the community. At the Permit Board meeting Mr. Billy Magee explained he made that statement because Mr. Le had not yet made a commitment to reconfigure the poultry houses. Mr. Le stated that the community will object no matter what he does. He stated that if the Permit Board found the Magees' trailer was an occupied dwelling, he requested a variance from the buffer zone requirements in the applicable regulations.

Permit Board Chair Dennis Riecke stated that this is the second time the matter had been presented to the Permit Board and to have an orderly and timely discussion, the Board would limit the comment time to a total of one hour. Mr. Riecke allotted five minutes to each person who wished to speak and stated each person would only be allowed to speak once. Mr. Riecke noted that the Permit Board had received several emails with comments that were sent in with letters, that according to Ms. Tomkins there were more than 350 comments, had received emails with numerous pages, had received questions from the NAACP, and MDEQ staff's response to the NAACP questions. The following speakers urged the Permit Board to deny the permit: Mississippi Representative Angela Cockerham; Mississippi Senator Tammy Witherspoon, Mayor of Magnolia Anthony Witherspoon; Ms. Pauline Magee; Mr. Billy Magee; Ms. Steffie Patterson; Mr. Randy Tate; President of the Mississippi Chapter of the NAACP Mr. Charles Hampton; Chair of the Concerned Citizens Mr. Eddie Simmons; and Ms. Gloria Morris. The opponents stated the following objections to issuance of the permit coverages: non-compliance with the buffer zone requirements; health concerns; concerns with air quality pertaining to the density of poultry houses in the area; an allegedly incomplete CNMP; alleged inaccuracies in the inspection report and checklist; lack of timely community engagement; and environmental justice issues. Several speakers urged the Permit Board to conduct a study regarding whether the number of poultry houses in an area would adversely impact air quality. While she acknowledged the county had no zoning prohibiting poultry houses in the area, Representative Cockerham stated the area where Le Poultry would be located had always been residential. The speakers concluded before the hour elapsed; thus, Permit Board Chair Dennis Riecke asked if anyone else would like to comment. No one else stepped forward to speak in opposition to the permit coverages. Mr. Riecke asked Mr. Le if he would like to speak. Mr. Le stated he wanted to move forward with his plans, but stated that he would respect the Permit Board's decision no matter how the Board decided.

Much of the meeting centered on whether the trailer on the Magees' property, which was placed within the 600-foot buffer zone from the proposed poultry houses after MDEQ's initial inspection, was an "occupied dwelling." Ms. Pauline Magee stated she and her husband purchased their land to provide a legacy to their children. She stated that their daughter plans to retire and live on the property. Ms. Magee stated she has lived in the mobile home on her property since March of 2018. She stated that the MDEQ inspector never asked whether the trailer was occupied. MDEQ visited the site on May 4, 2018, and saw that a power pole with an electric box had been erected. Staff could not ascertain whether the electricity had been connected to the trailer. Mr. Magee stated at the April Permit Board meeting that the agricultural well installed on his cattle farm with funds provided by NRCS was also the source of water connected to the trailer. NRCS informed MDEQ staff that it provided funds for the well, that NRCS does not fund residential wells, and that Mr. Magee would have to reimburse NRCS for the well if he uses the well for residential water supply. Mr. Magee stated that he plans to repay NRCS so he can use the well for residential purposes. Mr. Magee provided a document which he stated reflected the Mississippi Department of Health's ("MDOH's") approval for a septic system he previously installed on his land. The document did not reflect MDOH's approval. Mr. Duncan Welch, who was serving as the designee for Permit Board member Leslie Royals, and who is the Director of MDOH's Onsite Wastewater Division, offered to work with Mr. Magee to assist him with the approval process. Permit Board Chair Riecke asked Mr. Magee if he had any information showing that he lives in the trailer. Mr. Magee provided a bill from the electric company, with the address where the trailer is located, reflecting charges for hooking up the electricity. Mr. Magee provided a document reflecting he had paid for the hookup and stated he has had power since April 25, 2018. Permit Board Chair Riecke noted that every address he saw for the Magees was the 707 Stateline Road address and not the address where the trailer is located. Mr. Magee provided an email showing he had received a bill for garbage collection at the trailer's address. Mr. Magee stated he had not applied for homestead exemption for the trailer because of the uncertain condition he is in right now and that he has until March of next year to file if he so chooses. Mr. Magee

later produced a letter from MDEQ addressed to the trailer address on Emerald Stateline Road.

Ms. Tomkins responded to questions by the Permit Board related to a number of comments. Ms. Tomkins stated that several opponents sent information from the internet purportedly constituting studies related to hazards regarding poultry farms. Ms. Tomkins stated that much of the information submitted were actually articles from websites and no actual studies were submitted. She stated that some of the information provided was not related to poultry farms. Ms. Tomkins provided the Permit Board with a map showing there were two poultry farms in a three-mile radius of the Le Poultry site with a total of 12 poultry houses. The map showed there were three poultry farms within a five-mile radius of the Le Poultry site with a total of 16 poultry houses. Ms. Tomkins was not aware of any scientific studies linking adverse human health effects to permitted poultry houses. She stated the regulations, which include buffer zones, are designed to be protective. General Counsel Roy Furrh stated that some of the comment letters expressed concerns with incinerators; Ms. Tomkins stated that Le Poultry was not going to use incinerators. Mr. Furrh further stated that there were some comments regarding litter; Ms. Tomkins stated that all of the litter would be transferred off site. Mr. Furrh also asked if there would be any discharge of process wastewater discharge; Ms. Tomkins stated that there would be no discharge from the Le Poultry site.

Ms. Tomkins stated that at the time of staff's initial inspection, there were no structures within the regulatory 600-foot buffer zone or within the 1,000-buffer required by Mr. Le's integrator Sanderson Farms. She stated that Sanderson Farms took the position that because there was no trailer present when they did their initial inspection, Sanderson Farms was going to waive their 1,000-foot buffer requirement for the Le Poultry facility. Ms. Tomkins responded to the comment that the permit application and Comprehensive Nutrient Management Plan ("CNMP") were incomplete. She stated that much of the CNMP form did not apply to Le Poultry because the form mainly governs land application of litter and the CNMP was developed based on all of the dry litter being transferred offsite. If Le planned to landapply the litter, those pages would describe the tract where the litter would be land-applied, how much litter he can apply, when he can apply, and the crops that are to be located on those fields. Although there would be no litter applied to the Le Poultry site, MDEQ still required Le Poultry to submit a CNMP reflecting how much litter would be produced, how many poultry houses would be built, and where the houses would be placed. She stated that Le Poultry was not required to submit a producer's log to MDEQ; rather, Le Poultry will have to keep a producer's long on site for MDEQ inspectors to review when they visit the site. She stated the CNMP was complete from a permitting and regulatory standpoint.

Mr. Magee responded to the Permit Board's question-why they placed their trailer in its current location which is about 100 feet from an area on the Le Poultry site with a water drainage issue. Mr. Magee stated that the drainage issue was east of the trailer. When asked why they chose to place the trailer as close as he could to the property line when they have 52 acres of land, Ms. Magee explained that they were leaving space for their daughter to place her home site. He stated bad weather prevented them from placing the trailer on the site before March. Mr. Magee stated that his understanding of the buffer requirements had to do with a tree buffer. He stated he did not learn about the 600-foot buffer until way into the permitting process. Mr. Magee stated the first time he learned about the buffer zone requirements was when he received a copy of the site plan via email on April 6, 2018.

Mr. Magee questioned an MDEQ inspection report which stated there were no environmental justice concerns. He stated there were minorities, elderly, and low-income residents in the area. He stated that had MDEQ involved its Office of Community Engagement, MDEQ would have known there were environmental justice issues. Melissa Collier, the Director of MDEQ's Office of Community Engagement, addressed the Permit Board regarding MDEQ's community engagement process. Ms. Collier has flagged known environmental justice areas and the permit writer knows to contact her when a permit application has been filed for a flagged site. The Le Poultry site was not a flagged site or a known environmental justice site. Ms. Tomkins stated MDEQ's site inspector considered an environmental justice screen from the United States Environmental Protection Agency website, based on a 2010 census summary report, reflecting the percentage of minorities in the area, the educational level of residents, and the population by language spoken at home. The site inspector checked "no" to the question on the site inspection checklist asking whether there were environmental justice concerns based on his understanding after having reviewed the environmental justice screen. Had the inspector checked "yes" indicating the presence of environmental justice issues, that does not necessarily mean the matter would have been referred to the Office of Community Engagement. Ms. Tomkins stated that when she read the site inspection report, MDEQ had only received seven letters of concern. Once she became aware of the number of concerns in the community, Ms. Tomkins referred the matter to Ms. Collier around February 2018. Ms. Tomkins stated that MDEQ extended the comment periods, had meetings with the community, and had gone above and beyond what is required.

Ms. Tomkins reiterated staff's recommendation to issue the permit coverages. She stated the recommendation was based on no structures being in the buffer zone at the time of MDEQ's initial inspection. General Counsel Roy Furrh provided the Board with the following timeline: contiguous

landowner notifications were mailed in November 2017; MDEQ began receiving objection letters shortly thereafter; when MDEQ inspected the site in January 2018 there was no trailer in the buffer zone and Le Poultry met all buffer requirements at the time; the Magees purchased the trailer around March 8-12, 2018, and placed it within the buffer zone later in March; the trailer was present within the buffer zone when MDEQ inspected Le's site on April 3, 2018. Mr. Furrh stated the buffer requirements were met at the time MDEQ considered Le Poultry's permit application complete in December of 2017. Mr. Furrh stated the applicable regulations did not define "occupied dwelling." He stated the Permit Board needed to determine whether the Magees' trailer was an occupied dwelling; if the Board so determined, Mr. Furrh stated the Board would then need to consider Mr. Le's variance request. Chairman Riecke requested by a show of hands whether the Permit Board believed the Magees' trailer met the definition of "occupied dwelling." None of the Board members raised their hands. Mr. Furrh stated that in considering Le Poultry's permit applications, the Permit Board could consider Mr. Le's compliance history, financial capability, financial responsibility, or any other aspect of the applicant's history it deemed necessary or appropriate. Mr. Furrh stated that the Board did not have legal authority to require Mr. Le to obtain a bond or provide financial assurance.

On motion by Mr. McDonald and seconded by Mr. Welch, the Permit Board unanimously voted to issue the permit coverages to Le Poultry. Mr. Furth advised the audience that interested parties aggrieved by the decision could request an evidentiary hearing in writing within 30 days. After the vote, Representative Cockerham admonished the Board for not allowing her to make closing comments before voting on permit issuance. The Board then allowed her to state her comments. She stated the Magees are using their trailer as a home and that Mr. Le had constructive knowledge that the Magees planned to live on the land. She further stated that the Permit Board "grilled" Mr. Magee regarding his intent to live on his land, but did not similarly grill Mr. Le regarding the lack of tree buffer or his financial ability.

OTHER BUSINESS

MDEQ's General Counsel, Roy Furrh, informed the Permit Board that MDEQ staff from the Waste Division will make an educational presentation to the Permit Board in June on MDEQ's Solid Waste permitting application process.

CONFIRMATION OF THE NEXT REGULAR PERMIT BOARD MEETING

Chair Dennis Riecke confirmed that the next Regular Meeting will be held on June 12, 2018.

MEETING ADJOURNED

There being no further business to come before the Permit Board, Chair Dennis Riecke adjourned the meeting.
