# MISSISSIPPI COMMISSION ON ENVIRONMENTAL QUALITY OFFICIAL MINUTES JULY 26, 2018

The regular monthly meeting of the Commission on Environmental Quality was held on Thursday, July 26, 2018, in the Commission Hearing Room, 515 East Amite Street, Jackson, Mississippi, beginning at 9:00 a.m. Commissioners present were:

Patrick L. Johnson, Jr. Brenda Lathan Chat Phillips Jack Winstead, Chairman

Commissioners John Dane III and Billy Van Devender were not present.

Others present were: Gary Rikard, Executive Director; Joseph Curro, Tony Caldwell, Roy Furrh, staff of MDEQ; and other staff members and visitors whose names appear elsewhere in these minutes.

The meeting was called to order by Chairman Winstead, and after he said the invocation, the following business was transacted:

#### Election of Officers for Fiscal Year 2019 (July 2018 – June 2019)

On a motion made by Mr. Phillips and seconded by Ms. Lathan, the Commission voted to re-elect Jack Winstead to serve as Chairman and John Dane III to serve as Vice-Chairman of the Commission for Fiscal Year 2019. No other nominations were made.

#### Approval of Minutes

On motion made by Ms. Lathan and seconded by Mr. Johnson, the minutes of the May 24, 2018 meeting were approved and adopted as the Official Minutes.

#### Commission Approval of Brownfield Agreement

On behalf of staff, Mr. Joseph Curro recommended that the Commission approve the Brownfield Agreement between the Commission and MTB Properties, LLC regarding the remediation of brownfield property located at 206 Highway 182 East in Starkville, Mississippi. The administrative record for this environmental response project is referred to as the Humble Oil Property site. The property was previously operated as a fuel supply operation with underground storage tanks. Assessments revealed the extent of contamination in the shallow groundwater and soil at levels in excess of the Target Remediation Goals so remediation of the Brownfield Agreement Site is necessary. The proposed use of the Site after completion of all remediation will be a new restaurant and catering operation called "Humble Taco". The staff of the MCEQ evaluated the Brownfield Agreement and believes that, with the conditions and restrictions contained within the Brownfield Agreement, the Site will be in compliance with applicable State and Federal laws and standards and will be protective of the public health and the environment. Following staff presentation and after deliberation, on motion made by Mr. Phillips and seconded by Ms. Lathan, the Commission unanimously voted to approve the Brownfield Agreement between the Commission and MTB Properties, LLC regarding the remediation of brownfield property located at 206 Highway 182 East in Starkville, Mississisppi.

#### Environmental Covenant for Yazoo Valley EPA

Mr. Joseph Curro stated that pursuant to the Commission's delegation regulations (11 Miss. Admin. Code Pt. 1, R.1.1.Y.), the Executive Director of MDEQ approved the Environmental Covenant between the Commission and Yazoo Valley Electric Power Association (EPA) regarding the remediation of property located at 651 East 15<sup>th</sup> Street in Yazoo City, MS. Environmental Site Assessments revealed the site was contaminated with petroleum hydrocarbons at levels in excess of Target Remediation Goals (TRGs) so remediation of the site was necessary. The staff of the MCEQ evaluated the proposed Environmental Covenant and believes that, with the conditions and restrictions contained within; the site will be in compliance with applicable State laws and standards and will be protective of the public health and the environment. This briefing was for informational purposes only, requiring no action by the Commission.

# Water Pollution Control (Clean Water) State Revolving Fund Loan Program, Resolution of Necessity to Issue Bonds

On behalf of staff, Mr. Tony Caldwell stated that during the 2018 State legislative session, House Bill 1649 was passed and subsequently signed by the Governor. This bill provided for the issuance of \$5,000,000 in bonds to provide state matching funds required to obtain \$25,000,000 in available federal assistance to this program. The funds are loaned at low interest rates to facilitate the construction or improvement of Wastewater Treatment facilities in the state. In order to initiate this process, the Commission must adopt a Resolution of Necessity for issuance of these bonds. The Commission was previously provided with copies of the Resolution for consideration and staff recommended that the Commission adopt the Resolution of Necessity. Following staff presentation and after deliberation, on motion made by Mr. Phillips and seconded by Mr. Johnson, the Commission unanimously voted to adopt the Resolution of Necessity for issuance of the bonds necessary to obtain federal assistance available to the Water Pollution Control State Revolving Fund Loan Program.

#### Draft FY-2018 Water Pollution Control Revolving Loan Fund (WPCRLF) Program Intended Use Plan

On behalf of staff, Mr. Tony Caldwell briefed the Commission on the Draft FY-2018 Water Pollution Control Revolving Loan Fund (WPCRLF) Program Intended Use Plan. The Intended Use Plan identifies the loan funds available to our communities for the construction of wastewater infrastructure, the communities to receive these loan funds, the loan interest rate, program deadlines, and other related information. While there are 20-year loans available, this Intended Use Plan reflects the implementation of the new 30-year loan term availability. Public notice and a public hearing for the Draft Intended Use Plan will be scheduled to solicit public comments. Any comments received from the public or EPA will be addressed. Following staff presentation and after deliberation, on motion made by Ms. Lathan and seconded by Mr. Johnson, the Commission unanimously voted to conditionally adopt the Final FY-2018 WPCRLF Program Intended Use Plan, provided there are no changes or adverse comments during the public hearing.

# C.F. Gollott and Son Seafood, Inc., D'Iberville, Harrison County, Mississippi, Request for Commission Hearing

Mr. Roy Furrh, MDEQ General Counsel, made a presentation on MDEQ staff's behalf regarding a request from C.F. Gollott and Son Seafood, Inc. ("Gollott") for a Commission hearing. The Commission was previously provided handouts submitted by Gollott and MDEQ. Mr. Furrh stated that Gollott was issued an NPDES permit in 2014, allowing it to discharge process wastewater used for shrimp processing into the Back Bay of Biloxi, Mississippi. The permit was based on applicable new source performance standards ("NSPS"). When it became apparent that Gollott would not be able to comply with the permit limits, Gollott entered an Agreed Order with the Commission giving Gollott until December 2016 to demonstrate compliance with the limits. The Agreed Order was amended to allow Gollott until December 2018 to demonstrate compliance. Gollott has requested a Commission hearing in which the Commission would consider whether to stay or revoke the Agreed Order and the Amendment to the Agreed Order and whether the Commission should initiate contact with the United States Environmental Protection Agency ("EPA") regarding the NSPS which, according to Gollott, were improperly promulgated.

Mr. Furrh stated that Gollott knew that new source performance standards would be included in its permit but did not comment during the two comment periods and further did not challenge the permit after it was issued. Mr. Furrh stated that by signing the Agreed and Amended Agreed Orders, Gollott expressly waived its right to a Commission hearing. Three years after permit issuance, Gollott also petitioned the Mississippi Environmental Quality Permit Board ("Permit Board") for a permit modification. MDEQ staff is in the process of scheduling that hearing. Mr. Furrh indicated that Gollott stated several arguments to support its request for stay or revocation of the Orders. Specifically, Gollott disagreed with MDEQ's basing the permit limits on average production numbers it derived from Gollott's discharge monitoring reports. Gollott also argued that MDEQ considered a water quality model in setting the permit limits. Mr. Furrh acknowledged the model had some deficiencies, but stated the permit limits were based on the categorical limits for NSPS and not numbers derived from the model. Additionally, Gollott argued the United States Environmental Protection Agency ("EPA") did not properly adopt the NSPS and requested the Commission appeal to EPA. Mr. Furrh stated the NSPS were adopted more than 44 years ago and Gollott did not challenge such adoption at that time. Mr. Furrh also stated that Gollott did not challenge the Commission regulations adopted decades ago which incorporated the NSPS. Mr. Furrh maintained Gollott's arguments regarding permit limits should be made to the Permit Board as part of Gollott's permit modification request. He recommended the Commission deny Gollott's request for a Commission

hearing, Gollott's request for revocation or stay of the Orders, and its request that the Commission appeal to EPA regarding its promulgation of the NSPS. Mr. Furth stated that stay or revocation of the Orders would set a dangerous environmental enforcement precedent which would compromise the integrity of MDEQ's permitting and compliance and enforcement programs.

Mr. Keith Turner, legal counsel for Gollott, stated that Gollott made its hearing request pursuant to Miss. Code Ann. § 49-17-35 rather than Miss. Code Ann. § 49-17-31 which was the statute referred to in the Orders. He stated that Gollott experiences large fluctuations in production and MDEQ's use of average production numbers to derive permit limits was not consistent with the EPA's Permit Writers' Manual because actual production numbers should be used. Mr. Turner asserted the flawed WASP model played a role in the permit and because of that the permit was fundamentally flawed. Mr. Turner claimed the NSPS regulations were not properly promulgated by EPA and, therefore, are not valid. Mr. Dale Gollott stated Gollott had been in business since 1933 and that the issues before the Commission are critical to Gollott's future both financially and operationally. Mr. Gollott also stressed Gollott's environmental compliance record. Mr. Turner stated his opinion that the Commission should obtain independent legal counsel in matters such as these because MDEQ staff and legal staff are advising the Commission of their point of view.

Mr. Furrh responded that MDEQ staff has a recommendation and that the Commission makes its own decision after hearing from Gollott. Mr. Furrh stated that Miss. Code Ann. § 49-17-35 requires such investigations as the Commission deems necessary but allows the Commission discretion to determine whether it should grant a hearing. Mr. Furrh indicated the investigation includes the facts presented to the Commission.

Following Mr. Furrh's and Mr. Turner's presentations and Mr. Gollott's comments, and after deliberation, on motion made by Mr. Winstead and seconded by Mr. Phillips, the Commission unanimously voted to adopt the staff recommendation and deny Gollott's request for hearing; deny Gollott's request for a stay or revocation of the Agreed Order and Agreed Order Amendment; and deny Gollott's request for the Commission to petition EPA regarding promulgation of the NSPS regulations. There was some further discussion and Mr. Phillips stated one of the biggest concerns of the Commission was water quality issues on the Coast and that the Commission must be diligent in addressing those issues. Mr. Phillips also thanked Mr. Gollott for taking the time to come to Jackson. In order to make the record clear, the Commission, on motion made by Mr. Phillips and seconded by Ms. Lathan unanimously voted to deny Gollott's request for a stay of the Agreed Order and Agreed Order Amendment.
