Florance Bass, Manager of MDEQ's 401/Stormwater Branch, informed the Permit Board that Mississippi Export Railroad applied for coverage under the Large Construction Storm Water General NPDES Permit and a Section 401 Water Quality Certification (WQC) to conduct regulated activities in waters of the state for the construction of two railroad siding tracks to be located on the east and west sides of the existing railroad tracks located south of Carter's Road, north of Moss Point, Jackson County, Mississippi. Ms. Bass stated the proposed project will provide additional track space for marshalling, stabling, storing, and as passing loops to allow for more effective and safe management of longer train lengths and more frequent train traffic for Mississippi Export Railroad's customers. The proposed site consists of a 22-acre parcel located within the 100-foot railroad right-of-way of the existing railroad tracks. Construction of the project will disturb approximately 13.8 acres; thus, Mississippi Export Railroad applied for coverage under Mississippi's Large Construction Storm Water General Permit by submitting a Large Construction Notice of Intent (LCNOI) and an associated Storm Water Pollution Prevention Plan (SWPPP) on May 25, 2018. Ms. Bass stated that MDEQ reviewed the LCNOI and SWPPP, deemed them complete, and determined they adequately addressed storm water discharges from the project site.

Ms. Bass next stated the project will require filling 5.7 acres of jurisdictional wetlands on the site and the applicant must mitigate for the unavoidable wetland losses by purchasing credits from an approved wetland mitigation bank. The applicant also must obtain a permit pursuant to Section 404 of the Clean Water Act from the U.S. Army Corps of Engineers (Corps), a Section 401 Water Quality Certification from the Permit Board, and Coastal Zone Consistency from the Department of Marine Resources. Ms. Bass stated on April 10, 2018, MDEQ and the Corps published a Joint Public Notice provided a 30-day period for submission of public comments regarding the proposed Section 401 WQC and the Section 404 Permit. A copy of the Joint Public Notice was provided to the adjacent property

owners. Adjacent landowners submitted letters stating the following objections and concerns: project location and alternatives; drainage, flooding, and storm water management; impacts to endangered species; release of hazardous materials; and loss of visual buffers and noise buffers. The applicant responded to these concerns at the Department's request and provided additional supporting information supporting their permit and WQC applications. MDEQ provided the Permit Board copies of the objections letters, photographs of the project site, and the draft WQC with special conditions for the Board's review prior to the meeting. Permit Board member Chair James Hoffmann invited comments from opponents or proponents to the project. No one spoke either for or against issuance of the coverage or the WQC.

Staff recommended issuance of the coverage under the Large Construction Storm Water General Permit and issuance of the Section 401 Water Quality Certification. Upon motion by Dennis Riecke, and seconded by Chris McDonald, the Permit Board voted to accept the staff's recommendation to issue the Coverage and WQC.

**WASTE DIVISION /SOLID WASTE PERMITTING BRANCH
EPD- Water II Branch, Air II Branch, and 401/Stormwater Branch**

**Quad County Environmental Solutions LLC
Quad County Landfill, Marshall County**

Mr. Trent Jones of MDEQ's Waste Division advised the Permit Board that Quad County Environmental Solutions, LLC ("Quad County") applied for the following: Solid Waste Management Permit (SW0470010580), NPDES Storm Water Permit (MSS062383), Air Permit to Construct (1780-00053), Title V Air Permit (1780-00053), and Clean Water Act Section 401 Water Quality Certification (WQC2017077) to operate the proposed Quad County Landfill in Marshall County, Mississippi.

Quad County proposes to develop and construct a new commercial municipal solid waste landfill, to be known as the Quad County Landfill, on a site it currently operates as a Class I rubbish disposal facility. The proposed landfill facility would accept and dispose of nonhazardous solid wastes from commercial, industrial and institutional sources. The proposed landfill will not be permitted to accept household garbage and other similar wastes from residences or apartment complexes. The area proposed for the landfill is approximately 110 acres. The current permitted rubbish disposal area will be reduced to 16.3 acres and will be operated until it reaches design capacity. The proposed Quad County Landfill will be constructed adjacent to and partially over the rubbish disposal area after the area is closed. The landfill will be constructed with bottom and side wall liner systems which will be a composite liner system that will be constructed above a low permeability soil buffer of at least five feet. The liner system will consist of 24 inches of compacted clay, overlain by a plastic liner, constructed to federal and state permeability standards. Quad County requested a variance to reduce the required setback distance of 500 feet from the property line to 300 feet from the north side of the property line and 250 feet from the south, east, and west sides. The variance request is based on the presence and maintenance of existing natural visual screening. The draft solid waste permit includes the requested setback distances.

Based on MDEQ's review of the permit and certification applications, the design plans and drawings, the demonstrations of compliance with the siting criteria, and the supporting documents, MDEQ staff developed draft permits and a draft Section 401 water quality certification for the proposed project. MDEQ advertised a 30-day public comment period, from May 7, 2018, until June 7, 2018, and held a public hearing on June 7, 2018, to receive public comments regarding the draft permits and certification. MDEQ did not receive any public comments prior to the public hearing; however, representatives of the Three Rivers Solid Waste Management Authority and the Northeast Mississippi Solid Waste Management Authority provided comments at the public hearing and submitted documents which they requested be entered into the public record.

MDEQ provided a copy of the public hearing transcript to the Permit Board and a memorandum summarizing the public comments and MDEQ's responses to those comments to the Permit Board members prior to the Permit Board's meeting. The public comments centered around two primary issues: concerns related to the proposed service area for the proposed landfill and the need for the proposed landfill facility. Service area and need are issues within the jurisdiction of the Mississippi Commission on Environmental Quality ("Commission") and not within the Permit Board's purview. Inclusion of the proposed landfill in the Marshall County Solid Waste Management Plan, and Commission approval of same, are prerequisites to permit issuance.

The Marshall County Solid Waste Authority (“Marshall County Authority”) approved the inclusion of the proposed landfill and requested Commission approval of an amendment to include the proposed Quad County Landfill in the Marshall County Solid Waste Management Plan. Before the Commission considered the Solid Waste Plan amendment, MDEQ reviewed information and the process related to the Authority’s determination of need, service area, local zoning issues, and other local matters and ultimately recommended approval of the amendment to include the facility. MDEQ’s Executive Director, acting on behalf of the Commission, entered an Order (No. 6708 16) on November 23, 2016, approving the requested Plan amendment. The plan amendment was not challenged.

The draft solid waste management permit requires the owner to ensure that that service area for the Quad County Landfill is consistent with the service area approved in the amended Marshall County Authority Plan. Quad County Landfill’s service area overlaps the service areas of other landfills located in the region and some of the counties within the service area may be or are subject to local flow control ordinances. Flow control ordinances are local restrictions enacted by some solid waste management authorities to restrict the flow of certain solid wastes outside of the authority’s jurisdictions. Neither the Marshall County solid waste management plan nor the draft permit conditions grant any special rights to Quad County to violate any local laws or ordinances, including local flow control ordinances that are in place in any of the counties within the proposed service area.

Mr. Greg Beard, legal counsel for the Northeast Mississippi Solid Waste Management Authority (“Northeast Authority”), stated his client’s opposition to the proposed permits and certification. He stated there was no need for a new landfill and expressed concerns with the service area for the proposed Quad County Landfill and was specifically concerned that a new landfill would take waste stream away from existing landfills which are included in Northeast Authority’s solid waste management plan. Mr. Beard also complained about lack of notice regarding the amendment to the Marshall County Solid Waste Management Plan.

Mr. John Brunini, legal counsel for Quad County, stated that the Marshall County Authority complied with the regulations requiring notification to adjacent counties by notifying Benton County of the proposed plan amendment. Mr. Brunini disagreed with Mr. Beard’s comment that the Marshall County Authority did not adequately demonstrate need for the new landfill. Mr. Brunini pointed out that the only comments MDEQ received on the draft permits and certification was from the Northeast Authority which is mainly concerned with losing business to a competing landfill. Mr. Brunini echoed Mr. Jones’s statement that it was within the Commission’s purview to consider the adequacy of a county’s demonstration of need and issues regarding service area.

Mr. Jones stated that MDEQ staff concluded, under the constraints and limitations within the proposed permits, the facility can operate within all state and federal laws and regulations. Thus, staff recommended issuance of the permits.

Upon motion by Dennis Riecke and seconded by Les Herrington, the Permit Board voted to accept the staff’s recommendation to issue the permit.

OTHER BUSINESS

MDEQ’s General Counsel, Roy Furrh, welcomed to the Permit Board its newest member, Les Herrington with the Mississippi Department of Health.

Mr. Furrh informed the Permit Board that the Waste Division of MDEQ planned to present a MDEQ Solid Waste Permit Review Presentation next month toward the end of the August 14, 2018 Permit Board meeting.

Mr. Furrh reminded the Permit Board that an evidentiary hearing requested by Mr. Billy Magee and members of the community regarding Le Poultry would possibly be held at a future Permit Board meeting.

Mr. Furrh also reminded the Permit Board that another evidentiary hearing will be forthcoming regarding a request for modification of C.F. Gollot and Son Seafood, Inc.’s NPDES Permit.

CONFIRMATION OF THE NEXT REGULAR PERMIT BOARD MEETING

Chair Jim Hoffmann confirmed that the next Regular Meeting will be held on August 14, 2018.


