NOTICE OF PUBLIC HEARING

PUBLIC NOTICE START DATE: November 18, 2016

DEADLINE FOR COMMENTS: December 21, 2016

Pursuant to Miss. Code Ann. Sec. 49-17-30, the Mississippi Department of Environmental Quality will hold a public hearing to receive comments regarding the proposed Title V Permit fee for September 1, 2017 through August 31, 2018 to be established by Order of the Mississippi Commission on Environmental Quality (Commission). The public hearing will be held on Wednesday, December 21, 2016, at 1:30 p.m. in Room 104A at the Mississippi Department of Environmental Quality, 515 E. Amite St., Jackson, Mississippi.

Miss. Code Ann. Sec. 49-17-30 provides that under Title V of the Federal Clean Air Act, the owner and/or operator of any stationary source of regulated air pollutants shall pay the Department of Environmental Quality (DEQ) an annual permit fee. The Commission is charged by law to establish the permit fee in an amount sufficient to cover the cost of the Title V Permit Program. Miss. Code Ann. Sec. 49-17-16 established an Advisory Council to conduct an independent study of the cost of the Title V Permit Program.

On Thursday, November 10, 2016, the Commission received the recommendation and report of the Advisory Council. The Advisory Council recommended to the Commission that the Title V Permit fee be set at \$47.00 per ton of regulated air pollutants with a minimum fee of \$250 for September 1, 2017 through August 31, 2018. The staff of the DEQ also reported to the Commission that based upon the estimated cost of the program, the current estimate of reportable air emissions and projected fiscal year 2017 fund balance, the Title V Permit fee of \$47.00 per ton with a \$250 minimum would be adequate. The Commission authorized the staff to proceed to notice of public hearing with the fee as proposed by the Advisory Council.

To assure clarity and conciseness of the hearing record, both written and oral comments should be restricted to this matter.
