MISSISSIPPI COMMISSION ON ENVIRONMENTAL QUALITY OFFICIAL MINUTES NOVEMBER 8, 2018

The regular monthly meeting of the Commission on Environmental Quality was held on Thursday, November 8, 2018, in the Commission Hearing Room, 515 East Amite Street, Jackson, Mississippi, beginning at 9:00 a.m. Commissioners present were:

Commissioners Brenda Lathan and Billy Van Devender were not present.

Others present were: Gary Rikard, Executive Director; James Matheny, Adrien Perkins, Lynn Chambers, Roy Furrh, staff of MDEQ; and other staff members and visitors whose names appear elsewhere in these minutes.

The meeting was called to order by Chairman Winstead and after he led the invocation, the following business was transacted:

Notice of Meeting

The Commission was informed that the legal Notice of Meeting concerning the time, date, and place of this meeting had been posted publicly as required by law. The Notice of Meeting read as follows: "Please take note that the regularly scheduled meeting of the Mississippi Commission on Environmental Quality for November, 2018, will take place on Thursday, November 8, 2018. This meeting will be held in the Commission Hearing Room at the offices of the Mississippi Department of Environmental Quality at 515 East Amite Street, Jackson, Mississippi. As always, the public is invited to attend." This notice was posted in the lobby of the MDEQ offices in Jackson on October 1, 2018.

Approval of Minutes

On motion made by Mr. Phillips and seconded by Mr. Dane, the minutes of the August 23, 2018, meeting were approved and adopted as the Official Minutes.

Establishment of the Lignite Mining Fee for Liberty Fuels Company, LLC for the Liberty Mine in Kemper County for State Fiscal Year 2019;

Establishment of the Lignite Fee for the Mississippi Lignite Mining Company for the Red Hills Mine in Choctaw County for State Fiscal Year 2019

On behalf of MDEQ staff, Mr. James Matheny recommended the Liberty Fuels Company, LLC Lignite Mining Fee for the 2019 state fiscal year be set at \$125,000, which is the same as for state fiscal year 2018. Mr. Matheny also recommended that the Mississippi Lignite Mining Company Lignite Mining Fee for the 2019 state fiscal year be set at \$175,000, which is an increase of \$50,000 more than the fee for state fiscal year 2018. This fee increase is due to cover the additional costs associated with stream monitoring of Little Bywy Creek and Middle Bywy Creek. The increase is also necessary to cover the additional staff resources/costs associated with an application review related to a proposed project expansion. This amount will cover approximately 50% of the anticipated costs of administering the federally-approved coal mining program in Mississippi; the remaining approximately 50% of the cost will be covered by a federal Office of Surface Mining Reclamation and Enforcement grant. These fees will cover 100% of the anticipated cost of administering the program above the amount of the federal OSMRE grant. Staff also recommended that the Commission delegate the authority to sign the Orders to the Executive Director. Following staff presentation and deliberation, on motion made by Mr. Johnson and seconded by Mr. Dane, the Commission unanimously voted to set the Liberty Fuels Company, LLC Lignite Mining Fee for the 2019 state fiscal year at \$125,000 and set the Mississippi Lignite Mining Company Lignite Mining Fee for the 2019 state fiscal year at \$175,000. The Commission also authorized Orders setting these fees be executed by the Executive Director.

2018 Mississippi 303(d) List of Impaired Water Bodies

On behalf of MDEQ staff, Ms. Adrien Perkins provided a briefing to the Commission on the 2018 Mississippi Section 303(d) List of Impaired Water Bodies. Public notice of the draft 303(d) list began April 10th and ended May 15th with a public hearing. Two public comments were received and a responsiveness summary was prepared. EPA issued a letter of no comment on the draft list. Commission members were previously provided with a document package which included the final list, the transcript of the public hearing, the public notice and proof of publication, EPA's letter of no comment, the public comments, and the responsiveness summary. Ms. Perkins requested the Commission adopt the 2018 list and propose the list to EPA Region 4 for their final approval with an accompanying Order. Following staff presentation and deliberation, on motion made by Mr. Phillips and seconded by Mr. Johnson, the Commission unanimously voted to adopt the 2018 303(d) list and propose the list to EPA Region 4 for their final approval with an accompanying Order. In response to a question raised by Mr. Phillips, Ms. Perkins stated the oldest 303(d) list of which she is aware is from 1996. Executive Director Gary Rikard informed the Commission Ms. Perkins was relocating to the State of Washington. Mr. Rikard wished Ms. Perkins well and congratulated her on a job well done.

Commission Approval of Modified Brownfield Agreement

On behalf of MDEQ staff, Ms. Lynn Chambers stated the Commission approved Brownfield Agreement 5969 11 in May 2011, between the Commission and Delta Biofuels, Inc. for Delta Biofuels property located in Natchez, Mississippi. The original brownfield agreement required an environmental covenant to be placed on portions of the property due to Volatile Organic Compounds in the groundwater and soils at levels in excess of the Target Remediation Goals. The agreement also required long term groundwater monitoring with implementation of additional corrective action, if necessary. Upon recent review of the brownfield agreement order, it was determined further clarification of the original order is necessary to specify the boundaries of the environmental covenant. Ms. Chambers recommended that the Commission approve the modified Brownfield Agreement between the Commission and World Asset Management, the new property owner, regarding the environmental covenant for the 13.518 acres at L.E. Barry Road in Natchez, Mississippi. Staff of the MCEQ has evaluated the Brownfield Agreement and believes that, with the conditions and restrictions contained within the Brownfield Agreement, the Site will be in compliance with applicable State and Federal laws and standards and will be protective of the public health and the environment. Following staff presentation and deliberation, on motion made by Mr. Dane and seconded by Mr. Phillips, the Commission unanimously voted to approve the modified Brownfield Agreement between the Commission and World Asset Management regarding the environmental covenant for the 13.518 acres at L.E. Barry Road in Natchez, Mississippi.

Asbestos Certifications

On previous authority delegated to the Head, Office of Pollution Control, the staff reported that 180 asbestos certifications had been issued since the last report.

Emergency Clean-Up Expenses

On previous authority delegated to the Executive Director, the staff reported the Emergency Clean-Up Expenses incurred since the Commission's last meeting. A list of these expenses is made a part of these minutes and is filed in the Official Minutes File.

Lead Paint Certifications

On previous authority delegated to the Head, Office of Pollution Control, the staff reported that 114 lead paint certifications had been issued since the last report.

Underground Storage Tank (UST) Certifications

On previous authority delegated to the Head, Office of Pollution Control, the staff reported 24 that certifications to those who install, alter, or remove underground storage tanks had been issued since the last report.

Wastewater Operator Certifications

On previous authority delegated to the Head, Office of Pollution Control, the staff reported that 112 wastewater operator certificates had been issued since the last report.

Administrative Orders

On previous authority delegated to the Executive Director, DEQ, the staff reported that 22 Administrative Orders had been issued since the Commission's last meeting. A list of these orders is made a part of these minutes and is filed in the Official Minutes File.

Other Business

Mr. Roy Furrh provided the Commission with an update on the Illinois Central train derailment in Minter City, MS, in which pollutants were released on farmland owned by the Melton family. The Meltons have requested an evidentiary hearing, before the Commission, related to the corrective action plan which has been submitted by the railroad and approved by MDEQ. As part of the corrective action plan, a report needs to be submitted specifying the areas of soil and ground water which will be tested for contamination. MDEQ staff is in the process of reviewing and approving this report. The plan also includes two rounds of sampling to determine the extent of the contamination. Therefore, the evidentiary hearing will probably occur late next year so that Illinois Central can move forward with the testing and sampling process.

Executive Director, Gary Rikard advised the Commission that Alice Perry has returned to work for MDEQ part time on contract. Mr. Rikard and Ms. Perry are in the processing of scheduling meetings with legislators prior to the start of the 2019 legislative session.

Mr. Rikard also advised the Commission that Kay Whittington and he recently met with Yazoo Management District to discuss a delegation agreement for YMD to receive, investigate, and make recommendations regarding applications for MRVA agriculture and wildlife water use permits. It is the same type of delegation agreement MDEQ signs with EPA relative to federal programs. In addition, Mr. Rikard stated he was meeting with Delta Council on Monday to discuss applications for water withdrawal

permits. MDEQ wants to make sure the information in the application is accurate for modeling purposes.

Finally, Mr. Rikard informed the Commission that an ex parte order has been drafted against an automobile parts manufacturer, Parker Hannifin, in Booneville, MS. The plant closed in 2008 and garnered MDEQ's attention because they began installing monitoring wells and doing clean-up without MDEQ's knowledge. It appears Parker Hannifin has some off site contamination and they are refusing to conduct the recommended testing necessary to ensure human health and safety. Mr. Rikard stated he will probably execute this order. If the order is contested, this matter may come before the Commission at a later date.

Setting of Meeting

It was the decision of the Commission to announce the December meeting date in the near future.

Adjournment

There being no further business to come before the Commission, the meeting was adjourned.
