**Issuance of Air Pollution Control Permit to Construct Air Emission Equipment
for #0840-00022, George County**

Ms. Krystal Rudolph, Chief of the Environmental Permits Division (EPD), advised the Permit Board that Enviva Pellets Lucedale, LLC is proposing to construct a greenfield facility in Lucedale, George County, Mississippi, that will produce industrial-grade wood pellets from green wood fiber material. The facility will be designed to manufacture approximately 1.4 million oven-dried tons of wood pellets per year utilizing up to 85% softwood by weight.

The proposed draft Air Construction Permit contains numerous regulatory limitations and constraints which would reduce the emissions of particulate matter, particulate matter less than 10 microns in diameter, particulate matter less than 2.5 microns in diameter, and volatile organic compounds below the Prevention of Significant Deterioration (PSD) threshold of 250 tons per year per pollutant; therefore the facility is not subject to PSD permitting requirements and is instead subject to the permit to construct requirements found in 11 Mississippi Administrative Code Part 2, Chapter 2. The limitations and constraints for the facility would also reduce the emissions of hazardous air pollutants, but the facility would still be subject to applying case-by-case Maximum Achievable Control Technology (MACT) requirements for hazardous air pollutants. Enviva has proposed the installation and operation of air pollution control devices to reduce the emission of particulate matter, volatile organic compounds and hazardous air pollutants.

On March 14, 2019, MDEQ provided a 30-day public notice period to receive public comments. During that initial 30-day comment period, EPD received requests for the comment period to be extended and a public hearing to be held for the project. On April 11, 2019, a second notice was issued to both schedule a public hearing held on May 14, 2019, and extend the public comment period through the date of the hearing. MDEQ provided a total of 61 days for public comments.

All comments received during the comment period and hearing were thoroughly examined by MDEQ staff. MDEQ staff prepared a "Response to Comments" document and proposed changes to the draft permit to address some of the comments. MDEQ provided the Permit Board members with a copy of MDEQ's Response to Comments document, the revised draft Permit to Construct, the updated permit review summary, the transcript of the public hearing, and all comments received about the project in advance of the Permit Board meeting. Individuals who submitted oral comments of concern during the public hearing, organizations that submitted comments of concern, and key officials were notified of the Permit Board meeting.

Many visitors were present at the Permit Board meeting. Before taking up this matter, MDEQ staff attorney Roy Furrh, stated that there had been an extended comment period of 61 days for this permit and that a public hearing in Lucedale, MS had been held on May 14 to obtain comments. Mr. Furrh stated that the MDEQ staff had responded to all comments and revised the draft permit conditions. The room was filled with people and Mr. Furrh stated that considering the extended comment period and the public hearing that was held, he thought that only new comments should be accepted at this meeting but that decision was up to the MDEQ Permit Board. Mr. Riecke stated that he would like to hear comments from those present. Mr. Furrh again stated that while it was up to the permit board members, there had been plenty of opportunity for people to comment.

Chairman McDonald asked those who had new comments to raise their hand. Two people did so. Mr. Frank Figgers asked the MDEQ Permit Board not to issue the permit. He stated that the permit violated the standards of the Clean Air Act for particulate matter for nitrogen oxide. He stated that he was concerned about the bypasses of air pollution control equipment that were allowed under the permit. He stated these were a violation of the Clean Air Act. He stated that residents around the Enviva plant in Amory, MS have complained about dust and smoke Mr. Doug Lee, former Mayor of Lucedale, Mississippi stated that in his professional opinion the proposed facility is needed in George County and would be good for the community and the state of Mississippi.

Mr. Riecke asked Krystal Randolph, MDEQ's Environmental Permits Chief to respond to Mr. Figgers comments. Ms. Randolph said the company has better air pollution control technology now to install in this plant. She said that the reason for bypassing air pollution control equipment is that at start up this equipment is not ready to begin functioning fully and that bypass is only allowed about 50 times per year. Mr. Riecke asked Ms. Randolph about Enviva's environmental compliance record. She acknowledged the Amory facility has had issues with fugitive dust emissions but stated the proposed Enviva facility will be a different, more modern, type of facility than the Amory facility with more controls. Thus, while fugitive dust should not be a problem with the proposed facility, MDEQ is requiring Enviva to implement a fugitive dust management plan.

In conclusion, Ms. Rudolph stated that MDEQ reviewed the application and determined that proposed permit for the Enviva Pellets Lucedale, LLC facility has been developed with the proper constraints, and limits, such that the facility could operate within all state and federal environmental laws

and regulations; therefore, the staff recommended that the Permit Board issue the permit.

On motion by Duncan Welch and seconded by Dennis Riecke, the Permit Board voted to accept the staff's recommendation to issue the permit coverage.

Bush Construction Company requested permit P90-009 (Forrest County) be transferred to River Road Sand & Gravel. River Road Sand & Gravel provided the required bond and transfer form to MDEQ. If approved, the new permit number for Rebel Rock, LLC will be P16-028TAT. The staff recommended approval of the transfer request.

On motion by Duncan Welch and seconded by Dennis Riecke, the Permit Board voted to approve the above surface mining permit transfer.

OTHER BUSINESS

MDEQ's General Counsel, Roy Furrh, informed the Permit Board that the Hearing Officer was still reviewing dispositive motions filed in the Le Poultry matter and that he anticipates the Hearing Officer to make a recommendation regarding the parties' dispositive motions at the next Permit Board meeting on August 13, 2019.

CONFIRMATION OF THE NEXT REGULAR PERMIT BOARD MEETING

Chair Chris McDonald confirmed that the next Regular Meeting will be held on August 13, 2019.

MEETING ADJOURNED

There being no further business to come before the Permit Board, Chair Chris McDonald adjourned the meeting.
