**Issuance of Air Pollution Control Permit to Construct Air Emission
Equipment for #0600-00075, Copiah County**

Ms. Krystal Rudolph, Chief of the Environmental Permits Division (EPD), advised the Permit Board that Alternative Energy Development Copiah LLC (referred to as AED) is proposing to construct a greenfield facility in Hazlehurst, MS that will produce industrial-grade wood pellets from green wood fiber material. The facility will be designed to manufacture approximately 473,040 oven-dried tons of wood pellets per year utilizing up to 85% softwood by weight.

The proposed draft Air Construction Permit contains numerous regulatory limitations and constraints which would reduce the emissions of particulate matter, particulate matter less than 10 microns in diameter, particulate matter less than 2.5 microns in diameter, and volatile organic compounds below the Prevention of Significant Deterioration (PSD) threshold of 250 tons of year; therefore this facility is not subject to PSD permitting requirements and is instead subject to the permit to construct requirements found in 11 Mississippi Administrative Code Part 2, Chapter 2. The limitations and constraints for the facility would also reduce the emissions of hazardous air pollutants (HAPs) below the major source threshold of 25 tons per year for combined HAPs and 10 tons per year for individual HAPs.

In order to reduce the emissions of particulate matter, volatile organic compounds and hazardous

air pollutants, AED has proposed the installation and operation of air pollution control devices including a regenerative thermal oxidizer, a wet electrostatic precipitator and baghouses.

On October 9, 2019, MDEQ provided a 30-day public notice and a notice for the scheduling of a public hearing. The public comment period was extended until the day of the public hearing on November 12, 2019.

All comments received during the comment period and hearing were thoroughly examined by MDEQ staff. MDEQ staff prepared a "Response to Comments" document and proposed changes to the draft Permit to Construct, the updated permit review, the transcript of the public hearing, and provided these documents to the Permit Board for its review in advance of the Permit Board meeting. Individuals who provided oral comments of concern during the public hearing, organizations that submitted comments of concern, and key officials were notified of the Permit Board meeting.

The permit applicant was present to answer the Permit Board's questions and address the concerns of any objectors; however, there was no one present who spoke in opposition of permit issuance.

Ms. Rudolph stated that MDEQ staff believes the Air Permit to Construct for the AED Copiah LLC facility has been developed with the proper constraints, limits and requirements such that the facility could operate within all state and federal environmental laws and regulations.

On motion by Adam Choate and seconded by Dennis Riecke, the Permit Board voted to accept the staff's recommendation to issue the permit coverage.

OTHER BUSINESS

MDEQ's General Counsel, Roy Furrh, informed the Permit Board that the evidentiary hearing requested challenging the issuance of the Mississippi State Port Authority Water Quality Certification is scheduled for the Regular Permit Board Meeting on May 12, 2020. There was previous discussion that the matter may be scheduled at a Special Permit Board meeting on February 20, 2020, but the parties have subsequently agreed to the May 12, 2020, date.

Mr. Furrh also informed the visitors that were present for the proposed NCL permit matter, that the Permit Board would recess and then reconvene at 10:30 am to consider the proposed NCL permits.

Roy Furrh, General Counsel of MDEQ, informed the audience of the composition of the Permit Board; provided an overview of the NCL permitting process; and discussed that the Permit Board requested at its previous November 12th meeting to consider the proposed NCL permits as follows: The Permit Board will first hear from MDEQ staff; the Permit Board will then hear from the representatives of the applicant NCL Waste, LLC; the Permit Board will then break for lunch; after lunch, the Permit Board will then hear opinion statements from those persons who have previously signed-in at the tables outside

in the lobby; speakers are allowed 3-minute opinion statements which are monitored through a time-keeper sitting with the Permit Board; the Permit Board members may ask questions which will not count against any speaker's time; MDEQ staff will then make a final statement; and finally the Permit Board will deliberate and make its initial decision to issue, deny or modify the proposed NCL permits or it may continue its decision. The Permit Board does not have to accept MDEQ staff recommendation. The manner to request an evidentiary hearing related to the Permit Board's initial decision and any subsequent appeal process were also discussed.

Mr. Trent Jones, Manager of the Solid Waste Permitting and Certification Branch in MDEQ's Waste Division, presented to the Permit Board proposed environmental permits which would allow the siting, construction and operation of a new municipal solid waste landfill located at 2858 North County Line Road in Madison County, near the city limits of Jackson and Ridgeland and on the border of Madison and Hinds counties. Mr. Jones reminded the Permit Board that it previously denied permit applications for a proposed landfill at this same location site in July 2012 and affirmed that decision after an evidentiary hearing on the matter in November 2012. The Permit Board's action to deny the initial permit applications came after the previous applicant and the MDEQ reached an impasse on key siting components of the solid waste permit application. This impasse included several siting components such as the setback distances from the disposal area to property lines, the adequacy of visual screening, and setbacks to individual homes as it relates to noise conditions from the landfill. In the previous matter, no draft permits were presented to the Permit Board, and therefore the Board did not resolve all of the issues related to those permit applications. Mr. Jones also reminded the Board members that the Permit Board took an additional action at that time in which the Board instructed the applicant that it would consider the Solid Waste Management Permit Application with a 500-foot setback from the disposal area to all property lines for the proposed NCL Landfill Site.

Mr. Jones indicated that upon MDEQ's initial receipt of the current application in January 2017, MDEQ staff discussed the new proposed project in relation to the Board's previous decision with MDEQ Senior Management and Legal Counsel, and the determination was made that since the applicant company had changed in ownership and the content of the application was different, MDEQ would review and evaluate the new project as a different project and would make determinations based on the ability of the new project to comply with state Regulations.

Mr. Jones stated that the applications for the new proposed NCL Waste project were originally submitted to MDEQ in January 2017 and the five actions presented at this Permit Board meeting included the following: an application for a solid waste management permit for the design, construction, and operation of the proposed municipal solid waste landfill; an application for a waste water pretreatment permit to allow the discharge of leachate to a permitted waste water treatment facility; an application for a National Pollutant Discharge Elimination System (NPDES) permit for the discharge of storm water runoff; an application for a State air construction permit to allow the development of the landfill and installation of certain equipment, and an application for a water quality certification regarding potential impacts to wetlands and other waters of the state related to construction of the landfill.

Mr. Jones then summarized each of the permit applications. The primary permit for the proposed North County Line Road landfill is the proposed solid waste management permit. The applicant has proposed a total disposal area for the landfill of approximately 89 acres within the total property area of 166 acres. The solid waste management permit, if issued, would allow the proposed NCL Landfill to accept and dispose of various nonhazardous solid wastes from residential, commercial, industrial, institutional and other approved sources from an approved 13-County service area. Mr. Jones also noted that the solid waste permit application process requires that the applicant first obtain local approval for a proposed landfill through inclusion in the local solid waste management plan and through local zoning or land use ordinances. The Madison County Board of Supervisors previously considered and approved the inclusion of the landfill on several occasions and Mr. Jones provided additional details on those approvals. Mr. Jones indicated the service area approved by Madison County includes Madison, Hinds, and Rankin Counties and the contiguous counties, which include Copiah, Simpson, Attala, Claiborne, Holmes, Leake, Scott, Smith, Warren, and Yazoo Counties. He indicated the landfill had not been approved by the County to accept out of state waste for disposal.

Mr. Jones then provided detailed information related to a determination of need for the landfill required by State law. Mr. Jones stated that, based on the applicant's demonstration of need and Madison County's previous consideration of need and approval of the new landfill capacity, staff does not believe MDEQ has a basis to recommend denial of the proposed landfill based on the lack of need.

Mr. Jones then provided information on the proposed landfill's compliance with the siting criteria and construction requirements for landfills found in the Mississippi Nonhazardous Solid Waste Management Regulations. This included general information and specific discussions regarding a reduction in the property line setback distance along a significant portion of the property boundary as allowed by the Mississippi Nonhazardous Solid Waste Management Regulations and a reduction in the setback from the

proposed disposal area to the nearest occupied dwelling. Mr. Jones stated that the MDEQ has concluded that the proposed location of the disposal area complies with the state siting criteria. Mr. Jones further reminded the Board that when the Mississippi Commission on Environmental Quality approved the modification of the Madison County Solid Waste Management Plan to include the proposed NCL landfill in the Plan in 2005, the Commission requested that the Permit Board consider an increase to the setback distance between the disposal area and the adjacent property line to greater than the minimum requirement of 500 feet.

Mr. Jones then summarized the Wastewater Pretreatment, NPDES Storm Water, Air Construction and 401 Water Quality applications for permit approval. He indicated that MDEQ staff in the Environmental Permits Division had reviewed the applications for permits for the project and had made determinations that the project complies with the requirements of the air and water pollution control permits. Mr. Jones then concluded his statements about the various applications and draft permits.

Mr. Jones also discussed the public comment process on the draft permits. He stated that MDEQ had received numerous written and verbal comments expressing opposition or varying concerns about the issuance of the proposed permits. He advised the Board that MDEQ had made a preliminary determination in August that the permit applications on each of the environmental permits were complete. Consequently, MDEQ went to public notice and solicited public comments over a 67 Day comment period. MDEQ held a public informational session and public hearing on September 26, 2019. Mr. Jones stated that the Permit Board was provided copies of all public comments received during the comment period and was provided the "Response to Public Comments" document developed by MDEQ which provided a summary of and response to the public comments. Mr. Jones also stated that some of the permits and rationale documents had been modified as a result of staff review and consideration of public comments.

Representatives of the applicant were then allowed to provide opinion statements in favor of the proposed permits.

At this point in the meeting the Permit Board adjourned for lunch and reconvened at approximately 1:00 p.m.

Upon reconvening, concerned citizens that completed registration cards were given the opportunity to offer opinion statements to the Permit Board in three-minute time-frame increments. Approximately 30 persons, other than the applicant's representatives, provided opinion statements on the proposed landfill project. The majority of the opinion statements expressed opposition to the landfill based on concerns related to the lack of need for the proposed NCL landfill (given there were already two landfills in Madison County and no other Mississippi county has more than one), the planned annexation of the proposed Landfill area by the City of Ridgeland, the previous decisions by the Permit Board and the Commission regarding this site, compliance with the regulatory buffer-zone from "residential areas", environmental justice concerns about the project, the anticipated heavy presence of trucks, health risks, unbearable odors from methane gas, vehicle noises, leachate, dust in homes from the road traffic, muddy roads, trash, and cancer causing pollution. There were also several persons including members of the North County Line Road Homeowner's Association that offered opinion statements which expressed support for the project.

After the conclusion of the opinion statements, Mr. Jones provided closing remarks and indicated that MDEQ's final determination was that the applications were complete and MDEQ had no information on issues within its jurisdiction that they believe would prevent the Permit Board from issuing the environmental permits for this project. However, Mr. Jones stated that MDEQ also recognized the significance of the public comments received and the previous recommendation and determinations made by the Commission and Permit Board and had attempted to provide information on these matters to the Permit Board for consideration. Mr. Jones further stated that MDEQ recognized that the Permit Board in its ultimate decision, based on all of the information received, has the discretion to issue the proposed permits or to modify or deny the proposed permits should the Permit Board determine that any of the aspects of the project are insufficient to protect the environment and human health or are not in compliance with State laws or regulations.

Upon considering the previous comments, the presentations from MDEQ staff, the applicant and the public statements, Jess New moved for the Permit Board to go into executive session, Chris Hawkins seconded. Roy Furrh, MDEQ's General Counsel, advised the Board it would first have to vote to go into closed session before determining whether to go into executive session. Jess New retracted his original motion and moved to go into closed session to discuss whether to go into executive session. Chris Hawkins seconded the motion and the Permit Board voted to go into closed session. Upon return from the closed session, Chris Hawkins moved to end the closed session and Adam Choate seconded and the Permit Board voted to end the closed session. Chris Hawkins then made the motion to go back into open session and Les Herrington seconded and the Permit Board voted to return to open session. Mr. Furrh informed attendees at the Permit Board meeting that the Permit Board had decided not to go into executive session.

Thereafter, Dennis Riecke made the motion to continue the decision of the Permit Board on the proposed NCL permits based on comments received by the Permit Board members concerning the geology of the site and Adam Choate seconded. With a show of hands, four Permit Board members voted in favor of the motion with two opposing the motion. Chris Hawkins abstained. David Dockery provided clarification on the comments related to geologic concerns for the site received by the Permit Board. Mr. Dockery indicated that the concerns regarding certain geologic formations were not relevant to the project site.

Consequently, on motion by Chris Hawkins, seconded by David Dockery, the Permit Board voted to reverse and rescind its decision to continue the matter. Jess New indicated he needed clarification on some issues and requested the Permit Board be allowed to submit questions and receive answers from MDEQ staff prior to making a decision and moved again to continue the decision of the Permit Board, which was seconded by Adam Choate, and the Permit Board voted to continue its decision related to the proposed NCL permits. The Permit Board will again consider the matter at its next regular Permit Board meeting.

Mr. Furrh informed everyone that the Permit Board would not be accepting additional opinion statements at the next Permit Board meeting to be held on Tuesday, January 14, 2020, when the proposed NCL permits will be considered.
