L-1		The Office of Pollution Control must concur with engineered plans and specifications for the installation or modification of the wastewater treatment facility and sewer collection system prior to the commencement of construction. After the completion of construction, but before the commencement of wastewater disposal by either discharge or land application, the permittee must, through a letter signed by a professional engineer, certify to the Office of Pollution Control that the project has been constructed in accordance with submitted plans and specifications. If any changes to the initially reviewed plans and specifications are made, "as-built" drawings with a list of all changes must also be submitted for the Office of Pollution Control's concurrence.
