MISSISSIPPI COMMISSION ON ENVIRONMENTAL QUALITY OFFICIAL MINUTES MAY 27, 2021

The regular monthly meeting of the Commission on Environmental Quality was held via Zoom on Thursday, May 27, 2021, and initiated from Conference Room 604-B at the offices of the Mississippi Department of Environmental Quality, 515 East Amite Street, Jackson, Mississippi, beginning at 9:00 a.m.

Commissioners who participated telephonically were: John Dane III, Patrick Johnson, Brenda Lathan, Jamie Martin, Chat Phillips, Billy Van Devender and Jack Winstead.

Others present were: Chris Wells, Executive Director; Trent Jones, Lynn Chambers, Roy Furrh, staff of MDEQ; and other staff members and visitors whose names appear elsewhere in these minutes.

The meeting was called to order by Chairman Dane and after Mr. Phillips led the invocation, the following business was transacted:

#### Notice of Meeting

#### Approval of Minutes

On motion made by Mr. Johnson and seconded by Ms. Martin, the minutes of the April 22, 2021, telephonic meeting were approved and adopted as the Official Minutes.

Request from the Northeast Mississippi Solid Waste Management Authority for a Variance to State Siting Criteria for the Proposed Expansion Area at the Authority's Municipal Solid Waste Landfill

On behalf of MDEQ staff, Mr. Trent Jones stated the Northeast Mississippi Solid Waste Management Authority (Authority) would be requesting a variance to one of the siting criteria for municipal solid waste landfills found in the Commission's Mississippi Nonhazardous Solid Waste Management Regulations, for a proposed expansion to the permitted disposal area of the existing Northeast Mississippi Regional Landfill, owned by the Authority. Due to limited disposal capacity, the Authority made preliminary plans to expand the permitted disposal area of their existing landfill and submitted a permit application to MDEQ. Upon review of the regulatory siting criteria, MDEQ staff determined that the proposed location of the expansion area did not meet the natural geology siting criteria found in the regulations regarding the presence of naturally occurring clay buffer material directly beneath the entire disposal area. Mr. Jones provided the Commission with some brief historical information regarding the Authority's permit history. The Mississippi Nonhazardous Solid Waste Management Regulations (11 Miss. Admin. Code Pt. 4 Ch. 1.), in part states that "New landfills shall be located where there are adequate naturally occurring geological materials present of low permeability to act as a buffer between the base of the landfill liner and the top of the uppermost aquifer. Such materials shall generally consist of clays, silty clays, clayey silts, or other soils which have an average hydraulic conductivity of 1 x 10-6 cm/sec or less. The thickness, or depth, of these materials shall extend to at least five feet immediately beneath the base of the landfill liner." The Authority's permit application proposes to supplement the areas of the expansion that would not meet the natural geology criteria by constructing a comparable clay buffer. Because the solid waste regulations do not provide for MDEQ staff or the Mississippi Environmental Quality Permit Board to grant a variance to the naturally occurring geology siting requirements, MDEQ staff believed the path forward for the Authority was to petition the Commission for a siting criteria variance. Mr. Jones further stated that the granting of a variance would not guarantee the issuance of a permit and that the ultimate decision for the issuance of a permit granting approval of a new disposal area would be rendered by the Mississippi Environmental Quality Permit Board. The Authority would still be required to go through the permitting process, which would include a public participation process. Greg Beard, Attorney and Chairman for the Authority, David Green with Waste Services of Northeast Mississippi (operator), and Jeff Breedlove with Promus Engineering all participated in the presentation of the variance request to the Commission, providing details of the proposed expansion plan and other relative information regarding their request. A couple of general questions were asked by the Commission and answered by the Authority and MDEQ. Following the presentations and after deliberation, Chairman Dane stated he was in favor of granting the Northeast Mississippi Solid Waste Management Authority's request for a variance and called the Commission to a vote. All Commissioners voted to grant the Authority's request for a variance, except for Jamie Martin who voted in opposition to this request. With the majority of the Commission voting in favor of granting Northeast Mississippi Solid Waste Management Authority's request for a variance, the matter before the Commission passed.

### Commission Approval of Brownfield Agreement - Delmar Plaza Holdings, LLC

On behalf of staff, Ms. Lynn Chambers recommended that the Commission approve the Brownfield Agreement between the Commission and Delmar Plaza Holdings, LLC regarding the remediation of the brownfield property located at 12057 Highway 49 North in Gulfport, Mississippi. The administrative record for this environmental response project is referred to as the Exclusive Cleaners site. The Exclusive Cleaners, which is located within the Delmar Plaza Shopping Center, released dry cleaning solvents which resulted in soil and groundwater contamination at this location. Delmar Plaza Holdings, LLC has agreed that the proposed remediation measures will be through the biological enhanced reductive dechlorination (ERD) and in-situ chemical reduction (ISCR) pathways, filing a land use restriction with the property deed, and entering

into a Brownfield Agreement. The Brownfield Agreement Site will be subject to an environmental covenant restricting the future site use, including all impacted media. The draft Brownfield Agreement completed the 30-day public comment period which ended on May 10, 2021, and no comments were received. MDEQ staff evaluated the proposed Brownfield Agreement and believes that, with the conditions and restrictions contained within the proposed Brownfield Agreement, the site will be in compliance with all applicable State and Federal laws and standards and will be protective of the public health and the environment once the Brownfield Agreement is completed. Following staff presentation and after deliberation, on motion made by Mr. Phillips and seconded by Ms. Lathan, the Commission unanimously voted to approve the Brownfield Agreement between the Commission and Delmar Plaza Holdings, LLC regarding the remediation of brownfield property located at 12057 Highway 49 North in Gulfport, Mississisppi.

## Restrictive Use Agreed Order and Environmental Covenant for FC Meyer Packaging, LLC

(For Reporting Purposes Only)

Pursuant to the Commission's delegation regulations (11 Miss. Admin. Code Pt. 1, R.1.1.Y.), the Executive Director of MDEQ approved the Restrictive Use Agreed Order and Environmental Covenants between the Commission and FC Meyer Packaging, LLC regarding the remediation of property located at 101 Ascher Street, Quitman, Clarke County, Mississippi. FC Meyer Packaging, LLC operated the site as a cardboard packaging manufacturing facility. Environmental Site Assessments revealed the presence of Trichloroethene impacting groundwater at concentrations in excess of Target Remediation Goals (TRGs). Therefore, remediation of the site is necessary. Staff of MDEQ evaluated the proposed Restrictive Use Agreed Order and Environmental Covenant and believes that, with the conditions and restrictions contained within; the site will be in compliance with applicable State laws and standards and will be protective of public health and the environment. This briefing was for informational purposes only, requiring no action by the Commission.

#### **Asbestos Certifications**

On previous authority delegated to the Head, Office of Pollution Control, the staff reported that 84 asbestos certifications had been issued since the last report.

#### **Emergency Clean-Up Expenses**

On previous authority delegated to the MDEQ Executive Director, the staff reported the Emergency Clean-Up Expenses incurred since the Commission's last meeting. A list of these expenses is made a part of these minutes and is filed in the Official Minutes File.

### **Lead Paint Certifications**

On previous authority delegated to the Head, Office of Pollution Control, the staff reported that 60 lead paint certifications had been issued since the last report.

## Wastewater Operator Certifications

On previous authority delegated to the Head, Office of Pollution Control, the staff reported that 11 wastewater operator certificates had been issued since the last report.

## Administrative Orders

On previous authority delegated to the MDEQ Executive Director, the staff reported that 11 Administrative Orders and 3 Amended Orders have been issued since the Commission's meeting on April 22, 2021. A list of these orders is made a part of these minutes and is filed in the Official Minutes File.

#### Other Business

Executive Director Chris Wells stated that during the 2020 legislative session, legislators passed a bill creating the Mississippi High Hazard Dam Rehabilitation Grant Program. Staff has developed regulations for this program and is currently completing the public notice and hearing requirements. The regulations will be brought before the Commission for approval at the June Commission meeting.
