

**MINUTES OF THE MISSISSIPPI ENVIRONMENTAL QUALITY PERMIT BOARD

The Mississippi Environmental Quality Permit Board held a meeting in the Commission Hearing Room of the Department of Environmental Quality, located at 515 East Amite Street, on June 8, 2021. Mark Williams, Chief of the Waste Division at the Mississippi Department of Environmental Quality, presented for consideration the proposed denial of the applicable permits and certification related to the NCL Waste LLC, North County Line Landfill in Madison County. The applicable permits had been previously considered by the Permit Board on December 10, 2019.

Mr. Williams reminded the Permit Board that staff brought for its consideration at the December 10, 2019, Permit Board meeting the matter involving environmental permit applications from NCL Waste, LLC for a new municipal solid waste landfill project to be located on North County Line Road in Madison County, Mississippi, and that the draft permits that were presented to the Board at the time for the landfill including a proposed solid waste management permit, a proposed Air Construction permit, a proposed NPDES Storm Water permit, a proposed wastewater pretreatment permit and a proposed 401 Water Quality Certification. After considering the matter, the Board voted to continue its consideration of the draft permits until the January 14, 2020, meeting. At the January meeting, the Board voted not to consider issuance of the environmental permits for the proposed landfill project any further until the applicant had provided an updated needs assessment for the proposed landfill from the Madison County Board of Supervisors, because the previous needs assessment for the project was over 15 years old.

Mr. Williams informed the Permit Board that neither the applicant nor the Madison County Board of Supervisors had provided an updated needs assessment to MDEQ for this proposed landfill; therefore, MDEQ staff had not resubmitted the matter to the Permit Board. However, Mr. Williams stated that the Mississippi Legislature changed the state law that would impact the status of the NCL landfill project. Mr. Williams explained that the recent changes to state law compelled MDEQ to bring this matter back before the Permit Board.

The Mississippi Legislature adopted House Bill 949 during its 2021 Regular Session, and the Governor signed the bill into law. The new law, which includes new requirements for local solid waste plans, will have a significant impact on the proposed landfill project. MDEQ provided copies of House Bill 949 to the Permit Board members prior to the Permit Board meeting. The law specifically modifies Sections 17-17-227 and 17-17-229 of the Mississippi Code, which govern the adoption of local nonhazardous solid waste management plans and permit application requirements for municipal solid waste landfills. The bill also codifies a new section of law, Section 17-17-237, which contains related new provisions for these laws.

Mr. Williams read the following new language from the amended Sections 17-17-227 and 17-17-229:

*Notwithstanding any provision of this chapter, no solid waste management plan shall include a proposed new municipal solid waste landfill in any county that has two (2) or more existing permitted municipal solid waste landfills and such new landfill will be located within a five (5) mile radius of an existing municipal solid waste landfill, unless a referendum election has been conducted and approved pursuant to Section 17-17-237.*

Mr. Williams informed the Permit Board that these amendments do not apply to proposed expansions or replacements of any permitted landfill by the permit holder or to other types of solid waste management facilities. Thus, only municipal solid waste landfills are affected by the new legislation. Mr. Williams explained that municipal solid waste landfills are the landfill types that accept the state's household garbage and similar wastes, like the proposed NCL Landfill. Mr. Williams read the following excerpt of the language in the newly codified Section 17-17-237:

*No new municipal solid waste landfill shall be incorporated into any solid waste management plan and no reference in any existing plan to any unpermitted new municipal solid waste landfill shall be effective, applicable or operative and no permit, grant or loan shall be approved for any new municipal solid waste landfill in any county that has two (2) or more existing permitted municipal solid waste landfills and such new landfill will be located within a five (5) mile radius of an existing municipal solid waste landfill, unless a local referendum election has been called and held in the county in which the new municipal solid waste landfill is proposed and with the results hereinafter provided.*

This subsection clarifies that the provisions of the statutory changes apply to any existing plan that references an unpermitted landfill. The new Section 17-17-237 then describes the conditions for the local referendum process whereby the public may vote to approve inclusion of a landfill in the local plan.

Mr. Williams concluded that MDEQ staff believes this new law directly impacts the existing Madison County Solid Waste Management Plan and the proposed NCL Landfill project. He explained that the proposed NCL Landfill is located in Madison County which already has two permitted municipal solid waste landfills and is proposed to be located within five miles of one of those existing landfills; therefore, the new and amended statutes apply to the proposed new landfill. Additionally, Section 17-17-237 provides "no reference in any existing plan to any unpermitted new municipal solid waste landfill shall be effective, applicable or operative . . . ." Thus, while the proposed NCL Landfill was previously recognized and included in the Madison County Solid Waste Management Plan and permit applications were submitted by NCL, the proposed landfill's inclusion in the local plan is no longer effective or applicable, unless a public referendum is conducted, affirmatively approving the inclusion of the landfill in the local plan.

Furthermore, Mr. Williams indicated Section 17-17-229 already specifies that "after approval of a local solid waste plan by the commission, neither the department, the permit board nor any other agency of the State of Mississippi shall issue any permit, grant or loan for any nonhazardous solid waste management facility in a county, municipality region, or district which is not consistent with the approved local nonhazardous solid waste management plan."

Mr. Williams reiterated that Section 17-17-237 effectively renders the proposed NCL Landfill inconsistent with the Madison County plan; therefore, in accordance with Section 17-17-229, the Permit Board cannot issue any environmental permits to NCL Waste, LLC. Based on these changes to Mississippi Law, MDEQ staff recommended that the Permit Board deny NCL's proposed environmental permits and certification including the applications for the solid waste management permit, the air construction permit, the NPDES Storm water permit, the wastewater pre-treatment permit, and the 401 water quality certification.

NCL representatives submitted a letter to the Permit Board members the day before the Permit Board meeting indicating that they may wish to address the Board with their request that the Board not deny the permits and to provide the applicant an opportunity to comply with the new state law. However, MDEQ staff later heard from the applicant that they decided not to participate in the meeting. Chair Wittmann asked if anyone was present to address the Permit Board in person or telephonically from NCL Waste, LLC and there was no audible response. Mr. Williams responded to a question from Mr. Mann that the City of Ridgeland has now annexed the area that includes the site of the proposed NCL landfill, has withdrawn from the Madison County Solid Waste Plan, and is working on developing its own long-range solid waste plan. Therefore, the applicant will now need approval from the City of Ridgeland if it wishes to be included in the City's solid waste plan.

Mr. Williams stated if the City then affirms the inclusion of the proposed landfill, the City would then need to petition the Madison County Board of Supervisors to conduct a public referendum on the matter. If the public approves including NCL in the local plan, then NCL would be able to resubmit its permit applications to the Department.

Mr. Doug Mann made the motion to deny the applicable permits and certification based on a matter of law. Mr. Les Herrington seconded the motion and the Permit Board voted to deny the applicable permits and certification related to the NCL Waste LLC, North County Line Landfill in Madison County.

### **Other Business**

MDEQ's General Counsel, Roy Furrh, recommended opening the floor to elect new Permit Board Officers for fiscal year 2022 beginning July 1, 2021. Mr. Furrh stated Les Herrington with the Department of Health, who was present at the meeting, is the current Vice Chair of the Permit Board; he stated the Board could nominate Mr. Herrington or any other Permit Board as the new Chair.

Chair Jennifer Wittmann then opened the floor for Chair nominations. Doug Mann nominated Les Herrington for Chair. With no other Chair nominations, the Permit Board, on motion by Doug Mann and seconded by David Dockery, voted to elect Les Herrington as Chair effective July 1, 2021.

Mr. Furrh then explained the Permit Board officers traditionally and historically rotated the position of Vice Chair, and the Oil and Gas Board was next in line for the Vice Chair position. Mr. Furrh reported that David Snodgrass, who was present at the meeting, stated he would be willing to serve as Vice Chair if elected; however, Mr. Furrh noted the Permit Board could nominate anyone else on the Permit Board other than Chair-Elect Herrington.

Chair Jennifer Wittmann then opened the floor for Vice Chair nominations. Les Herrington moved to nominate David Snodgrass as Vice Chair which was seconded by Doug Mann, and the Permit Board voted to close the nominations and to elect David Snodgrass as Vice Chair effective July 1, 2021.

Following the election of the Permit Board officers, Mr. Furrh announced that there would be more in person meetings of the Permit Board since COVID-19 vaccinations had made a significant difference in lowering the number of positive cases and he would let the Permit Board members know in advance before each meeting if the meeting would be held in person or telephonically.

### **CONFIRMATION OF THE NEXT REGULAR PERMIT BOARD MEETING**

Chair Jennifer Wittmann confirmed that the next Regular Meeting will be held on July 13, 2021.

**MEETING ADJOURNED**

There being no further business to come before the Permit Board, Chair Jennifer Wittmann adjourned the meeting.
