

**MINUTES OF THE MISSISSIPPI ENVIRONMENTAL QUALITY PERMIT BOARD
HELD IN JACKSON, MISSISSIPPI, ON TUESDAY, JULY 13, 2021**

The Mississippi Environmental Quality Permit Board held a meeting in the Commission Hearing Room of the Department of Environmental Quality, located at 515 East Amite Street, on July 13, 2021. COVID-19 protocols were implemented at the in-person meeting related to mandatory social distancing and face mask requirements for those who are unvaccinated. Limited seating was available at the meeting in order to comply with social distancing requirements. Proposed Findings of Fact and Conclusions of Law

MDEQ Senior Attorney Lisa Ouzts presented proposed Findings of Fact and Conclusions of Law (FOFCOL) for consideration regarding the Permit Board's decision, after an evidentiary hearing held on April 13, 2021, to revoke Gold Coast Commodities, Inc.'s (Gold Coast) State Operating Permit. Hearing Officer Doug Levanway presided over the matter.

Ms. Ouzts stated that MDEQ provided the draft to Gold Coast's attorney, Andy Taggart, for comment. Ms. Ouzts stated that she incorporated many of Mr. Taggart's comments. Mr. Taggart stated that Gold Coast objected to the references to its unpermitted discharges into the sewer systems of the Cities of Brandon, Pelahatchie, and Jackson. He stated Gold Coast also objected to Section B of the Conclusions of Law (paragraphs 82–84) regarding misrepresentations. Ms. Ouzts stated she provided the Permit Board with MDEQ's proposed draft FOFCOL which incorporated many of Gold Coast's comments and the draft which contained all of Gold Coast's comments. Ms. Ouzts advised the Permit Board that it could adopt MDEQ's proposed draft, Gold Coast's proposed draft, or include its own additional edits.

Doug Mann moved to enter closed session to determine whether to proceed in executive session. Chris McDonald seconded the motion and the Permit Board voted to enter closed session.

Mr. Mann then moved to enter executive session to discuss a matter involving pending litigation. Jennifer Wittman seconded the motion and the Board voted to enter executive session.

Mr. Mann then moved to end executive session and to return to open session. Chris Hawkins seconded the motion and the Permit Board voted to end executive session and return to open session.

Ms. Wittman moved to adopt and approve the proposed FOFCOL except for paragraphs 83 and 84 and incorporating minor edits suggested by Hearing Officer Levanway. Permit Board Member Chris McDonald seconded the motion and the Permit Board voted in favor of the motion.

Mr. Chris McDonald moved to authorize Vice Chair David Snodgrass to sign the FOFCOL on behalf of the Permit Board after MDEQ staff made the modifications and edits. Ms. Wittmann seconded the motion and the Permit Board voted in favor of the motion.




