

**MINUTES OF THE MISSISSIPPI ENVIRONMENTAL QUALITY PERMIT BOARD  
HELD IN JACKSON, MISSISSIPPI, ON TUESDAY, SEPTEMBER 14, 2021**

The Mississippi Environmental Quality Permit Board held a meeting in the Commission Hearing Room of the Department of Environmental Quality, located at 515 East Amite Street, on September 14, 2021. COVID-19 protocols were implemented at the in-person meeting related to mandatory social distancing and face mask requirements for those who are unvaccinated and were strongly encouraged for all attendees. Limited seating was available at the meeting in order to comply with social distancing requirements. **Issuance of NPDES Permit No. MS0062596**

Bradley Crain, Manager of MDEQ's Environmental Permits Division's Municipal Branch, advised the Permit Board that Sean Vidrine, an owner of Paradise Ranch RV Resort (Paradise Ranch), Walthall County, Mississippi, applied for a permit to discharge wastewater in accordance with the National Pollutant Discharge Elimination System (NPDES) on August 21, 2020. Paradise Ranch currently consists of about 100 RV spots and cabins, and Paradise Ranch wishes to expand to 536 units which requires additional wastewater treatment. The existing wastewater treatment system is regulated by the Mississippi State Department of Health. Paradise Ranch proposed to install a new mechanical-activated sludge treatment system, followed by chlorination for disinfection which, if

approved, would be regulated by MDEQ. The proposed wastewater system is designed for a maximum of 70,500 gallons per day of treated wastewater that would be discharged into an unnamed tributary of the Bogue Chitto River. The proposed Paradise Ranch treatment facility will be located at 660 Mississippi 48 West in Tylertown, Walthall County, Mississippi. A public notice was initiated for the proposed permit on November 16, 2020. The draft permit initially required quarterly testing and annual reporting.

During the public comment period, MDEQ received numerous comments of concern. Based on the comments concerning the Bogue Chitto River, MDEQ Staff revised the draft permit to require monthly monitoring and reporting. MDEQ initiated a second public notice on April 1, 2021, in which it announced that MDEQ would hold a virtual public hearing on May 4, 2021. After the virtual public hearing, MDEQ inspected Paradise Ranch to investigate claims of a raw sewage discharge into the Bogue Chitto on June 15, 2021. The inspection confirmed a raw sewage discharge into the Bogue Chitto River. The applicant resolved the violation by entering an Agreed Order on September 10, 2021, in which it agreed to prevent further discharge by capping the discharge, to pump and haul the waste to the City of McComb, and to pay a penalty. .

MDEQ staff thoroughly examined all comments received during both comment periods and during the public hearing and prepared a "Response to Comments" document addressing the comments. MDEQ provided the Permit Board with a copy of the written comments, the public hearing transcript, the permit application, the antidegradation report, the sewer plan (buffer zone), the MDEQ Stream report, the draft NPDES permit, the permit rationale, MDEQ's Agreed Order, and MDEQ's "Response to Comments" document prior to the Permit Board meeting.

Present at the Permit Board meeting were Mr. Sean Virdrine, an owner of Paradise Ranch, and Mr. Todd Cormier with Hoot Systems who explained the development and how the proposed wastewater treatment system would fully comply with the proposed permit. Both were present to answer any questions and concerns from the Permit Board members as well. Mr. Virdrine briefly described the proposed expansion of the site and stated that he planned to hire a third-party Class II operator to operate the proposed system. He stated that the operator would be responsible for the monthly reporting required in the permit. Mr. Cormier described the proposed treatment system. He stated that the actual discharge would be less than one-third of the 75,000 gallons per day cited in the permit. Mr. Cormier stated the system would be located outside of the 100-year floodplain. Mr. Andrew Whitehurst, representative of Healthy Gulf, was among the opponents who expressed numerous concerns regarding the proposed permit. Before the Permit Board meeting, Mr. Whitehurst, on behalf of Healthy Gulf and Friends of the Bogue Chitto, sent a petition with 509 names of persons opposing the permit to five state agencies and to the Governor's office. Among his concerns were the protection of recreational activities in the Bogue Chitto and compliance history of similar permitted systems in the state. Other opponents expressed their concerns with increasing sediment in the Bogue Chitto River, potential odors from the proposed system, flooding, and increased commercial development in the area. State Representative Bill Pigott of District 99 in Pike County stated he was comfortable with the proposed wastewater treatment system and supported issuance of the permit. Mr. Ken Craft, a member of the Walthall County Board of Supervisors District 2, agreed with Representative Pigott and felt the proposed project would be good for Walthall County. In response to a question by the Permit Board, Mr. Crain stated that the permit limits will protect the tributary, which is classified as fish and wildlife, and the discharge will meet the water quality standards before reaching the Bogue Chitto River.

Following the comments, Doug Mann moved for the Permit Board members to close the open session to discuss whether to enter into an executive session to discuss a matter related to potential litigation. Chris McDonald seconded the motion and the Permit Board members voted to approve the motion and enter in closed session. While in closed session, Doug Mann moved to go into executive session to discuss a matter related to potential litigation, Chris McDonald seconded the motion, and the Permit Board voted to approve the motion and enter into executive session. Chris McDonald moved to end executive session, David Dockery seconded the motion, and the Permit Board voted to approve the motion. Doug Mann moved to return to open session, Jennifer Wittmann seconded the motion, and the Permit Board voted to approve the motion and enter into open session.

After returning to open session, and after Permit Board deliberation, upon motion by Chris Hawkins and seconded by David Snodgrass, the Permit Board voted to accept staff's recommendation to issue the NPDES permit No. MS0062596 to Paradise Ranch, LLC with the additional permit condition that Paradise Ranch, LLC hire a third party Class II certified operator to operate the new wastewater system. Permit Board member Doug Mann voted present. Roy Furrh informed the parties opposed to the proposed permit that they have 30 days to request an evidentiary hearing.




