# MISSISSIPPI COMMISSION ON ENVIRONMENTAL QUALITY NOTICE OF PROPOSED RULEMAKING NOTICE OF PUBLIC HEARING

PUBLIC NOTICE START DATE: December 1, 2021 DEADLINE FOR COMMENTS: January 4, 2022

PLEASE TAKE NOTE that the Mississippi Commission on Environmental Quality (Commission) is considering proposed amendments to state air pollution control regulations. The proposed regulation amendments will be applicable statewide.

## I. Substance of the Proposed Actions.

The proposed amendments to the State of Mississippi's "Air Emissions Operating Permit Regulations for the Purposes of Title V of the Federal Clean Air Act," 11 Miss. Admin. Code Pt. 2, Ch. 6, incorporate changes necessary to implement a modified fee system for the Title V program. Under the Clean Air Act, states are required to develop a source funded fee system that adequately funds the Title V program. Mississippi law requires the fee system to collect sufficient funds through an equitable fee system. A review of the current system, established in 1993, indicates it is no longer equitable and, because it is solely based on varying source emissions, often results in inconsistent funding. Therefore, these amendments are necessary to modernize and add stability to the fee system to ensure continued and long-term compliance with state and federal law. While retaining the emissions-based portion of the fee calculation, the proposed changes incorporate a maintenance fee based on a source's number of applicable air regulations. The addition of the maintenance fee addresses the additional resources required for more complex sources, while adding resiliency to the program by no longer solely relying on emissionsbased funding. Other changes include removal of the 4,000 ton per pollutant maximum, establishing an appropriate minimum fee each year after an annual evaluation, removal of outdated information, and other editorial changes for improved clarity.
