

MISSISSIPPI COMMISSION ON ENVIRONMENTAL QUALITY
OFFICIAL MINUTES
FEBRUARY 24, 2022

The regular monthly meeting of the Commission on Environmental Quality was held on Thursday, February 24, 2022, in-person in the Commission Hearing Room at the offices of the Mississippi Department of Environmental Quality, 515 East Amite Street, Jackson, Mississippi, beginning at 9:00 a.m.

Commissioners present were: John Dane III, Patrick Johnson, Jr., Brenda Lathan, Chat Phillips and Jack Winstead.

Commissioners Jamie Martin and Billy Van Devender were not present.

Others present were: Chris Wells, Executive Director; Melissa Fortenberry, Shawn Clark, Roy Furrh, staff of MDEQ; and other staff members and visitors whose names appear elsewhere in these minutes.

The meeting was called to order by Chairman Lathan and after Mr. Winstead led the invocation, the following business was transacted:

Approval of Minutes

On motion made by Mr. Dane and seconded by Mr. Phillips, the minutes of the August 26, 2021, telephonic meeting were approved and adopted as the Official Minutes.

FY 2023 Title V Fee Recommendation - Approval to Proceed to Public Notice of Hearing

Ms. Melissa Fortenberry stated a copy of the draft report containing the Title V Advisory Council's Title V fee recommendation for the upcoming fee year in FY 2023 was previously provided to the Commission. On behalf of MDEQ staff, Ms. Fortenberry requested approval to hold a public hearing to receive comments regarding the proposed Title V fee at \$46/ton, which is the current fee, and to proceed with public notice of the hearing. After the public participation process is completed, staff will bring the fee recommendation back before the Commission for final action. Following staff presentation and after deliberation, on motion made by Mr. Winstead and seconded by Mr. Johnson, the Commission unanimously voted to proceed to public notice for a hearing on the Title V fee recommendation of \$46/ton.

Amendments to 11 Miss. Admin. Code, Part 2, Chapter 6, or "Title V Fee System"

On behalf of MDEQ staff, Ms. Melissa Fortenberry recommended that the Commission adopt amendments to 11 Mississippi Administrative Code, Part 2, Chapter 6, "Air Emissions Operating Permit Regulations for Purposes of Title V of the Federal Clean Air Act." It is the duty of the Title V Advisory Council to recommend changes to the regulations when necessary. The proposed amendments specifically involve revisions to Rule 6.6 to modify the Title V Fee System that was established in 1993. These modifications were necessary to ensure the Title V Program is adequately and equitably funded, as required by state and federal laws and regulations, and will add stability to the fee system. The amendments also remove outdated information, make editorial changes for improved clarity, and include a future effective date of September 1, 2022, to allow the appropriate transition from one fee system to the next. Once the proposed amendments to the regulations were drafted, the Title V Advisory Council created a work group of the regulated community who would be impacted by the changes. The feedback from the work group was positive and no changes were recommended. The work group did, however, recommend that staff conduct outreach events to educate the regulated community on the proposed changes prior to official proposal. Staff participated in such outreach events last fall and a public hearing was held on January 4, 2022, following a 30-day public comment period. Two similar comments were received. A copy of the public hearing transcript, comments received, and staff's response to those comments were previously provided to the Commission. There was some discussion between Executive Director Chris Wells, Commissioner Phillips and Ms. Fortenberry about fees and emissions and how part of the success of the Title V program has been a reduction in said emissions. Following staff presentation and after deliberation, on motion made by Mr. Dane and seconded by Mr. Winstead, the Commission unanimously voted to adopt the regulations as recommended by the Title V Advisory Council and MDEQ staff.

2022 Mississippi 303(d) List of Impaired Water Bodies

Mr. Shawn Clark stated that Section 303(d) of the Clean Water Act requires MDEQ to publish the State's 303(d) list of impaired water bodies which identifies those waters within our jurisdiction that do not meet one or more water quality standards. Public notice of the draft 2022 Mississippi Section 303(d) List of Impaired Water Bodies list began January 10, 2022 and ended February 10, 2022. A public hearing was held on February 10, 2022. Public comments were received, and a responsiveness summary was prepared. EPA issued a letter of no comment on the draft list. Mr. Clark pointed out a couple of items in the report to the Commission, including that the total number of impaired water bodies is down from two years ago. Commission members were previously provided with a document package which included the final list, the transcript of the public hearing, the public notice and proof of publication, EPA's letter of no comment, the public comments, and the responsiveness summary. On behalf of MDEQ staff, Mr. Clark requested the Commission adopt the 2022 list and propose the list to EPA Region 4 for their final approval with an accompanying Order. Following staff presentation and after deliberation, on motion made by Mr. Phillips and seconded by Mr. Dane, the Commission unanimously voted to adopt the 2022 303(d) List of Impaired Water Bodies and propose the list to EPA Region 4 for their final approval along with an accompanying Order.

Asbestos Certifications

Other Business

Executive Director Chris Wells informed the Commission that the Mississippi State Legislature is currently trying to determine how to distribute and manage federal funding under the American Rescue Plan Act (ARPA), but that it does appear likely that MDEQ will be managing a wastewater infrastructure grant program. He also mentioned that there is some interest in the legislature for Board and Commission meetings to be livestreamed in the future. MDEQ's budget was briefly discussed, and Mr. Wells advised the Commission on the State Personnel Board's initiative (SEC2) to reduce job classifications and realign salaries across state government. Mr. Wells informed Ms. Lathan that the Governor's staff had been reminded that her current term is set to expire in June 2022. Finally, Mr. Wells informed the Commission that he met with EPA Regional Administrator for Region 4, Daniel Blackman, while he was in town yesterday.

Setting of Meeting

The Commission decided to meet next on March 24, 2022, beginning at 9:00 a.m.

Adjournment

There being no further business to come before the Commission, on motion made by Mr. Phillips and seconded by Mr. Winstead, the meeting was adjourned.
