BACKGROUND

2858 NORTH COUNTY LINE
ROAD IN MADISON COUNTY
WAS ENLISTED AS THE
PROPOSED DEVELOPMENT OF
A NEW MUNICIPAL SOLID
WASTE LANDFILL.

Located near both Jackson and Ridgeland city limits, the site sits between the existing Little Dixie Municipal Landfill and DDB Construction, LLC/Madison South Rubbish Landfill, Inc. It borders Hinds and Madison Counties, and the area surrounding the proposed site is zoned residential and industrial.

The MDEQ Permit Board considered the site in July 2012. It was denied due to the applicant's request for a 250-foot setback instead of the 500-foot setback, which would have provided the best benefit to residents in close proximity and visual screenings' adequacy. In January 2017, under new ownership, NCL Waste,LLC, North County Line Landfill submitted permits to MDEQ to develop a new municipal solid waste landfill. Due to new ownership and content differences, the permits were evaluated as a new and different project and the company's ability to comply with the state regulations.

The permits went to public notice on August 22, 2019. MDEQ's then Executive Director, Gary Rikard, extended the public notice until October 28, 2019. Over the 67 day comment period, the agency received numerous written and verbal comments opposing the permits' issuance.

On December 10, 2019, the Permit Board tabled the decision until January 14, 2020, to allow MDEQ staff an opportunity to respond to the board's additional questions. The staff provided written answers before the 14th. On January 14, 2020, the Permit Board moved not to take action on the permit applications until Madison County provided an updated needs assessment.


After years of debate that included annexation considerations and potential lawsuits, Mississippi lawmakers passed H.B. 949 in March 2021. The new legislation requires any waste plan to be approved through a ballot referendum. Days after the bill received legislative approval, Governor Tate Reeves sign it into law at Ridgeland's City Hall.
