

MISSISSIPPI COMMISSION ON ENVIRONMENTAL QUALITY
OFFICIAL MINUTES
JULY 28, 2022

The regular monthly meeting of the Commission on Environmental Quality was held on Thursday, July 28, 2022, in-person in the Commission Hearing Room at the offices of the Mississippi Department of Environmental Quality, 515 East Amite Street, Jackson, Mississippi, beginning at 9:00 a.m.

Commissioners present were: John Dane, III, Patrick Johnson, Jr., Brenda Lathan, Jamie Martin, Chat Phillips, and Jack Winstead.

Commissioner Billy Van Devender was not present.

Others present were: Chris Wells, Executive Director; Thomas Wallace, Roy Furrh, staff of MDEQ; and other staff members and visitors whose names appear elsewhere in these minutes.

The meeting was called to order by Chairman Lathan and after Mr. Winstead led the invocation, the following business was transacted:

Approval of Minutes

On motion made by Mr. Phillips and seconded by Mr. Johnson, the minutes of the May 26, 2022, meeting were approved and adopted as the Official Minutes.

Commission Approval of Brownfield Agreement Completion

Mr. Thomas Wallace stated that on August 27, 2020, the Commission reached a Brownfield Agreement (#7064-20) with Castle Starkville, LLC, for remediation of the former Garan Manufacturing property located at 601 Highway 12 Starkville, Oktibbeha County, MS. On June 30, 2021, the Commission approved Agreed Order #7133-21, amending Brownfield Agreement #7064-20, and effectively transferred responsibility of the Brownfield Agreement to Triangle Crossings, LLC. Corrective Actions at the site included abatement of asbestos containing materials and executing an Environmental Covenant due to contamination from an adjacent property. The reuse of the property is a retail center. In accordance with 11 Miss. Admin. Code Pt. 3, R.2.1.7.B: Final Regulations Governing Brownfield Voluntary Cleanup and Redevelopment in Mississippi, Triangle Crossings, LLC, requested the Commission make a determination as to the completion of the Brownfield Agreement and to issue a "no further action" letter by the Executive Director. Staff evaluated the corrective action report, conducted the required inspection of the site, and received confirmation that the Environmental Covenant had been filed of record. Staff recommended that the Commission issue an Order in accordance with the Brownfield Regulations concluding that Triangle Crossings, LLC, completed Brownfield Agreement #7064-20. The Environmental Covenant shall remain in effect until the site achieves unrestricted remediation goals and a subsequent determination is proposed and approved by the Commission. Following staff presentation and after deliberation, on motion made by Mr. Dane and seconded by Ms. Martin, the Commission unanimously voted to issue an Order in accordance with the Brownfield Regulations concluding that Triangle Crossings, LLC, completed Brownfield Agreement #7064-20, and that a "no further action" letter be issued by the Executive Director.

Commission Approval of Brownfield Agreement Termination

Mr. Thomas Wallace stated that on February 28, 2014, the Commission reached a Brownfield Agreement (#6394-14) with Cooley Center, LLC, and Mississippi State University for the remediation of the former Cooley Building, The Mill at Mississippi State University in Starkville, Oktibbeha County, MS. Corrective Actions at the site included abatement of asbestos containing materials and lead based paint and removal of an Underground Storage Tank. An Environmental Covenant was not required at this site. The reuse of the property is a conference center, technology hub, and a hotel. In accordance with 11 Miss. Admin. Code Pt. 3, R.2.1.7.B: Final Regulations Governing Brownfield Voluntary Cleanup and Redevelopment in Mississippi, the Cooley Center, LLC sent a petition to the Commission to make a determination as to the completion and termination of the Brownfield Agreement and to issue a "no further action" letter by the Executive Director. Staff reviewed the corrective action report and conducted the required inspection of the Brownfield Agreement Site. Staff recommended that the Commission issue an order in accordance with the Brownfield Regulations concluding that Cooley Center, LLC, and Mississippi State University completed Brownfield Agreement #6394-14. Following staff presentation and after deliberation, on motion made by Ms. Martin and seconded by Mr. Dane, the Commission unanimously voted to issue an Order in accordance with the Brownfield Regulations concluding that Cooley Center, LLC, and Mississippi State University completed Brownfield Agreement #6394-14, and that a "no further action" letter be issued by the Executive Director.

Executive Director, Chris Wells, congratulated Thomas Wallace on being named Chief of the Groundwater Assessment and Remediation Division at MDEQ.

Election of Officers for Fiscal Year 2023 (July 2022 – June 2023)

On a motion made by Mr. Winstead and seconded by Mr. Dane, the Commission voted to re-elect Brenda Lathan to serve as Chairman and Patrick Johnson to serve as Vice-Chairman of the Commission for Fiscal Year 2023. No other nominations were made.

Asbestos Certifications

On previous authority delegated to the Head, Office of Pollution Control, the staff reported that 297 asbestos certifications had been issued since the last report.

Lead Paint Certifications

On previous authority delegated to the Head, Office of Pollution Control, the staff reported that 91 lead paint certifications had been issued since the last report.

Underground Storage Tank (UST) Certifications

On previous authority delegated to the Head, Office of Pollution Control, the staff reported that 11 certifications to those who install, alter, or remove underground storage tanks had been issued since the last report.

Wastewater Operator Certifications

On previous authority delegated to the Head, Office of Pollution Control, the staff reported that 41 wastewater operator certificates had been issued since the last report.

Emergency Clean-Up Expenses

On previous authority delegated to the MDEQ Executive Director, the staff reported the Emergency Clean-Up Expenses incurred since the Commission's last meeting. A list of these expenses is made a part of these minutes and is filed in the Official Minutes File.

Administrative Orders

On previous authority delegated to the MDEQ Executive Director, the staff reported that 13 Administrative Orders and 2 Amended Orders have been issued since the Commission's meeting on May 26, 2022. A list of these orders is made a part of these minutes and is filed in the Official Minutes File.

Other Business

Executive Director, Chris Wells, informed the Commission that MDEQ's website went live on July 1, 2022, with information on the Mississippi Municipality & County Water Infrastructure Grant Program. Information included the approved regulations, scoring criteria and ranking system, and a list of questions which will later become the grant application. It is anticipated that the on-line portal will open this fall for application submissions. Later this morning, MDEQ will host the first in a series of webinars for interested parties to gather information about the grant program, and an informational meeting is scheduled for August.

Setting of Meeting

The Commission decided to meet next on August 25, 2022, beginning at 9:00 a.m.

Adjournment

There being no further business to come before the Commission, the meeting was adjourned.
