Reissuance of Title V Air Operating Permit (No. 1280-00118)**

Carla Brown, MDEQ's Air Emissions Inventory and Attainment Planning Branch Manager, presented the proposed reissuance of the Title V Permit (No. 1280-00118) to Operate Air Emissions Equipment to Halter Marine and Offshore, Inc., which is located at 601 Bayou Casotte Parkway in Pascagoula. Ms. Brown stated that operations at Halter Marine and Offshore generally consist of surface coating, welding, and abrasive blasting related to repair of offshore drilling rigs and marine vessels. These activities cause emissions of volatile organic compounds, hazardous air pollutants, and particulate matter thus necessitating a Title V air operating permit.

Ms. Brown stated that the Title V permit proposed for reissuance imposes additional requirements including a Site-Specific Dust Control Plan, use of control devices when using the Plate Line or Paint Building, and use of high-volume, low-pressure spray guns, or equivalent, to minimize paint overspray. The proposed permit continues to limit emissions of volatile organic compounds to below the Prevention of Significant Deterioration threshold and addresses hazardous air pollutants regulated by EPA's National Emission Standards for Hazardous Air Pollutants from Surface Coating of Miscellaneous Metal Parts and Products. The proposed permit also includes EPA's National Emission Standards for Hazardous Air Pollutants from

Shipbuilding and Ship Repair surface coating operations should Halter Marine repair a “ship” as defined in these regulations.

Ms. Brown stated that OPC and MDEQ’s Office of Community Engagement mailed more than 200 flyers to the nearby Cherokee community and to city and county government officials. MDEQ posted the permit and other relevant documents to its public-facing website. On March 9, 2022, a 30-day period to submit public comments regarding the proposed permit commenced. On March 28, 2022, Jennifer Crosslin, on behalf of the Cherokee Concerned Citizens, requested a public hearing to allow additional time to review the draft permit and submit comments. Rather than scheduling a public hearing, MDEQ extended the public comment period to April 22, 2022. Only one person, Ms. Barbara Weckesser, submitted comments during this extended comment period. MDEQ did not hold a public hearing because MDEQ had already addressed Ms. Crosslin’s and Ms. Weckesser’s comments in the draft permit and supporting documentation including a Response to Comments document. On May 20, 2022, MDEQ submitted the proposed permit and the Response to Comments to EPA Region 4 for EPA’s 45-day review period. MDEQ amended its Response to Comments document after being informed that Ms. Crosslin had emailed comments that MDEQ had not received. MDEQ submitted the revised Response to Comments document to EPA, thus restarting the 45-day review period. EPA did not have any comments regarding the proposed permit. The Permit Board were provided with the comments, response document and the draft permit for review in advance of the meeting.

Ms. Crosslin was present at the Permit Board meeting and addressed the Permit Board with her concerns. She expressed concerns that the “system” that regulates facilities like Halter Marine is “unjust and immoral.” She stated that fence-line communities like the neighborhood she represents are at risk of higher rates of cancer and other health issues. She acknowledged that state agencies do not have adequate resources to fully monitor emissions and must rely on industry to self-report.

Permit Board member Ms. Wittmann asked Ms. Brown to comment on the status of MDEQ’s application to EPA for a grant to install an air monitor in the Cherokee community. Melissa Fortenberry, Chief of MDEQ’s Air Division stated that MDEQ applied for a \$500,000 grant from EPA to monitor for approximately 60 pollutants including PM<sub>10</sub>, methane, volatile organic compounds, and hazardous air pollutants. Ms. Fortenberry stated that EPA had not yet indicated whether it would award the grant.

Ms. Brown stated that MDEQ developed the proposed permit with proper constraints, limits, and requirements such that the facility could operate within all state and federal environmental laws and regulations; thus, Ms. Brown recommended issuance of the permit as proposed.

On motion by Doug Mann and second by Les Herrington, the Permit Board approved the MDEQ staff recommendation and reissued Title V Air Operating Permit No. 128-00118 to Halter Marine and Offshore, Inc.

General Counsel Roy Furrh indicated an interested party aggrieved by the Permit Board’s decision has 30 days to request a formal evidentiary hearing.

## **OTHER BUSINESS**

### **Executive Session**

After a brief discussion, Mr. Mann moved to close the meeting to discuss whether to go into executive session to discuss pending and potential litigation regarding a Title VI of the Civil Rights Act of 1964 claim pertaining to the City of Jackson and Mr. McDonald seconded the motion. The Permit Board voted unanimously to close the meeting. The Permit Board, on motion by Mr. Mann and seconded by Les Herrington, voted unanimously to go into executive session to discuss the matter. After discussion, Mr. Mann moved to end executive session and return to open session and Mr. Herrington seconded the motion. The Permit Board unanimously voted in favor of the motion. Upon returning to open session, Chair Snodgrass announced that the Permit Board took no action in executive session.

### **Announcements**

Mr. Furrh notified the Permit Board that the Chancery Court of Harrison County affirmed the Permit Board's decision to issue a water quality certification to the Mississippi State Port Authority. He further announced Dr. Dockery was absent due to attending a national Geologists' meeting.


