**BFI Waste Systems of Mississippi, LLC, Big River Landfill
Washington County, Mississippi
Reissuance without Modification of Solid Waste Management Permit**

Trent Jones, MDEQ's Chief of the Waste Division, presented the proposed reissuance without modification and continued operation of the existing Big River Landfill owned and operated by BFI Waste Systems of Mississippi, LLC (a subsidiary of Republic Services, Inc.), Solid Waste Management Permit No. SW07601B0386 located at 52 Landfill Road in Leland, MS in Washington County.

Mr. Jones stated that no significant modifications to the landfill operations or approved landfill design are proposed with the application. The currently approved landfill disposal area consists of approximately 148 acres and the remaining landfill disposal capacity is approximately 19 million cubic yards (2021). The landfill would continue to accept and dispose of various nonhazardous solid wastes from residential, commercial, industrial, institutional, and other approved sources within the approved service area recognized in the Washington County Solid Waste Management Plan. The landfill area will continue to be constructed and developed in a manner consistent with the Mississippi Nonhazardous Solid Waste Management Regulations. The draft permit also includes standard requirements for conducting construction quality assurance assessments, inspections and monitoring of incoming waste loads, daily compaction of the wastes, the application of a daily cover over the wastes, the routine collection of litter and windblown wastes from the working area, and various other requirements to properly manage the landfill operations. The facility will be also required to maintain the existing groundwater and methane monitoring systems and conduct routine monitoring of these parameters.

Mr. Jones stated that a 30-day public comment period was advertised from September 14, 2022, through October 18, 2022, and an online public hearing was held on October 18, 2022. No public comments were received during the online public hearing or during the public comment period. Mr. Jones indicated that under the constraints and limitations within the proposed permit, MDEQ staff believes that the Big River Landfill can operate within all state and federal laws and regulations; thus, Mr. Jones recommended the reissuance without modification of Solid Waste Management Permit No. SW07601B0386 to BFI Waste Systems of Mississippi, LLC for the continued operation of the Big River Landfill.

On motion by Doug Mann and second by Chris McDonald the Permit Board approved the MDEQ staff recommendation presented by Trent Jones to reissue without modification Solid Waste Management Permit No. SW07601B0386 to BFI Waste Systems of Mississippi, LLC-Big River Landfill-Washington County.

OTHER BUSINESS

Roy Furrh, MDEQ General Counsel, informed the Permit Board that the Chancery Court of Harrison County's decision to affirm the Permit Board's issuance of the water quality certification to the Mississippi State Port Authority in Gulfport has been appealed to the Mississippi Supreme Court.


