Roy Furrh, General Counsel of MDEQ, requested that the Permit Board members execute the annual EPA certification form and electronically submit their annual statement of economic interest (for 2022) with the Mississippi Ethics Commission. The due date for submittal of the statement of economic interest is May 1, 2023.

CONFIRMATION OF THE NEXT REGULAR PERMIT BOARD MEETING


Chair David Snodgrass confirmed the next Regular Meeting will be held on Tuesday, February 14, 2023.
