Carrie Barefoot, MDEQ Office of Pollution Control, Environmental Permits Division, Director of the 401 Stormwater Branch, presented the Huber Engineered Woods, LLC permits. The Permit Board was previously provided with public comment and permit information for its review for the proposed water quality certification (WQC2023009) and coverage under the large construction stormwater general permit (MSR108987). Following Ms. Barefoot’s presentation, Vice-Chair Doug Mann asked if anyone else at the meeting wanted to address the Permit Board and no one responded. Following Ms. Barefoot’s staff recommendation to issue the water quality certification and stormwater coverage, on motion by David Snodgrass and second by Chris McDonald, the Permit Board voted to approve staff recommendation and issue the Section 401 water quality certification (WQC2023009) to Huber Engineered Woods, LLC. Subsequently, on motion by Chris McDonald and second by Les Herrington, the Permit Board voted to approve staff recommendation and issue coverage under the stormwater large construction permit (MSR108987) to Huber Engineered Woods, LLC.

OTHER BUSINESS

Vice-Chair Doug Mann announced there would be a short recess so the parties involved in the following evidentiary hearing could set up.

Roy Furrh, MDEQ General Counsel, MDEQ, indicated Kristen Love, Esq. with the Attorney General's Office, would serve as the Hearing Officer.

EVIDENTIARY HEARING

Issuance of State of Mississippi Surface Mining Permit No. P23-004 to mine 57 acres, located in Section 15, Township 17 North, Range 2 East, Carroll County Mississippi, and Mining Stormwater NPDES General Permit Coverage No. MSR322989, both issued to APAC Mississippi, Inc. by the Permit Board on March 14, 2023

The matter before the Permit Board was the issuance of Surface Mining Permit No. P23-004 and Mining Stormwater NPDES General Permit Coverage No. MSR322989, to APAC Mississippi, Inc., Carroll County, Mississippi. The Permit Board initially approved this permitting decision at its regular meeting on March 14, 2023. Ms. C. J. Holiday submitted a written request for a formal evidentiary hearing, objecting to the Permit Board's issuance of the permit and coverage to APAC Mississippi, Inc. (APAC).

The hearing officer in this matter was Kristen Love, Special Assistant Attorney General with the Office of the Attorney General. General Counsel Roy Furrh and Senior Attorney Ted Lampton represented the Mississippi Department of Environmental Quality (MDEQ). Attorneys Betty Ruth Fox and Abram Orlansky represented APAC. Ms. Holiday appeared pro-se. MDEQ submitted pre-filed direct testimony through the affidavits of James L. Matheny and Carrie Barefoot. Members of the Permit Board who were present during the hearing included Permit Board Member Snodgrass, Permit Board Member McDonald, Permit Board Member Mann, Permit Board Member Wittmann, Permit Board Member Herrington, and Permit Board Member Hawkins. Chair Dockery was not present and did not participate in the hearing. Vice Chair Mann served as Acting Chair.

As a preliminary matter, on behalf of MDEQ, Mr. Furrh presented a Motion to Strike pre-filed testimony that was filed by Ms. Holiday on July 31, 2023, on grounds that it was over a month after the deadline for pre-filed rebuttal testimony, and on additional grounds that the filing challenged ownership of the proposed mine site and the ownership of that property has previously been decided by the Chancery Court of Carroll County as well as the Mississippi Court of Appeals; and so her proposed testimony contradicting this prior decision was precluded by res judicata.

Ms. Fox, on behalf of APAC, also moved to strike Ms. Holiday's pre-filed testimony on grounds that Ms. Holiday had been granted two extensions of the time deadlines, but the testimony was still filed late, and on grounds that the pre-filed testimony contested ownership of the proposed mine site which had been previously decided by court decisions in the Carroll County Chancery Court, the Mississippi Court of Appeals, and the Mississippi Supreme Court declined to take up further appeal (denied the writ of certiorari (cert)).

Ms. Holiday responded that she had been in the hospital, had four surgeries, and has been very ill, and that this was the reason the pre-filed testimony was not filed timely. Ms. Holiday also responded that during the previous trial regarding ownership of the land where the mine is proposed, the Judge would not allow her to present evidence which she believed would have proven that she and her relatives were the rightful owners of the proposed mine site; and she wished to present that evidence in her pre-filed testimony.

Mr. Furrh stated that the Permit Board's rules for evidentiary hearings establish deadlines for pre-filed testimony through the scheduling letter and amended scheduling letters, and Ms.

Holiday's testimony was late. Mr. Furrh added that Mr. Matheny, on behalf of MDEQ, had travelled to the Courthouse in Carroll County to obtain documentation on land ownership in the area of the proposed mine site and these records confirmed that J.J. Ferguson Sand and Gravel, Inc. is the current owner of the land where the mine site is proposed and APAC has a lease from J.J. Ferguson Sand and Gravel, Inc.

Mr. Orlansky stated that the Permit Board's rules on evidentiary hearings requires that a request for late document submittal be provided in writing showing good cause for such late submittal, and that Ms. Holiday had not met this requirement. He also stated that Ms. Holiday's late submittal, which contested ownership of the land, sought relief that the Permit Board could not provide, since the Permit Board does not have authority to determine real property ownership. Mr. Orlansky added that the previous court decisions awarded approximately 14 acres of property to Ms. Holiday and her family, and that 14 acres is adjacent to the proposed mine site and is not a part of the proposed mine site.

Ms. Holiday responded that the previous decision in the matter by the Court was incorrect and therefore she should be able to present her additional evidence related to land ownership in this matter. Mr. Furrh stated that the decision on land ownership has been made by a higher court and is not for the Permit Board to decide. Mr. Furrh added that there was no written request for the late submittal by Ms. Holiday, so no justification was provided as required by the rules.

Permit Board Member Wittmann stated that MDEQ staff obtained documents demonstrating APAC's right to mine the property, and she does not believe the Permit Board has the authority to make decisions that are contrary to decisions that have already been made by the court system.

At Hearing Officer Love's suggestion, Permit Board Member Herrington moved that the Permit Board go into closed session to consider whether to go into executive session for the purpose of deliberating on the motions to strike. Mr. Snodgrass seconded the motion and the motion carried. At Hearing Officer Love's suggestion, Mr. McDonald moved that the Permit Board go into executive session for said purpose at that particular time. Mr. Snodgrass seconded the motion and upon a vote by the Permit Board on the motion, it carried, and the Permit Board left the room for an executive session.

After the Permit Board voted to come out of executive session and return to open session, Hearing Officer Love stated that the Permit Board had voted in executive session that the motions to strike were granted in part and denied in part. The motions were granted to the extent that Ms. Holiday would not be allowed to re-litigate the prior court decisions or attempt to persuade the Permit Board that she and/or her family own the land that constitutes the proposed mine site; and denied to the extent that Ms. Holiday will be allowed to use her pre-filed documents to challenge whether or not APAC has a right to mine the property by way of its lease with J.J. Ferguson Sand and Gravel, Inc.

Mr. Orlansky requested clarification regarding the decision to accept the late filed documents without a written justification from Ms. Holiday, and clarification regarding the distinction between challenging the land ownership and challenging the right to mine. Hearing Officer Love responded that Ms. Holiday had submitted her pre-filed testimony by email, and that her email was correspondence that satisfied the requirement for a written request; and Hearing Officer Love stated that the pre-filed testimony in question could be used by Ms. Holiday to challenge whether or not APAC has a right to mine the property by way of their lease with J.J. Ferguson Sand and Gravel, Inc., but her pre-filed testimony could not be used to prove that she (Ms. Holiday) owned the mine site.

Thereafter, Mr. Furrh provided an opening statement on behalf of MDEQ.

Ms. Fox provided an opening statement on behalf of APAC.

Ms. Holiday (pro-se) provided an opening statement.

MDEQ presented its case first. Carrie Barefoot testified for MDEQ through her pre-filed direct testimony supporting the Permit Board's prior decision to issue the Mining Stormwater

NPDES General Permit Coverage No. MSR 322989 to APAC. Mr. Furrh, on behalf of MDEQ, questioned Ms. Barefoot on direct, and tendered Ms. Barefoot for cross-examination by APAC and Ms. Holiday. Mr. Orlansky, representing APAC, cross-examined Ms. Barefoot. Ms. Holiday cross examined Ms. Barefoot. The Permit Board had no questions for Ms. Barefoot.

James L. Matheny testified for MDEQ through his pre-filed direct testimony supporting the Permit Board's prior decision to issue Surface Mining Permit No. P23-004 to APAC. Mr. Furrh, on behalf of MDEQ, questioned Mr. Matheny on direct, and then tendered Mr. Matheny for cross-examination by APAC and Ms. Holiday. Ms. Fox, representing APAC, cross-examined Mr. Matheny. Ms. Holiday cross-examined Mr. Matheny. Through cross examination by Ms. Holiday, Mr. Matheny testified there was an error in the description of the drafted Surface Mining Permit. Permit Board Member Herrington asked Mr. Matheny if a correction was needed to the legal description on the permit. Mr. Matheny stated there was an inadvertent error in the legal description of the property on the permit and that it should say the Southwest quarter of Section 15. Permit Board Member Wittmann asked if it was just a typo on the final permit. Mr. Matheny stated that the correct information was included in the public notice and in documents presented to the Permit Board for their initial approval, and that it was just a typo when the permit document was being drafted. Mr. Furrh redirected Mr. Matheny, asking questions to clarify the correct legal description that should appear on the permit issued by the Permit Board. Mr. Matheny stated that the legal description should include the Southwest Quarter of Section 15, and not mention any of the other quarters of that section, as the entire mine site is located in the Southwest Quarter of Section 15. Ms. Fox recross-examined Mr. Matheny. Ms. Holiday recross-examined Mr. Matheny. Mr. Furrh further redirected Mr. Matheny. Mr. Snodgrass asked Mr. Matheny if all of the proposed mine site is located within the Southwest quarter of Section 15. Mr. Matheny responded that all of the property is within the Southwest quarter of Section 15.

Ms. Fox stated that APAC had no witnesses to present but reserved the right to cross-examine any witnesses that may testify for another party.

Ms. Holiday proceeded with her testimony. Ms. Holiday claimed she had new evidence that Mr. Steen (ultimately J.J. Ferguson Sand and Gravel, Inc.) fraudulently obtained her family's property which he held a mining lease on since 1964 and the correct sections for the APAC surface mining permit should be sections 21 and 22 rather than 15. Mr. Orlansky, Mr. Furrh and Ms. Fox objected on grounds she continued to re-litigate the land ownership issue that had been previously decided. On motion by Permit Board Member McDonald, seconded by Permit Board Member Snodgrass, the Board voted to go into closed session to consider whether to go into executive session to discuss whether to allow Ms. Holiday to present testimony that was not pre-filed before the hearing. On motion by Mr. McDonald and second by Mr. Snodgrass, the Permit Board voted to go into executive session to determine whether to allow Ms. Holiday's testimony. After the Permit Board came out of executive session and returned to open session, Acting Chair Mann stated that the Permit Board had voted to not allow Ms. Holiday to present testimony and other evidence because the testimony that she wished to present related to ownership issues that have already been decided by the courts of the state; and the Permit Board does not have the authority to second guess the courts that decided the land ownership issues.

Subsequently, Mr. Furrh provided a closing statement on behalf of MDEQ.

Mr. Orlansky provided a closing statement on behalf of APAC.

Ms. Holiday (pro-se) provided a closing statement.

Hearing Officer Love closed the hearing so the Permit Board could go into executive session to deliberate a decision. Mr. Herrington moved that the Permit Board go into closed session. Ms. Wittmann seconded the motion and the Permit Board voted to go into closed session to consider whether to go into executive session. On motion by David Snodgrass, and second by Chris McDonald, the Permit Board voted to go into executive session at that time to deliberate. Thereafter, Hearing Officer Love announced that the Permit Board had ended its executive session, returned to open session and stated that Acting Chair Mann would deliver the decision of the Permit Board.

Acting Chair Mann stated that Permit Board affirmed its prior decision to issue Surface Mining Permit No. P23-004 and Mining Stormwater NPDES General Permit Coverage No. MSR322989, to APAC Mississippi, Inc., Carroll County, Mississippi, with the condition that the staff of the MDEQ prepare corrected permits consistent with the evidence presented that the area to be mined is in the Southwest Quarter of Section 15, Township 17 North, Range 2 East, in Carroll County Mississippi.

The next scheduled meeting of the Permit Board was confirmed for 9 a.m. on Tuesday, September 12, 2023.

On motion by Chris McDonald, and second by David Snodgrass, the Permit Board voted to adjourn the meeting.
