Carrie Barefoot, MDEQ, Office of Pollution Control, Environmental Permits Division, 401/Stormwater Branch Chief, presented the matter on behalf of MDEQ staff. Ms. Barefoot indicated the applications from South Cherry Tree Development, LLC were submitted for the construction of a combination of a residential/commercial development to be known as Delta Landing Subdivision. The proposed project is on a 251-acre parcel located in Hernando, DeSoto County. In preparation for the meeting, MDEQ staff provided the Permit Board members with a draft of the water quality certification rationale addressing the decision factors for a water quality certification; a draft of the water quality certification; the post construction stormwater management plan; copies of the large construction notice of intent; the stormwater pollution prevention plan; and the public comments received. The public comments included concerns about the amount of impervious surface and local stormwater requirements; phased construction greater than 50 acres as required by the general permit; a receiving stream being on the Clean Water Act Section 303(d) list; sediment basin calculations; streams onsite and flood zones; and cumulative impacts from projects in the area. Ms. Barefoot indicated MDEQ staff reviewed the public comments and the applicant's response and felt the concerns have been adequately addressed. Ms. Barefoot mentioned that she was amending the water quality certification rationale to add an incident of noncompliance and include a notice of violation issued to the applicant in 2021 related to the failure to implement a stormwater pollution prevention plan and failure to maintain erosion and sediment controls related to the Cherry Tree Park South Subdivision. The applicant addressed those concerns and MDEQ required no further action.

Gary Rikard, attorney for South Cherry Tree Development, LLC, spoke in support of the project.

Vice-Chair Doug Mann asked if anyone else would like to address the Permit Board and there was no response from the audience.

Subsequently, Ms. Barefoot recommended that the Permit Board issue the 401 Water Quality Certification and issue coverage under the Large Construction Storm Water General Permit to South Cherry Tree Development, LLC in two separate actions.

On motion by David Snodgrass and second by Les Herrington, the Permit Board voted to issue 401 Water Quality Certification No. WQC2023046 to South Cherry Tree Development, LLC.

Thereafter, on motion by Les Herrington and second by David Snodgrass, the Permit Board voted to issue coverage MSR108904 under the Large Construction Storm Water General Permit to South Cherry Tree Development, LLC.

## **Waste Division and Environmental Permits Division**

### **Solid Waste Permitting Branch and 401/Stormwater Branch**

#### **Faircloth Rubbish Landfill, Inc. - Faircloth Rubbish Landfill (Class I Rubbish Site) Hinds County**

#### **Reissuance with Modification Solid Waste Management Permit No. SW0250020548**

#### **Issuance of NPDES Industrial Storm Water Permit Coverage No. MSR003427**

Trent Jones, MDEQ, Office of Pollution Control, Waste Division Director, presented the matter on behalf of MDEQ Staff. Mr. Jones indicated the permit actions for consideration related to the proposed expansion and continued operation of the existing Faircloth Rubbish Landfill owned by Faircloth Rubbish Landfill, Inc. ("Faircloth"). Mr. Jones mentioned the Permit Board members were previously provided with a summary memo; the public and community notices; the draft solid waste permit and rationale; stormwater package; copies of the written public comments and the transcript from the public hearing; and a MDEQ response to comments document. Faircloth has submitted a solid waste permit application for the renewal and modification of the existing Class I Rubbish site (SW0250020548). The proposed modification would expand the existing disposal area to the east and increase the available Class I rubbish disposal area by 26.55 acres. The new total disposal area for the rubbish site would be 52.65 acres. Mr. Jones indicated the Faircloth application does not include any requests for variance to the regulatory siting criteria for class I rubbish sites. Prior to submittal of the solid waste permit application, the Hinds County Board of Supervisors also considered the proposed Faircloth expansion. Mr. Jones mentioned Hinds County issued a conditional use permit related to its local land use and zoning ordinances and also approved an amendment to its local solid waste management plan that recognized the proposed Faircloth expansion. The Mississippi Commission on Environmental Quality also ultimately approved the modification of the Hinds County Solid Waste Management Plan as requested by the Hinds County Board of Supervisors. Mr. Jones indicated Faircloth has also submitted a National Pollutant Discharge Elimination system ("NPDES") Industrial permit application for stormwater management. The proposed storm water coverage would authorize the expansion of the class I rubbish disposal area and allow the continued operation of the existing class I rubbish site. The stormwater application includes a site-specific Storm Water Pollution Prevention Plan ("SWPPP") as developed by the applicant that includes controls to retain sediment on-site and to minimize the discharge of

pollutants off-site. Mr. Jones referenced a 30-day public comment period from July 4 to August 3, 2023, and a public hearing held on August 3, 2023. The Permit Board members were previously provided copies of all public comments received during the 30-day comment period and public hearing and a MDEQ Response to Public Comments document to summarize and respond to the public comments. The SWPPP was modified by Faircloth after the public participation process and subsequent discussions with MDEQ in an effort to address some of the public concerns regarding stormwater management. The MDEQ Office of Community Engagement also sent notice to local residents advising that the Permit Board would be considering this matter today. Mr. Jones indicated that there were members of the public that wished to address the Permit Board.

Subsequently, Bruce Deviney, Michael Usry, Carson Chittom, Colby Berry, Don Kazery, Jr., William Moore, Adrienne Lauden, Tom Mann, and Albert Spann, who live near the Faircloth Class I Rubbish Site, spoke in opposition to the proposed expansion. Mr. Kazery provided sampling results to the Permit Board. Richard Harrell and Clifford D. Daniels spoke in support of the project. Permit Board member David Snodgrass asked several questions which were addressed by Trent Jones, Richard Harrell, Don Kazery, Jr., Tom Mann and Albert Spann.

After hearing the comments, on motion by Chris McDonald and second by David Snodgrass, the Permit Board voted to go into closed session to determine whether to proceed into executive session. The Permit Board departed the Commission hearing room. Thereafter, MDEQ General Counsel Roy Furrh announced to the audience that on motion by Chris McDonald and second by Les Herrington, the Permit Board voted to go into executive session to discuss potential litigation. Subsequently, the Permit Board returned to the Commission hearing room and Mr. Furrh announced to the audience that on motion by Chris McDonald and second by Chris Hawkins, the Permit Board voted to close executive session and return to open session.

Thereafter, Vice-Chair Mann indicated the sampling results presented at the meeting by Mr. Kazery would be reviewed by MDEQ staff, but the results were not submitted by the public notice comment deadline.

Subsequently, Trent Jones, on behalf of MDEQ, recommended that the Permit Board reissue with modification the solid waste management permit and issue coverage under the NPDES Industrial Storm Water General Permit to Faircloth Rubbish Landfill, Inc. in two separate actions. Mr. Jones indicated the constraints, limitations and provisions of the proposed permits, the facility and the proposed expansion area can be sited, constructed and operated in a manner consistent with the applicable state and federal laws and regulations that are within MDEQ's jurisdiction.

Subsequently, on motion by Les Herrington and second by Jennifer Wittmann, the Permit Board voted 4-2 to reissue with modification solid waste management permit No. SW0250020548 to Faircloth Rubbish Landfill, Inc. Mr. Furrh requested a roll-call vote and Ms. Wittmann, Mr. Herrington, Mr. Hawkins and Vice-Chair Mann verbally announced they voted in favor of the motion and Mr. McDonald and Mr. Snodgrass verbally announced they voted against the motion. Mr. Mann, as acting Chair, verbally voted to provide a majority vote for the motion.

Thereafter, on motion by Jennifer Wittmann and second by Les Herrington, the Permit Board voted 4-2 to issue coverage MSR002437 under the NPDES Industrial Storm Water General Permit. Mr. Furrh requested a roll-call vote and Ms. Wittmann, Mr. Herrington, Mr. Hawkins and Vice-Chair Mann verbally announced they voted in favor of the motion and Mr. McDonald and Mr. Snodgrass verbally announced they voted against the motion. Again, Mr. Mann, as acting Chair, verbally voted to provide a majority vote for the motion.

Mr. Furrh announced that any aggrieved party may request an evidentiary hearing related to the Permit Board's decisions pursuant to Miss. Code Ann. § 49-17-29 and that he could be contacted for assistance.

Following a brief presentation by MDEQ General Counsel Roy Furrh, on motion by Chris McDonald and second by Les Herrington the Permit voted to adopt and approve the proposed FOFCOLS related to the Permit Board's decision after an evidentiary hearing held on August 8, 2023, to issue Surface Mining Permit No. P23-004 and issue coverage under the State of Mississippi Mining Storm Water, Dewatering and No Discharge General Permit No. MSR322989 to APAC-Mississippi, Inc. in Carroll County. Mr. Furrh clarified the version that was adopted and approved included revisions suggested by APAC-Mississippi, Inc. and Vice-Chair Mann which was previously provided to the Permit Board members for their review.

**OTHER BUSINESS**

Mr. Furrh announced there was no further business.

Vice-Chair Mann confirmed the next Permit Board meeting for Tuesday, December 12, 2023.

Vice-Chair Mann adjourned the meeting.
