MISSISSIPPI COMMISSION ON ENVIRONMENTAL QUALITY OFFICIAL MINUTES DECEMBER 13, 2023

The regular monthly meeting of the Commission on Environmental Quality was held on Wednesday, December 13, 2023, in-person in the Commission Hearing Room at the offices of the Mississippi Department of Environmental Quality, 515 East Amite Street, Jackson, Mississippi, beginning at 9:00 a.m.

Commissioners present were: John Dane, III, Patrick Johnson, Jr., Chat Phillips, Jamie Planck Martin McRee, Billy Van Devender, and Jack Winstead.

Commissioner Brenda Lathan was not present.

Others present were: Chris Wells, Executive Director, Jaricus Whitlock, Donna Hodges, Thomas Wallace, Roy Furrh, staff of MDEQ; and other staff members and visitors whose names appear elsewhere in these minutes.

The meeting was called to order by Chairman Johnson and the following business was transacted:

Notice of Meeting

The Commission was informed that the legal Notice of Meeting concerning the time, date, and place of this meeting had been posted publicly as required by law. The Notice of Meeting read as follows: "Please take note that the regularly scheduled meeting of the Mississippi Commission on Environmental Quality for December, 2023, will take place on Wednesday, December 13, 2023, at 9:00 a.m. This meeting will be held in the Commission Hearing Room at the offices of the Mississippi Department of Environmental Quality at 515 East Amite Street, Jackson, Mississippi. As always, the public is invited to attend." This notice was posted on MDEQ's website and in the MDEQ offices in Jackson, MS on October 26, 2023.

Approval of Minutes

On motion made by Mr. Winstead and seconded by Mr. Van Devender, the minutes of the October 26, 2023, meeting were approved and adopted as the Official Minutes.

After approval of the minutes, Executive Director Chris Wells, took a few moments to pay tribute to Krystal Rudolph, Chief of MDEQ's Environmental Permits Division, who recently passed away.

FY 2025 Title V Fee Recommendation - Approval to Proceed to Public Notice of Hearing

Mr. Jaricus Whitlock stated that a copy of the report containing the Title V Advisory Council's Title V fee recommendation for the upcoming fee year was previously forwarded to the Commission. It is both the Title V Advisory Council's recommendation and the staff's recommendation to set the fee schedule for the upcoming year at \$32 per ton of regulated air pollutants, which is a reduction from the previously established rate of \$37 per ton. In response to questions by several Commissioners on the reduced recommended fee, Executive Director Chris Wells stated that Title V fees are structured to fund the Title V program and to pay staff that do Title V work. Title V fees can only go toward funding the Title V program and not to fund other programs within the agency. Due to staffing shortages, the program has not been expending as many funds as was anticipated last year when the FY 2024 fee was set.

On behalf of MDEQ staff, Mr. Whitlock requested approval to hold a public hearing to receive comments regarding the proposed fee and to proceed with public notice of the hearing. After the public hearing has been held, the public comment period has ended, and comments have been reviewed, staff will bring the fee recommendation back before the Commission for final action. Following staff presentation and deliberation, on motion made by Ms. McRee and seconded by Mr. Phillips, the Commission unanimously voted to proceed with a public hearing to receive comments regarding the proposed FY 2025 Title V fee and to proceed with public notice of the hearing.

Designation of Hearing Officer

Ms. Donna Hodges stated that Miss. Code Ann. § 49-17-33 allows a hearing officer designated by the Commission to conduct an evidentiary hearing. On behalf of MDEQ staff, Ms. Hodges proposed and recommended the approval and designation of Ellen O'Neal, a former Special Assistant Attorney General

provided by the Office of the Attorney General, as the hearing officer in the pending case of *MCEQ v. The City of Jackson* to handle pre-hearing evidentiary matters on behalf of the Commission and to assist the Commission during the evidentiary hearing itself with rulings on evidentiary matters pursuant to Miss. Code Ann. § 49-17-33. Ms. Hodges stated that Ms. O'Neal is a long-time state employee with over thirty years of experience. Following staff presentation and deliberation, on motion made by Ms. McRee and seconded by Mr. Winstead, the Commission unanimously voted to approve and designate Ellen O'Neal as the hearing officer in the pending case of *MCEQ v. The City of Jackson*.

Mr. Wells also informed the Commission that an evidentiary hearing in the case of MCEQ v. The City of Jackson is currently scheduled to be heard by the Commission during the January 25th Commission meeting. In response to a question by Mr. Van Devender, Executive Director Chris Wells stated that the hearing involves an enforcement action related to a garbage collection issue which arose last spring.

Commission Approval of Brownfield Agreement Termination

Mr. Thomas Wallace stated that the Commission previously approved Brownfield Agreement 7250 23 in May 2023, between the Commission and Iconic Buildings, LLC for the remediation of the former Triplett Day Drug Building in Gulfport, Mississippi. The original brownfield agreement required the remediation of asbestos containing materials. The completed remedial activities met the requirements of the MDEQ-approved Corrective Action Plan dated January 5, 2023. Iconic Buildings, LLC requested the Commission make a determination as to the completion of the Brownfield Agreement. Staff of MDEQ evaluated the Brownfield Agreement completion and believes that the Site is in compliance with applicable State and Federal laws and standards and will be protective of the public health and the environment. Therefore, on behalf of MDEQ staff, Mr. Wallace recommended the Commission determine the Brownfield Agreement has been completed. Following staff presentation and deliberation, on motion made by Mr. Dane and seconded by Mr. Van Devender, the Commission unanimously voted that Brownfield Agreement 7250 23 between the Commission and Iconic Buildings, LLC for the remediation of the former Triplett Day Drug Building in Gulfport, Mississippi, be deemed complete.

Solid Waste Tire Assistance Grants

On previous authority delegated to the MDEQ Executive Director, the Commission was provided a listing by staff of the following waste tire assistance grants that have been awarded to local governments:

Asbestos Certifications

On previous authority delegated to the Head, Office of Pollution Control, the staff reported that 111 asbestos certifications had been issued since the last report.

Lead Paint Certifications

On previous authority delegated to the Head, Office of Pollution Control, the staff reported that 77 lead paint certifications had been issued since the last report.

Underground Storage Tank (UST) Certifications

On previous authority delegated to the Head, Office of Pollution Control, the staff reported that 5 certifications to those who install, alter, or remove underground storage tanks had been issued since the last report.

Wastewater Operator Certifications

On previous authority delegated to the Head, Office of Pollution Control, the staff reported that 74 wastewater operator certificates had been issued since the last report.

Administrative Orders

On previous authority delegated to the MDEQ Executive Director, the staff reported that 12 Administrative Orders have been issued since the Commission's meeting on October 26, 2023. A list of

these orders is made a part of these minutes and is filed in the Official Minutes File.

Other Business

Executive Director Chris Wells reminded the Commission that the new legislative session begins in January and that any proposed legislation that affects the agency will be addressed as necessary. MDEQ will request an increase in appropriations and will also be assigned new Chairmen in the Senate and House environmental and conservation committees.

Setting of Meeting

The Commission decided to meet next on Thursday, January 25, 2024, beginning at 9:00 a.m.

There being no further business to come before the Commission, the meeting was adjourned.
