MISSISSIPPI COMMISSION ON ENVIRONMENTAL QUALITY2531 OFFICIAL MINUTES SEPTEMBER 26, 2024

The regular monthly meeting of the Commission on Environmental Quality was held on Thursday, September 26, 2024, in-person in the Commission Hearing Room at the offices of the Mississippi Department of Environmental Quality, 515 East Amite Street, Jackson, Mississippi, beginning at 9:00 a.m.

Commissioners present were: John Dane, III, Patrick Johnson, Jr., Brenda Lathan, Kent Parrish, Jr., Chat Phillips, Billy VanDevender and Jack Winstead.

Others present were: Chris Wells, Executive Director, Brent Jones, Chris Sanders, Donna Hodges, Roy Furrh, staff of MDEQ; and other staff members and visitors whose names appear elsewhere in these minutes.

After the meeting was called to order by Chair Patrick Johnson, the following business was transacted:

Welcome of New Commissioner

Chair Patrick Johnson and Executive Director Chris Wells welcomed Mr. Kent Parrish, Jr. to the Commission on Environmental Quality.

Approval of Minutes

On motion made by Mr. Winstead and seconded by Ms. Lathan, the minutes of the June 27, 2024, meeting were approved and adopted by the Commission as the Official Minutes.

Water Pollution Control Revolving Loan Fund (WPCRLF) Program, Adoption of FY-2024 Intended Use Plan

On behalf of MDEQ staff, Mr. Brent Jones recommended the Commission adopt the draft FY-2024 Intended Use Plan, which was previously sent to them for review. This document identifies the loan funds available to our communities for the construction of wastewater infrastructure, the communities to receive these loan funds, the loan interest rate, program deadlines, and other related information. Public comments on the draft Intended Use Plan were solicited through a public comment period and public hearing. No comments were received from the public. Comments were received from EPA Region 4 which resulted in minor text changes. Following staff presentation and deliberation, on motion made by Mr. Dane and seconded by Mr. Phillips, the Commission unanimously voted to adopt the Water Pollution Control Revolving Loan Fund (WPCRLF) Program FY-2024 Intended Use Plan and issue a corresponding Order to be executed by the Executive Director.

Briefing to the Commission on New Statutory Language and requested approvals - Senate Bill 2649

Mr. Chris Sanders provided a briefing to the Commission on the new statutory language of Mississippi Senate Bill 2649 (2024 Regular Session), amending Section 49-2-13 of the Mississippi Code, which Governor Tate Reeves signed into law effective July 1, 2024. Under the new law, a pathway was created for permitting applicants, seeking permits from the Mississippi Department of Environmental Quality Permit Board, to voluntarily request that MDEQ seek additional assistance to process their applications and/or certifications. This additional assistance to MDEQ would be voluntarily paid for by the permitting applicant. Senate Bill 2649 further authorizes the Executive Director to enter into contracts with applicants seeking this additional assistance but may do so only with approval by the Commission. A draft contract, as the designated mechanism to engage in this work with the applicant, was previously forwarded to the Commission for review and would ensure that MDEQ is reimbursed the costs of the additional services requested by the applicant. A contract will also be made between MDEQ and qualified persons or entities wishing to provide additional permit processing services to MDEQ, and staff is currently drafting a Request for Qualifications (RFQ) to procure these services. On behalf of staff, Mr. Sanders requested Commission approval for the draft contract with the permitting applicant and for the Executive Director to be able to enter into said contract with the applicant. Mr. Sanders also requested Commission approval for the Executive Director to enter into contract with persons and entities providing additional permit processing services to MDEQ once the RFQ process is completed. Executive Director Chris Wells stated that MDEQ believes the legislative intent behind Senate Bill 2649 was to provide an efficiency for permitting applicants and Commission approval on staffs' requests will ensure that individual contracts do not need to be brought before the Commission each time they are received. In response to a question by Mr. Parrish, Mr. Sanders stated that MDEQ would review all contractors' work and ensure that all requirements are met. Executive Director Chris Wells stated that contractors act as an agent for MDEQ, so MDEQ would address any contractual issues. In response to a question by Mr. Phillips, Mr. Wells stated that the reporting requirement to the legislature in Senate Bill 2649 will help ensure that the program is working and that any changes that need to be made can be done in future legislative sessions. Following staff presentation and deliberation, on motion made by Mr. Dane and seconded by Mr. Winstead, the Commission unanimously voted to approve the draft contract with the permitting applicant, and to grant the Executive Director approval to enter into said contract with the applicant on the Commission's behalf. On motion made by Mr. Dane and seconded by Mr. Phillips, the Commission also granted the Executive Director approval to enter into contracts with qualified persons or entities desiring to provide MDEQ service assistance in reviewing/processing permit applications and/or certifications on the Commission's behalf.

<u>Mississippi Commission on Environmental Quality v. Ted Doukas, 2 Lisa Court Corp.et al. – Hearing Officer</u>

Ms. Donna Hodges stated that MDEQ legal Counsel and John Lassiter, Counsel for Ted Doukas, are requesting to postpone today's hearing on the Defendant's Notice of Appeal and MDEQ's Motion to Dismiss the Notice of Appeal. Ms. Hodges further stated that counsel for both sides have been working on a resolution to this issue and are requesting a 10-day postponement of the hearing to continue discussions. Mr. Lassiter stated that he had a conflict on day 10 of the extension but will work with counsel on an agreeable date. So that the Commission does not have to reconvene in 10 days to hear this matter, counsel for both sides requested the Commission designate Executive Director Chris Wells as the hearing officer, to hear these motions. Executive Director Chris Wells stated that the Commission has statutory authority to appoint hearing officers and that the hearing officer can be the Executive Director if the Commission so chooses. Following staff presentation and deliberation, on motion made by Mr. Dane and seconded by Ms. Lathan, the Commission unanimously voted to approve Executive Director, Chris Wells, as hearing officer to hear the Defendant's Notice of Appeal and MDEQ's Motion to Dismiss the Notice of Appeal in the matter of the Mississippi Commission on Environmental Quality v. Ted Doukas, 2 Lisa Court Corp., et al.
