Grantman MS, LLC-Sandhill Subdivision-Jackson County-Consideration of: Issuance of Clean Water Act Section 401 Water Quality Certification-WQC2023035 and Issuance of Coverage under the Large Construction Stormwater General Permit-MSR109040

Carrie Barefoot, Branch Manager of the 401 Water Quality Certification and Stormwater Branch of the Environmental Permits Division of the Office of Pollution Control of MDEQ, presented the matter for the Permit Board's consideration.

This project has two permitting actions. The first action is a request for a Section 401 Water Quality Certification and the second action is a request for coverage under the Large Construction Stormwater General Permit.

These requests are related to applications from Grantman MS, LLC for the construction of a single-family residential subdivision, to be known as Sandhill Subdivision, located on a 72.8-acre parcel located west of Eglin Road and south of Fort Bayou Road in the St. Martin community of Jackson County, Mississippi.

The applicant applied for a Section 401 Clean Water Act Water Quality Certification to conduct regulated activities in jurisdictional waters for the construction of a residential subdivision. On-site activities would consist of clearing, grubbing, and grading of the site and the construction of 184-lots ranging in size from 8,300 square feet to 11,500 square feet in size, access roads, utilities, and detention ponds. The project purpose, as stated by the applicant, is to provide housing opportunities for Jackson County residents who wish to live in the Ocean Springs area.

The 72.8-acre parcel contains approximately 38.02 acres of wetlands and 0.35 acres of other waters. Construction of the project would result in the filling of approximately 25.64 acres of pine savanna wetlands and 1.15 acres of bottomland hardwood wetlands for a total of 26.79 acres of wetlands. Additionally, 0.20 acres of other waters, including 84 linear feet of an intermittent stream would also be impacted. The remaining 11.23 acres of wetlands and 1,055 linear feet of stream onsite would be avoided. These impacts and avoidance take into account the applicant's efforts to avoid and minimize impacts to jurisdictional waters. To compensate for the loss of wetland and stream functions, the applicant proposes to purchase wetland mitigation credits from an approved mitigation bank.

In addition to the Water Quality Certification, the proposed project requires a permit pursuant to Section 404 of the Clean Water Act from the U.S. Army Corps of Engineers, Mobile District. On June 15, 2023, the U.S. Army Corps of Engineers, Mobile District published a joint public notice for this project, and a copy of the notice was provided to adjacent property owners. During the public notice period, a letter of objection was received by MDEQ. The concerns, outlined in this letter and in subsequent communications with the commentor, include: the potential for increased flood risk and excessive stormwater runoff; the filling of natural drains and springs and the impact on the local ecosystem; the potential impacts to the Mississippi Sandhill Crane National Wildlife Refuge and other impacts to wildlife; the potential cumulative impacts from this and other developments in the area; the potential negative impacts to water quality; and the potential increase in traffic, noise pollution, and strain on the local infrastructure.

As a follow-up, the applicant addressed these concerns in a response dated February 4, 2025. MDEQ staff has reviewed these comments and the applicant's response as they pertain to water quality and feel as though these concerns have been adequately addressed. The applicant addressed items related to water quality and provided information to address the treatment of stormwater runoff both during and after construction, mitigation to offset the loss of functions

and values of the impacted waters, documentation to address any potential impacts to threatened and endangered species, and information that demonstrates that wastewater collection and treatment is available.

The second action for this proposed development is a request for coverage under the large construction stormwater general permit. The applicant submitted a Large Construction Notice of Intent and an associated Storm Water Pollution Prevention Plan on July 20, 2023, with subsequent revisions, to obtain coverage under Mississippi's Large Construction Stormwater General Permit for construction activities. Construction activities would disturb approximately 64.8 acres for site clearing, grubbing, and grading and the construction of 184-lots, access roads, utilities, and detention ponds.

Some of the storm water controls proposed during construction include installation of a construction entrance/exit, use of double row silt fencing, and four sedimentation basins equipped with skimmers. The Notice of Intent and SWPPP were reviewed and deemed complete and meet the minimum requirements in addressing storm water discharges from the project site.

Thereafter, Vice-Chair Hawkins opened the meeting for public comment and Joshua Nelson, a neighbor of the proposed Sandhill Subdivision spoke against the permits. Subsequently, on behalf of Grantman MS, LLC, Dennis Stieffel, a professional engineer, spoke in favor of the project. There were no other public comments related to Grantman MS, LLC's proposed applications.

Permit Board members Les Herrington and David Dockery and MDEQ General Counsel Roy Furrh asked questions. Permit Board member Jennifer Wittmann indicated that the Mississippi Department of Marine Resources consistency determination with the State's approved Coastal Program under the Coastal Zone Management Act would have to be re-noticed and reconsidered due to additional wetland impacts proposed by the applicant.

Ms. Barefoot indicated that MDEQ reviewed the request for Section 401 Water Quality Certification and request for coverage under the Large Construction Stormwater Notice of Intent and associated Stormwater Pollution Prevention Plan and based on that review believe that the applicant included the necessary components required by state and federal regulations and the Large Construction Stormwater General Permit.

Subsequently, on motion by David Snodgrass and second by Les Herrington, the Permit Board voted to issue the Section 401 Water Quality Certification (WQC2023035) to Grantman MS, LLC for the Sandhill Subdivision in Jackson County.

Next, on motion by Chris McDonald and second by Les Herrington, the Permit Board voted to issue coverage under the Large Construction Stormwater General Permit (MSR109040) to Grantman MS, LLC for the Sandhill Subdivision in Jackson County.

Thereafter, Mr. Furrh informed Mr. Nelson that any interested party could request an evidentiary hearing in writing within thirty days of the Permit Board's decision and told Mr. Nelson to contact him with any questions.

RaceTrac, Inc.-Moss Point-Jackson County-Consideration of Issuance of Clean Water Act Section 401 Water Quality Certification (WQC2024012) to RaceTrac, Inc. and Issuance of Coverage under the Large Construction Stormwater General Permit (MSR109432)

Ms. Barefoot presented the matter for the Permit Board's consideration. This project has two permitting actions for your consideration. The first action is a request for a Section 401 Water Quality Certification and the second action is a request for coverage under the Large Construction Stormwater General Permit.

These requests are related to applications from RaceTrac, Inc. for the construction of a travel center that would incorporate and expand an existing gas station located on a 30-acre site located on the west side of the intersection of Mississippi Highway 63 and Sarracenia Road in Moss Point, Jackson County, Mississippi.

On November 25, 2024, RaceTrac submitted a request for a Section 401 Clean Water Act Water Quality Certification to conduct regulated activities in jurisdictional waters for the construction of a travel center that would incorporate and expand an existing gas station and would include a travel center building, gasoline and diesel pumps for larger transport trucks, a large area of parking for use by transport trucks, utilities, and detention ponds. The building would contain facilities for showering, sleeping, and eating for customers.

The total project site is approximately 30.17 acres in size of which 26.62 acres have been identified as wetlands. Construction of the project would result in the filling of 10.38 acres of wet pine savanna wetlands and 0.06 acres of hardwood drain wetlands for a total of 10.44 acres of wetlands. The remaining 16.18 acres of wetlands onsite would be avoided. To compensate for the loss of wetland functions, the applicant proposes to purchase wetland mitigation credits from an approved mitigation bank.

In addition to the Water Quality Certification, the proposed project requires a permit pursuant to Section 404 of the Clean Water Act from the U.S. Army Corps of Engineers, Mobile District. On March 5, 2024, the U.S. Army Corps of Engineers, Mobile District published a joint public notice for this project, and a copy of the notice was provided to adjacent property owners. During the public notice period, letters of objection were received by MDEQ. The concerns outlined in these letters include: The potential for increased flood risk; the impacts associated with filling of wetlands; the potential impact to wildlife; and the potential for noise and light pollution.

As a follow-up, the applicant addressed these concerns in a response dated June 26, 2024. MDEQ staff reviewed these comments and the applicant's response as they pertain to water quality and feel as though these concerns have been adequately addressed. The applicant addressed items related to water quality and provided information to address the treatment of stormwater runoff both during and after construction, mitigation to offset the loss of functions and values of the impacted waters, and documentation to address any potential impacts to threatened and endangered species.

The second action for this proposed development is a request for coverage under the large construction stormwater general permit. The applicant submitted a Large Construction Notice of Intent and an associated Storm Water Pollution Prevention Plan on November 25, 2024, with subsequent revisions, to obtain coverage under Mississippi's Large Construction General Permit for construction activities. Construction activities would disturb approximately 12.75 acres for construction of the travel center and associated infrastructure.

Some of the storm water controls proposed during construction include installation of a construction entrance/exit, use of double row silt fencing, straw wattles, inlet protection, and a sedimentation basin equipped with a skimmer. The Notice of Intent and Storm Water Pollution Prevention Plan were reviewed and deemed complete and meet the minimum requirements in addressing storm water discharges from the project site.

Permit Board members received detailed information on this project before the meeting. In relation to the Water Quality Certification, MDEQ staff provided copies of the public notice of application, a copy of the request for Water Quality Certification, a copy of the public comments received, and a draft of the proposed 401 WQC. Also, with regards to the construction stormwater application, MDEQ staff provided copies of the Large Construction Notice of Intent and the Storm Water Pollution Prevention Plan. The information Permit Board members received reflects the most recent versions of the applications and plans proposed by the applicant.

Ms. Barefoot indicated that MDEQ has reviewed the request for Section 401 Water Quality Certification and request for coverage under the Large Construction Stormwater Notice of Intent and associated Stormwater Pollution Prevention Plan. Based on that review, MDEQ believes the applications include the necessary components required by state and federal regulations and the Large Construction Stormwater General Permit.

On behalf of RaceTrac, Inc., Jack Schmidt, a professional engineer, spoke in favor of the project. There was no further public comment from the audience. Permit Board member Wittmann indicated that the Mississippi Department of Marine Resources consistency determination with the State's approved Coastal Program under the Coastal Zone Management Act would have to be re-noticed and reconsidered due to additional wetland impacts proposed by the applicant.

Thereafter, on motion by David Snodgrass and second by Les Herrington, the Permit Board voted to issue the Section 401 Water Quality Certification (WQC2024012) to RaceTrac, Inc. for its proposed site in Moss Point, Jackson County

Subsequently, on motion by Les Herrington and second by David Snodgrass, the Permit Board voted to issue coverage under the Large Construction Stormwater General Permit (MSR109432) to RaceTrac, Inc. for its proposed site in Moss Point, Jackson County.

### **OTHER BUSINESS**

Mr. Furrh welcomed Ryan Jones, an alternate designee with the Mississippi Department of Wildlife, Fisheries and Parks. Mr. Jones participated in the meeting for Lynn Posey, the Executive Director of the Department of Wildlife, Fisheries and Parks and substituted for Chair Doug Mann.

Mr. Furrh indicated he would remind any Permit Board members, who have not done so, to file their respective Statements of Economic Interest by the May 1, 2025, deadline, for the year 2024.


