MISSISSIPPI COMMISSION ON ENVIRONMENTAL QUALITY2557 OFFICIAL MINUTES MARCH 27, 2025

The regular monthly meeting of the Commission on Environmental Quality was held on Thursday, March 27, 2025, in-person in the Commission Hearing Room at the offices of the Mississippi Department of Environmental Quality, 515 East Amite Street, Jackson, Mississippi, beginning at 9:00 a.m.

Commissioners present were: Brenda Lathan, Kent Parrish, Jr., Chat Phillips, and Jack Winstead.

Commissioners John Dane, III, Patrick Johnson, Jr., and Billy Van Devender were not present.

Others present were: Chris Sanders, Chief of Staff, Laura James, Ryan Ozment, Roy Furrh, staff of MDEQ; and other staff members and visitors whose names appear elsewhere in these minutes.

After the meeting was called to order by Co-Chair Chat Phillips, and after he led the invocation, the following business was transacted:

## Approval of Minutes

On motion made by Mr. Winstead and seconded by Ms. Lathan, the minutes of the January 23, 2025, meeting were approved and adopted by the Commission as the Official Minutes.

#### FY2025 Title V Fee Recommendation

Ms. Laura James stated that the Commission was presented with the Title V fee schedule recommendation at its meeting on January 23, 2025. Air Division staff is now requesting approval to finalize the FY 2026 Title V fee recommendation after completing an associated public notice period and public hearing. The public hearing was held on March 5, 2025, and two (2) comments were received from the same entity. A response to these comments was provided with no change to the proposed fee needed. Ms. James recommended the Commission set the fee as previously recommended at the proposed rate of \$27 per ton of regulated air pollutants, accompanied by a tiered minimum fee, if applicable, and maintenance fee. Following staff presentation and deliberation, on motion made by Ms. Lathan and seconded by Mr. Parrish, the Commission unanimously voted to approve the Title V fee at the proposed rate of \$27 per ton of regulated air pollutants, accompanied by a tiered minimum fee, if applicable, and maintenance fee.

## Commission Approval of Brownfield Agreement

On behalf of staff, Ms. Ryan Ozment recommended that the Commission approve the Brownfield Agreement between the Commission and Tracetown Redevelopment, LLC, regarding the remediation of the brownfield property located at 55 Sergeant Prentiss Drive, Natchez, Adams County, Mississippi. The administrative record for this environmental response project is referred to as the Tracetown Shopping Center. The proposed site currently operates as a multi-unit commercial property with multiple vacant units. Sampling and inspection of the construction materials indicated the presence of Asbestos Containing Materials (ACM) in excess of the Environmental Protection Agency's 1% ACM threshold. Therefore, remediation of the Brownfield Agreement Site is necessary. Tracetown Redevelopment, LLC, proposed abatement and disposal of the CM material in accordance with MDEQ approved methods. The proposed future land use of the site will be a retail center. Staff of the MDEQ evaluated the Brownfield Agreement and believes that, with the conditions and restrictions contained within the Brownfield Agreement, the Site will be in compliance with applicable State and Federal laws and standards and will be protective of public health and the environment. Following staff presentation and deliberation, on motion made by Mr. Winstead and seconded by Mr. Parrish, the Commission unanimously voted to approve the Brownfield Agreement between the Commission and Tracetown Redevelopment, LLC, regarding the remediation of brownfield property located at 55 Sergeant Prentiss Drive, Natchez, Adams County, Mississippi.

Amendments to Mississippi State Oil and Gas Board Rule 45-Commission's consideration of approval of the Amendments

Mr. Roy Furrh introduced Mr. Marcy Forester, Esquire, and David Snodgrass from the Mississippi

State Oil and Gas Board ("Oil and Gas Board"), and explained they attended today's meeting to answer any questions by the Commission. Mr. Furrh further stated that the Oil and Gas Board approved Amendments to Oil and Gas Board Rule 45 on Wednesday, March 19, 2025. The proposed amendments to Rule 45 went through an Oil and Gas Board public notice, a public comment period and a public hearing. By statute and through case law, adoption and amendments of Oil and Gas Board disposal regulations must be approved by the Commission since they deal with waste disposal. The staff of the Oil and Gas Board coordinated with the Staff of MDEQ on the amendments to Rule 45. The purpose of the Amendments to Oil and Gas Board Rule 45 is to streamline, clarify and update the rule to current standards and practices as well as to provide more stringent environmental protection. Under the proposed amendments, pit fluids and mud may no longer be discharged into streams. The amendments to Rule 45 add or reference definitions for "commercial oil field exploration and production waste disposal"; "noncommercial disposal of oil field exploration and production waste"; "oil field exploration and production wastes"; "produced water"; and "underground source of drinking water". The use of earthen pits is limited under the amendments to prevent the pollution of air, fresh waters and soils. Consistent with the current practice, the use of burn pits, emergency pits and well test pits would no longer be allowed. In the future, only temporary storage pits for produced water and drilling reserve pits will be allowed under Rule 45. The amendments provide chlorides and pH limits for what can be landspread. The amendments recognize MDEQ/Commission statutory jurisdiction over "commercial oil field exploration and production waste disposal" and the Oil and Gas Board's statutory jurisdiction to regulate "noncommercial disposal of oil field exploration and production waste" and commercial and noncommercial Class II Underground Injection Control wells. The amendments also specify installation and use of flares and venting activities must be conducted in accordance with the Commission's regulations and the Mississippi Air and Water Pollution Control Act. During the Oil and Gas Board Rule 45 public comment period, the Southeast Oil and Gas Association provided a few minor comments which were incorporated in the amendments. The Commission was previously provided with a copy of the red-lined amendments for consideration. Mr. Snodgrass addressed a question by Mr. Phillips related to determining the chloride limit for landspreading in Rule 45 through what is allowed in the state of On behalf of MDEQ Staff, Mr. Furth recommended the Commission approve the provided amendments to Oil and Gas Board Rule 45. Following staff presentation and deliberation, on motion made by Mr. Parrish and seconded by Ms. Lathan, the Commission unanimously voted to approve the amendments to the Oil and Gas Board Rule 45.
