

**MINUTES OF THE MISSISSIPPI ENVIRONMENTAL QUALITY PERMIT BOARD

**Amite BioEnergy, LLC – Wood Pellet Manufacturing Facility
Amite County, Mississippi**

Jaricus Whitlock, Chief of the Air Division of MDEQ, presented the matter for the Permit Board's consideration.

Mr. Whitlock mentioned this project has two proposed permitting actions. The first action for consideration is the proposed modification of the State of Mississippi Air Pollution Control Permit to Construct Air Emissions Equipment (or "Permit to Construct" in short) initially issued November 26, 2012, and respectively modified March 21, 2014, and March 9, 2021; and the second action for consideration is the proposed issuance of an initial Title V Air Operating Permit.

In coordination with MDEQ's Office of Community Engagement, 192 post cards and 77 emails were transmitted providing notice of this meeting and MDEQ's intention to present the draft permits to the Permit Board for consideration.

Mr. Whitlock indicated Amite BioEnergy is an existing industrial facility that produces wood pellets from green softwood material. Wood pellet production primarily is achieved through the overall operation of a log chipper, a bark hog, debarker, wood-fired furnace, rotary drum dryer, dry hammer mills (both primary and secondary), wood pellet press mills, wood pellet coolers, final product load-out operations, and auxiliary equipment for emergency power.

The initial Permit to Construct was issued November 26, 2012, and established emission limits for the facility to avoid applicability to Prevention of Significant Deterioration (or "PSD") regulations as well as to avoid being classified as major source of hazardous air pollutants (or "HAPs"). As a regulatory reminder, the following are the thresholds for each status:

- *For PSD applicability:* emitting 250 tons per year of any criteria pollutant
- *For HAP major source applicability:* emitting either 10 tons per year of a single HAP or 25 tons per year of all HAPs in total.

A modification of the initial Permit to Construct was issued March 21, 2014, to address "as-built" changes made to the wood-fired furnace and rotary dryer during the construction of these process units.

Amite BioEnergy certified the completion of construction activities on August 11, 2015, which triggered a 12-month window in which the facility was required to submit an initial Title V Operating Permit application for on-site operations to continue. Accordingly, Amite BioEnergy submitted this application to MDEQ on August 10, 2016. As a result of the facility satisfying the denoted submittal obligation and MDEQ signifying the application as "administratively complete", Amite BioEnergy was granted an "administrative shield" for which on-site operations could continue in accordance with the requirements established in the modified Permit to Construct issued March 21, 2014, until issuance of the initial Title V Operating Permit.

After completing a review of the denoted Title V application, MDEQ prepared a draft Title V Operating Permit and associated supporting documentation for public comment. The public notice period began July 14, 2017, and ended August 14, 2017. By the completion of this public notice period, MDEQ had received several significant comments expressing both concerns and alleged deficiencies in the draft permit.

During this time, MDEQ initiated an enforcement action against the facility on March 2, 2017, to address violations pertaining to the non-permitted use of an emergency fire water pump engine, failure to conduct weekly observations for visible emissions, and failure to submit monitoring reports in a timely manner. The enforcement action culminated in the execution of an Agreed

Order on June 27, 2019, that included a civil penalty totaling \$110,000. Amite BioEnergy paid the \$110,000 penalty.

MDEQ reviewed the comments received during the public comment period for the aforementioned draft Title V Operating Permit and prepared the appropriate responses. MDEQ received a statement from Amite BioEnergy on November 7, 2018, disclosing that it may not be complying with the PSD avoidance limit established for volatile organic compound emissions in the initial Permit to Construct based on comparable data collected at a sister facility in Louisiana. Amite BioEnergy confirmed this speculation on February 22, 2019, with the submittal of emissions data that indicated their exceedance of the denoted volatile organic compound emission limit since 2016. As such, the facility submitted an application to MDEQ on December 20, 2019, requesting a modification of the Permit to Construct issued March 21, 2014, to facilitate the installation and operation of a regenerative catalytic oxidizer (which was to be the primary air pollution control mechanism for returning Amite BioEnergy to a status of “full compliance”) in addition to modifying existing on-site operations for expanded dried wood chip production and wood pellet production.

In response to the reported violation of the PSD avoidance limit, MDEQ initiated an enforcement action against the facility, which culminated in the execution of an Agreed Order on October 27, 2020, that included a civil penalty totaling \$2.5 million. Amite Bioenergy paid the \$2.5 million dollar penalty. Also included with the Agreed Order was a stipulated civil penalty in the amount of \$80,000 per month that was to start July 1, 2021, and continue until such time as the start-up of the regenerative catalytic oxidizer. On June 18, 2021, Amite BioEnergy submitted documentation affirming the full operation of the regenerative catalytic oxidizer, which satisfied the requirement in the Agreed Order.

Upon MDEQ’s review of the application requesting the aforementioned modification of the Permit to Construct, MDEQ prepared a draft permit and supporting documentation that imposed emission limits, performance standards, and operational restrictions to continue Amite BioEnergy’s avoidance of both PSD applicability and HAP major source applicability. In addition, MDEQ established more comprehensive monitoring, recordkeeping, and reporting requirements within the draft permit to ensure more effective compliance assurance mechanisms for all imposed standards, restrictions, and limits. MDEQ provided a 45-day public notice period for the proposed modification of the Permit to Construct, which began December 18, 2020, and ended February 1, 2021. The draft permit was presented to the Permit Board on March 9, 2021, and was approved on that day.

On March 8, 2022, Amite BioEnergy submitted an application that served as both a request for a modified Permit to Construct and an update to the initial Title V application submitted August 10, 2016. This application reflected the following “as-built” changes to on-site operations since the modified Permit to Construct issued March 9, 2021:

- A declaration that five (5) green hammermills, two (2) pellet coolers, and four (4) pellet mills would not be constructed;
- A rescission of the earlier request to repurpose three (3) secondary dry hammermill systems into “dry shavings hammermill systems.”
- The inclusion of three (3) emergency bypass stacks for process equipment associated with the wood pelletizing process; and,
- A reduction in the maximum permitted throughputs for dried wood chip production and wood pellet production.

However, upon review of the submitted application, MDEQ discovered that the calculated HAP emissions exceeded the limits that had been established for the facility to avoid HAP major source applicability. MDEQ informed Amite BioEnergy of this finding on April 11, 2022, and the facility confirmed that the calculated HAP emissions were correct based on performance testing required by the modified Permit to Construct issued March 9, 2021. As such, Amite BioEnergy formally requested to be reclassified as a “HAP major source”.

With acknowledgement of the exceedance to the established HAP limits and upon further investigation of other alleged violations, MDEQ initiated an enforcement action against the facility, which culminated in the execution of an Agreed Order on September 11, 2024, that included a civil penalty totaling \$225,000. As an agreed upon stipulation of the final settlement, MDEQ allowed Amite BioEnergy credit up to \$75,000 for the construction and installation of a dust suppression screen on the southeast side of the facility's property as a Supplemental Environmental Project. Amite BioEnergy paid the remaining \$150,000 penalty. The dust suppression screen is required to be installed by July 8, 2025. As of December 31, 2024, Amite BioEnergy is complying with the existing established HAP limits independent of the request for a modification of the Permit to Construct through a reduction in overall production.

With regard to permitting as a HAP major source, Amite BioEnergy became subject to the Federal regulation noted as Requirements for Controlled Technology Determinations for Major Sources in accordance with the Clean Air Act Section 112(g) (or the "Case-By-Case MACT"). Therefore, a determination was required to be made in selecting both control technology as well as an emission limit that achieves the maximum degree of reduction in HAPs while taking into consideration the cost of achieving such emissions, any non-air quality and environmental impacts, and energy requirements.

In information submitted by Amite BioEnergy on January 9, 2024, the facility proposed operating the existing regenerative thermal oxidizer and regenerative catalytic oxidizer in a manner to achieve no less than 90% destruction efficiency of HAP emissions. While MDEQ agreed with the proposed selection of existing air pollution control devices to satisfy the "best available control technology" criteria, MDEQ also concluded that a more stringent emission limit was necessary within the regulatory framework. Therefore, in coordination with EPA, MDEQ determined that Amite BioEnergy shall operate the selected control technology in such a manner as to achieve no less than 96% destruction efficiency of HAPs from the major process equipment.

With consideration to the facility's compliance history, its applicability to the Case-By-Case MACT requirements, and MDEQ's expanded understanding of wood pellet production, MDEQ made a substantive effort to incorporate emission limits, operational restrictions, and compliance assurance mechanisms within the draft permits that are in accordance with all applicable State of Mississippi and Federal environmental laws, regulations, and ambient air quality standards.

Upon completion of the draft permits, MDEQ started the public comment period on October 11, 2024, and ended it on November 26, 2024. In all, MDEQ provided a 46-day public comment period. Additionally, to ensure meaningful public involvement for local community members to express concern regarding the proposed draft permit, MDEQ held a public hearing on November 14, 2024, at the Gloster Public Library in Gloster, Mississippi. During the overall public notice period, four (4) separate parties submitted written comments expressing support for the proposed issuance of the draft permits, approximately forty-seven (47) separate parties submitted written comments expressing concern about Amite BioEnergy regarding various issues, and twenty-eight (28) individuals conveyed concerns during the public hearing. Mr. Whitlock indicated all comments received have been thoroughly examined by MDEQ staff. Accordingly, a "Response to Comments" document was prepared to address concerns, and as appropriate, revisions were made to the draft permits to either correct errors or omissions, to further clarify MDEQ's intent for a requirement, or strengthen an existing requirement. Permit Board members were provided a copy of MDEQ's "Response to Comments" document along with all comments received during the public notice period, the registration cards for all individuals in attendance at the public hearing, the full transcript of the public hearing, and the updated draft permits that include all incorporated revisions.

Mr. Whitlock concluded that MDEQ reviewed and evaluated the environmental permit application, the supporting documents and information, and the comments received on the proposed draft permits that pertain to matters that are within MDEQ's environmental regulatory jurisdiction. Based on the cumulative review and in coordination with EPA, MDEQ developed a final draft modification to the Permit To Construct Air Emissions Equipment and a final draft Title V Air Operating Permit that MDEQ believes meets all applicable technical and environmental regulatory requirements.

Andrew Whitehurst, Paul Harris, Herbert Bell, Jimmy Brown, Kadin Love, Derhonda Brengettsy, Carmella Causey, Crystal Martin, Naya Black, Katherine Egland, Dr. Charlotte Keys, Isaiah Selman and Leslie Harvey spoke in opposition of the proposed permits.

Brad Mayhew, Vice-President of Southern Operations with Drax-a parent company of Amite BioEnergy, LLC, spoke in favor of the proposed permit actions. Annie McIlwain with PPM Consultants, also spoke in favor of the proposed permit actions.

Permit Board members asked Mr. Whitlock, Mr. Mayhew and Ms. McIlwain questions. Some members in the audience were allowed to make brief comments.

After discussion on motion by Les Herrington and second by Will Watkins, the Permit Board voted to proceed into closed session to determine whether to go into executive session. The Permit Board left the Commission hearing room and the public was allowed to remain in the room. Thereafter, Roy Furrh returned to the Commission hearing room and announced to the public that on motion by Chris McDonald and second by Jennifer Wittmann, the Permit Board voted to move into executive session to discuss a matter related to potential litigation. Mr. Furrh indicated the Permit Board would return. Next, on motion by Chris Hawkins and second by Les Herrington, the Permit Board voted to end executive session and return to open session which was announced to the public by Mr. Furrh. Chair Mann informed the public the Permit Board made no decision while in executive session.

Permit Board members asked Mr. Whitlock additional questions as well as Mr. Mayhew and Ms. McIlwain related to whether the proposed permit actions would allow Amite BioEnergy, LLC to increase production at the facility. The indication was the proposed permit actions would allow Amite BioEnergy, LLC to increase production. Other members in the audience were allowed to make brief comments. Mr. Whitlock indicated if the proposed permit actions were denied that Amite BioEnergy, LLC would be allowed to continue to operate under the existing Air Permit to Construct (0080-00031).

Thereafter, on motion by Les Herrington and second by Jennifer Wittmann, the Permit Board voted to proceed into closed session to determine whether to go into executive session. The Permit Board left the Commission hearing room and the public was allowed to remain in the room. Next, Mr. Furrh returned to the Commission hearing room and announced to the public that on motion by Jennifer Wittmann and second by Chris McDonald, the Permit Board voted to move into executive session to discuss a matter related to potential litigation. Mr. Furrh indicated the Permit Board would return. Thereafter, on motion by Chris Hawkins and second by Chris McDonald, the Permit Board voted to end executive session and return to open session which was announced to the public by Mr. Furrh. The Permit Board made no decision in executive session.

After returning to open session, on motion by David Dockery and second by Les Herrington, the Permit Board voted to deny the proposed permit actions which include the modification of the Air Permit to Construct and the Title V Air Operating Permit due to concern about Amite BioEnergy LLC's past compliance history. Will Watkins abstained from the vote.

Chair Mann indicated to the audience that the Permit Board would consider permit actions proposed by Amite BioEnergy LLC in the future after providing support for improved compliance history and timely installing the dust suppression curtain.

Mr. Furrh informed representatives of Amite BioEnergy, LLC that it could request a full evidentiary hearing before the Permit Board within 30 days of the decision.

OTHER BUSINESS

Mr. Furrh mentioned he would check the Ethics Commission website to confirm that all of the Permit Board members had filed their statements of economic interest for 2024 as the due date for filing is May 1.

CONFIRMATION OF THE NEXT REGULAR PERMIT BOARD MEETING

Chair Doug Mann confirmed the next regular meeting of the Permit Board was scheduled for Tuesday, May 13, 2025.

MEETING ADJOURNED

There being no further business to come before the Permit Board, on motion by David Dockery and second by Jennifer Wittman, the Permit Board voted to adjourn the meeting. Chair Doug Mann then adjourned the meeting.
