MISSISSIPPI COMMISSION ON ENVIRONMENTAL QUALITY OFFICIAL MINUTES APRIL 24, 2025

The regular monthly meeting of the Commission on Environmental Quality was held on Thursday, April 24, 2025, in-person in the Commission Hearing Room at the offices of the Mississippi Department of Environmental Quality, 515 East Amite Street, Jackson, Mississippi, beginning at 9:00 a.m.

Commissioners present were: Patrick Johnson, Jr., Brenda Lathan, Kent Parrish, Jr., Chat Phillips, Billy VanDevender and Jack Winstead.

Commissioner John Dane, III, was not present.

Others present were: Chris Wells, Executive Director, Thomas Wallace, Roy Furrh, staff of MDEQ; and other staff members and visitors whose names appear elsewhere in these minutes.

After the meeting was called to order by Chair Patrick Johnson, Mr. Phillips led the invocation, and the following business was transacted:

#### Approval of Minutes

On motion made by Ms. Lathan and seconded by Mr. Parrish, the minutes of the March 27, 2025, meeting were approved and adopted by the Commission as the Official Minutes.

### Commission Approval of Brownfield Agreement Modification

Mr. Thomas Wallace recommended that the Commission approve the Brownfield Agreement Modification between the Commission and McIngvale Square, LLC regarding the remediation of the brownfield property located at 820 McIngvale Road, Hernando, Desoto County, Mississippi. administrative record for this environmental response project is referred to as the McIngvale Square site. The proposed site currently operates as a golf course maintenance facility. Soil-vapor sampling indicated the presence of volatile organic compounds (VOCs) in soils. Contaminants 1,2-dichloroethane and 1,4-dioxane were detected at concentrations greater than the Environmental Protection Agency Vapor Intrusion Screening Levels, which is a potential risk for vapor intrusion. Therefore, remediation of the Brownfield Agreement Site is necessary. McIngvale Square, LLC, proposes to excavate and dispose of contaminated soil at the site prior to the construction of a new 8,000 square foot structure on the property. Previously, McIngvale Square, LLC, proposed installing a vapor barrier during the construction of the new structure. This was approved by the Commission via a Brownfield Agreement at its meeting on October 24, 2024; however, due to construction timelines, remedial, and economic considerations, McIngvale, LLC, is requesting to modify the method of remediation in the Corrective Action Plan to excavation. The proposed future land use of the site will be mixed-use, single-story structures, and parking. Staff of MDEQ evaluated the Brownfield Agreement Modification and believes that, with the conditions and restrictions contained within the Brownfield Agreement, the Site will be in compliance with applicable State and Federal laws and standards and will be protective of the public health and the environment. Following staff presentation and deliberation, on motion made by Mr. Winstead and seconded by Mr. Phillips, the Commission unanimously voted to approve the Brownfield Agreement Modification between the Commission and McIngvale Square, LLC regarding the remediation of brownfield property located at 820 McIngvale Road, Hernando, Desoto County, Mississippi.

Mr. Wallace also informed the Commission that the City of Natchez submitted a Brownfield Revolving Loan Application for \$500,000 as part of the cleanup project at the Fry Building Brownfield Site. The City of Natchez has several Brownfield projects in motion including the Tracetown Brownfield site that the Commission approved for a Brownfield Agreement last month.

#### Briefing to the Commission on Waters of the State

Executive Director, Chris Wells, reminded the Commission that proposed water regulations under the Mississippi Air and Water Pollution Control Law were released for an extended public comment period on January 3, 2025, which culminated with a public hearing on Thursday, April 17, 2025. In addition to the public hearing, a question-and-answer session was also held. Based on the verbal and written comments received, MDEQ staff has decided not to bring the regulations before the Commission for finalization at this

time. Staff will take the feedback and comments received during the public comment period and continue their efforts to clarify the proposed water regulations, bringing them back for public comment later in the year. There was some discussion between Mr. Wells and the Commission about these regulations. This briefing was for informational purposes only and did not require any action by the Commission.

#### Solid Waste Assistance and Waste Tire Grants

### **Asbestos Certifications**

On previous authority delegated to the Head, Office of Pollution Control, the staff reported that 184 asbestos certifications had been issued since the last report.

### **Lead Paint Certifications**

On previous authority delegated to the Head, Office of Pollution Control, the staff reported that 59 lead paint certifications had been issued since the last report.

# Underground Storage Tank (UST) Certifications

On previous authority delegated to the Head, Office of Pollution Control, the staff reported that 4 new and 7 renewed certifications to those who install, alter, or remove underground storage tanks had been issued since the last report.

### Wastewater Operator Certifications

On previous authority delegated to the Head, Office of Pollution Control, the staff reported that 7 new and 17 renewed wastewater operator certificates had been issued since the last report.

### **Administrative Orders**

On previous authority delegated to the MDEQ Executive Director, the staff reported that 11 Administrative Orders have been issued since the Commission's meeting on March 27, 2025. A list of these orders is made a part of these minutes and is filed in the Official Minutes File.

### Approval to Enter into Executive Session

After a brief discussion led by Executive Director Chris Wells, Mr. Winstead moved to close the meeting to discuss whether to go into executive session to discuss pending litigation. Mr. Phillips seconded the motion. The Commission voted unanimously to close the meeting. Mr. Wells requested the public clear the Commission hearing room other than the Commission members, and Chief of Staff, Chris Sanders. The

Commission, on motion by Mr. Winstead and second by Ms. Lathan voted unanimously to go into executive session to discuss the matter and Mr. Sanders, announced the Commission's decision to the public that had left the Commission hearing room and gathered outside in the lobby. After discussion, Mr. Winstead moved to end executive session and return to open session and Mr. Parrish seconded the motion. The Commission unanimously voted in favor of the motion. Mr. Sanders invited the public to return to the Commission hearing room as the Commission returned to open session. Mr. Wells announced the Commission took no action during executive session.

The Commission decided to meet next on Thursday, May 22, 2025, beginning at 9:00 a.m.
