The Mississippi Environmental Quality Permit Board held a meeting in the Commission Hearing Room of the Department of Environmental Quality, located at 515 East Amite Street, in Jackson, Mississippi, on May 13, 2025. Roy Furrh, General Counsel for MDEQ, was present as legal counsel. Chair Doug Mann called the meeting to order. On motion by Les Herrington and second by Jennifer Wittmann, the Permit Board voted to adopt and approve the minutes for the regular Permit Board meeting held on April 8, 2025.

THE PERMIT BOARD CONSIDERED THE FOLLOWING OFFICE OF GEOLOGY MATTERS:

Mining and Reclamation Division

Surface Mining Permit Bond Releases

After presentation by Guillermo Gibson with the Mining and Reclamation Division, Office of Geology, MDEQ, receiving no public comment from the audience and correcting the Maxey Materials surface mining permit transfer from Hancock to Carroll County, on motion by Jennifer Wittmann and second by Chris Hawkins, the Permit Board voted to approve the following surface mining permit transfers (David Dockery abstained):

Mapco Service, LLC, P97-023T, transfer to Bayou Caddy Truck, FNC in Hancock County. Bayou Caddy has provided the proper bonding and transfer forms. The new permit will be P97-023T1.

Maxy Materials, LLC, P22-006T, transfer to JJ Ferguson Sand & Gravel, Inc.in Carroll County. JJ Ferguson has provided the proper bonding and transfer forms. The new permit will be P22-006T1

Surface Mining Permit Recission

After presentation by Mr. Gibson and receiving no public comment from the audience, on motion by Will Watkins and second by Chris McDonald, the Permit Board voted to rescind the T.L. Wallace surface mining permit (P12-010) in Lincoln County (David Dockery abstained.)

Tallahatchie County Waste Transfer Station

Consideration of issuance of Solid Waste Management Permit SW0680680620

Trent Jones, Chief of the Waste Division, presented the matter for the Permit Board's consideration.

Mr. Jones stated this is a solid waste management permit application and draft permit for the proposed operation of a new municipal solid waste transfer station, known as the Tallahatchie County Waste Transfer Station, to be owned and operated by the Tallahatchie County Board of Supervisors. Permit Board members received information about this permit prior to the meeting. Mr. Jones also stated that there might be visitors at the meeting who wish to address the permit board members.

According to the Mississippi Nonhazardous Solid Waste Management Regulations, a "transfer station" means a fixed facility used for the primary purpose of transferring solid waste from one solid waste transportation vehicle to another. Currently, there are 32 operating municipal solid waste transfer stations located in Mississippi.

The proposed Tallahatchie County Waste Transfer Station would be located at 15660 MS Highway 35, Charleston, Mississippi, in Tallahatchie County. The proposed waste transfer station will be located on approximately 51.89 acres owned by Tallahatchie County Board of Supervisors.

The proposed permit issuance includes a partially enclosed, three-walled 2,300 square foot building for the off-loading and management of municipal solid wastes and garbage. The primary purposes of the transfer station will be to collect and temporarily store locally generated municipal solid waste, transfer the waste to long haul vehicles, and transport the waste to an approved municipal solid waste landfill for final disposal. The permit application anticipates the processing of approximately 23 tons of waste materials per day at the facility. The service area of the facility will be Tallahatchie County.

Tallahatchie County has submitted a solid waste permit application for the proposed operation of the described facility. Based on the information provided in the application, it appears that the facility can be constructed and operated in a manner consistent with the Mississippi Nonhazardous Solid Waste Management Regulations. The draft permit includes standard requirements and conditions for the proper containment and storage of waste materials, the routine removal of waste (at least weekly), the daily cleaning of the tipping floor and equipment, the proper management of any wastewater, and the daily collection of any windblown materials or litter, and other operating requirements.

Prior to the submission of the solid waste permit application to MDEQ, the Tallahatchie County Board of Supervisors also considered the siting of this facility. State law requires that local governments modify their local solid waste management plans to include new or expanding solid waste management facilities prior to submitting solid waste permit applications. The County evaluated a number of locations before choosing the currently proposed location. The County noticed and held a 30-day public comment period and held a public hearing on September 6, 2022, related to the proposed Plan amendment. On September 12, 2022, the County adopted a resolution approving an amendment to the Plan recognizing the relocation of the approved municipal solid waste transfer station facility to the currently proposed location. The Commission on Environmental Quality also reviewed and considered the local planning process and ultimately issued Administrative Order No. 7306 24 on February 16, 2024.

The MDEQ Waste Division released a public notice soliciting public comments on the proposed draft solid waste permit for the transfer station on February 13, 2025. The notice was published in a local newspaper and established a 30-day public comment period from February 13, 2025,

through March 20, 2025, and also provided notice of a public hearing to be held on March 20, 2025. Additionally, the MDEQ Office of Community Engagement mailed copies of the notice to 122 individuals and/or businesses within half a mile of the proposed facility location. Copies of the public notice were also mailed to the Tallahatchie County Board of Supervisors and the City of Charleston.

During the public comment period, MDEQ received no written comments on the project. MDEQ held the public hearing on March 20, 2025, and no comments were received during the public hearing. MDEQ did receive comments from one (1) person in opposition of the proposed waste transfer station after the public comment period ended. The Permit Board was provided copies of the notice of public hearing and public comment period, public hearing transcript, public comments received, a "Response to Public Comments" document developed by MDEQ to attempt to summarize and respond to the public comments, a Permit Rationale and a Draft Permit.

Staff reviewed and evaluated the solid waste permit application, the supporting documents and information, and the public comments on the proposed permit relative to the matter within staff's environmental regulatory jurisdiction. Based on that review, MDEQ believes the permit application that has been provided is complete.

Tommy Reynolds, Mayor of Water Valley, and Johnny Goodwin, President of the Tallahatchie County Board of Supervisors, spoke in favor of the proposed transfer station permit. There was no public comment at the meeting against the proposed transfer station permit.

On motion by Will Watkins and second by Les Herrington, the Permit Board voted to issue the Tallahatchie County Waste Transfer Station Solid Waste Management Permit SW0680680620.

Office of Land and Water Resources

Permitting, Certification and Compliance Division

Permitting Branch

CF Industries Nitrogen LLC-Nitrogen Fertilizer Production Facility Yazoo County

Austin Brister, Chief of the Permitting Branch of the Permitting, Certification and Compliance Division of the Office of Land and Water Resources at MDEQ, presented the matter. He presented nine (9) groundwater withdrawal permits. These permits consist of one (1) new groundwater withdrawal permit and eight (8) renewals of existing groundwater withdrawal permits for CF Industries Nitrogen, LLC (CF). Mr. Brister noted that representatives from CF were in the audience.

CF operates a large nitrogen fertilizer production facility in Yazoo County, MS, just north of Yazoo City. The facility was built in 1951 and has been supplied exclusively by groundwater since that time. CF is applying for an additional groundwater withdrawal permit due to aging groundwater wells at the facility, but is not asking for an increase in total volume at the facility. The total permitted volume would remain at 9.95 MGD. The breakdown of permitted rates and volumes by permit were provided to the Permit Board members prior to today's meeting. In September of 2023, MDEQ requested CF to submit an inventory of their once-through non-contact cooling water (OTNCCW) and a work plan to reduce and phase out their OTNCCW at the facility.

In December of 2023, representatives from CF met with MDEQ to present the water inventory. The water inventory indicated that approximately 871,000 GPD were used for OTNCCW. MDEQ expressed that CF Industries must show meaningful progress in reducing OTNCCW use before MDEQ would consider issuing a new permit or renewing existing permits.

As a result of this meeting, CF initiated several OTNCCW reduction projects and reported them to MDEQ. At this time, CF has either completed or has funded and will complete by the end of 2025, projects that will reduce OTNCCW used at the facility by over 56% from the inventory presented in December 2023. MDEQ believes this reduction of the total OTNCCW from 871,000 to 376,000 GPD shows significant progress towards reducing and phasing out OTNCCW from total water use. The permits are being presented to the permit board instead of issuance at staff level because the permits include more than 20,000 GPD for OTNCCW and must be approved by the Permit Board pursuant to 11 Miss. Admin. Code Pt. 7, R.1.4.D(1).

A Notice of Intent was published in The Yazoo Herald on April 2, 2025. MDEQ did not receive any comments during the 10-day public comment period. MDEQ monitors water levels in the state, including this area, and does not believe that the issuance of these permits will adversely affect other water users in the area. As part of the permit terms and conditions, CF must continue to reduce and phase out OTNCCW at the facility and submit water-use and water level data annually.

Gary Rikard and Trey Fleming were present on behalf of CF Industries Nitrogen LLC to answer any questions from Permit Board members. There were no public comments from the audience or questions from the Permit Board.

On motion by Chris McDonald and second by Les Herrington, the Permit Board voted to issue Groundwater Withdrawal Permit MS-GW-17829 and to renew Groundwater Withdrawal Permits MS-GW-03519, MS-GW-03520, MS-GW-03525, MS-GW-03528, MS-GW-03529, MS-GW-003530, MS-GW-03531 and MS-GW-16874, Yazoo County (Chris Hawkins abstained).

OTHER BUSINESS

Roy Furrh, General Counsel, MDEQ, announced that Chris McDonald, the Permit Board Designee for the Mississippi Department of Agriculture and Commerce, had been appointed by the President to a federal position with the United States Department of Agriculture and this would be Chris's last Permit Board meeting before assuming his new post. Chris expressed his appreciation to the Permit Board and indicated he had served on the Permit Board for over 8 years. Chris mentioned that Brian Perry would be the new Permit Board Designee for the Department of Agriculture and Commerce. Chris was congratulated and recognized for his service by the Permit Board members.

Mr. Furth indicated that the Permit Board Officer elections for fiscal year 2026 would be held at the next meeting. He mentioned that the normal rotation of officers would result in Chris Hawkins, the Permit Board Designee for the Office of Land and Water Resources, being the Chair, and the Permit Board Designee for the Mississippi Department of Agriculture and Commerce being the Vice-Chair.

CONFIRMATION OF THE NEXT REGULAR PERMIT BOARD MEETING

Chair Doug Mann confirmed the next regular meeting of the Permit Board was scheduled for Tuesday, June 10, 2025.
