Dear Ms. Johnston and Mr. Egetter:

This Monthly Progress Report summarizes the activities completed between October 1 and October 31, 2025, per the 2011 Resource Conservation and Recovery Act (RCRA) 3013(a) Administrative Order, the 2014 RCRA 3008(h) Administrative Order on Consent, and the 2022 Comprehensive Environmental Response, Compensation, and Liability Act (CERCLA) Administrative Settlement Agreement and Order on Consent (ASAOC) for the Remedial Investigation (RI)/Feasibility Study (FS) for the former Hercules LLC (Hercules) site in Hattiesburg, Mississippi, referred to herein as "the site."

The information contained herein is intended to document significant activities (e.g., field work, conference calls, technical deliverables, correspondence) performed throughout the reporting period and is not intended to capture all email correspondence between the U.S. Environmental Protection Agency (USEPA) and the Mississippi Department of Environmental Quality (MDEQ) (together, the Agencies) and Hercules over that same period.

Attachment A includes the updated conceptual schedule to implement the RI. The schedule was originally discussed and agreed to by the USEPA on January 14, 2025, and is updated as work progresses. The current schedule shows RI implementation moving from Spring 2026 to Fall 2026, which is due to the USEPA stating that

additional rounds of comments will be provided on select RI Deliverables, and to add Response to Comment letters (per discussions with the USEPA in October 2025, as noted below).

Tasks Initiated, Continued, or Completed during October 2025

- Participated in conference calls with the Agencies on October 6 and October 17, 2025, to discuss preliminary comments from the Agencies' review of the Revised Remedial Investigation/Feasibility Study Work Plan (Revised RI/FS Work Plan) submitted on June 30, 2025.
- Ms. Chrissy Piechoski (Hercules Project Coordinator) had a call with USEPA representatives on October 16, 2025, to discuss the path and potential timeline to finalize the RI Deliverables for the site, with the continued shared goal of initiating the RI field work in Spring 2026. The following items were discussed during the call:
 - ➤ Hercules submitted the seven RI Deliverables required by the ASAOC in March 2024 (i.e., Emergency Response and Notification Plan (ERNP), Data Management Plan (DMP), Health and Safety Plan (HASP), Quality Assurance Project Plan (QAPP), Field Sampling Plan (FSP), Sampling and Analysis Plan (SAP), and Reuse Assessment).
 - The USEPA has provided at least one round of comments, modification to the requirements in the ASAOC (i.e., SAP is no longer required), or approval (i.e., Reuse Assessment) for those submittals.
 - Hercules submitted revised versions of the applicable RI Deliverables addressing USEPA comments received to date and in accordance with discussions and agreements reached during multiple conference calls with the Agencies.
 - > The USEPA indicated that additional comments will be provided for select RI Deliverables. In an effort to streamline Agency review, it was agreed that Response to Comments letters will be prepared to address those new comments and obtain concurrence on path forward before completing revisions and finalizing the applicable RI Deliverables.
 - Since USEPA stated that they will provide additional rounds of comments on select RI Deliverables and to incorporate Response to Comment letters into the process, the conceptual schedule to implement the RI activities was adjusted (Attachment A). It pushes the start of the field work from Spring 2026 to Fall 2026, and the USEPA indicated that they will look at ways to streamline the process to see if RI implementation can start sooner.
- Submitted the Monthly Progress Report for September 2025 to the Agencies on October 20, 2025.
- As requested by the USEPA, the Contractor Contact Information and Quality Management Plans was
 resubmitted on October 23, 2025. The information was originally provided to the USEPA on December 16,
 2022, pursuant to Section VII, Paragraph 30 (Designation of Contractors and Project Coordinators) in the
 ASAOC.
- Received a letter from the USEPA on October 28, 2025, providing comments on the Revised RI/FS Work
- Notified the Agencies of the anticipated start for the 2025 annual monitoring event on October 29, 2025. The
 event, which was completed between November 3 and November 14, 2025, was performed in accordance
 with the agreement in the ASAOC, the requirements in the Restrictive Use Agreed Order (RUAO) and the
 RCRA Orders for the site, and the scope approved by the USEPA on April 15, 2025.

Challenges and/or Delays

Tasks Planned for Next Three Months (November 2025 – January 2026)

- Complete the 2025 annual monitoring event and develop the associated report.
- Participate in conference calls with the Agencies to discuss the USEPA's October 28, 2025 comments on the Revised RI/FS Work Plan and Hercules' proposed responses:
 - ➤ A conference call was held on November 17, 2025, to discuss the Hercules proposed responses to the USEPA comments.
 - Submit a Response to Comment letter to the Agencies.
 - Supplemental conference calls can be coordinated, as needed, to facilitate review and approval of those responses.
 - Submit a Revised RI/FS Work Plan to the Agencies upon receipt of approval of the Response to Comment letter.
- Decommission the three inactive industrial supply wells screened within the Catahoula formation at the site, as approved by the USEPA on September 24, 2025.

 - The Revised Field Sampling Plan submitted on September 18, 2025.
